A SUPPLEMENT

- 1 To the act of April 1, 1863 (P.L.213, No.227), entitled "An act to accept the grant of Public Lands, by the United States, to
 - the several states, for the endowment of Agricultural
- 4 Colleges, making appropriations for carrying the same into
- 5 effect, providing for a basis for payments of such
- appropriations and providing a method of accounting for the
- 7 funds appropriated.

- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. In order to carry into effect the act of
- 11 Congress, approved July 2, 1862, granting public land to the
- 12 several states for educational purposes, and subsequent acts of
- 13 Congress related thereto, and the act of the General Assembly of
- 14 Pennsylvania accepting the provisions and conditions of said
- 15 acts of Congress and pledging the faith of the State to carry
- 16 the same into effect, the following sums or as much thereof as
- 17 may be necessary are hereby specifically appropriated to the
- 18 Trustees of the Pennsylvania State University for the fiscal
- 19 year July 1, 1975 to June 30, 1976, for the purposes and in the
- 20 amounts as shown:

9	Section 2. Payments to Pennsylvania State University on	
10	account of the appropriations for all items as provided in	
11	section 1 except for instruction - Doctor of Medicine shall be	
12	made on the basis of costs during the fiscal year.	
13	Payments for instruction - Doctor of Medicine shall be made	
14	on the basis of full-time equivalent students enrollment at the	
15	rate of \$7,465 per student.	
16	Section 3. If necessary, the Pennsylvania State University	
17	may transfer funds among the appropriations listed in section 1,	
18	clauses (1), (2), (3) and (4): Provided, That the aggregate	
19	amount transferred into or out of each appropriation during the	
20	fiscal year shall not exceed 5% of the amount specifically	
21	appropriated for that purpose.	
22	Section 4. Payments to the Pennsylvania State University of	
23	the appropriations herein provided shall be made monthly during	
24	the fiscal year.	
25	Such monthly payments shall be made in accordance with the	
26	provisions of sections 2 and 3, on the basis of estimated costs	
27	and full-time equivalent students enrolled in the Doctor of	
28	Medicine program. The estimate of costs shall be submitted by	
29	the Pennsylvania State University to the Secretary of Education,	
30	the General Assembly and to the State Treasurer not later than

- 1 30 days prior to the date on which such payment is to be made.
- 2 Section 5. The Pennsylvania State University shall apply the
- 3 moneys appropriated by this act only for such purposes as are
- 4 permitted in this act and shall at all times maintain proper
- 5 records showing the application of such moneys. Not later than
- 6 120 days after the close of the fiscal year to which this act
- 7 relates, the Pennsylvania State University shall file with the
- 8 Secretary of Education, the General Assembly, and with the
- 9 Auditor General of the Commonwealth, a statement setting forth
- 10 the amounts and purposes of all expenditures made from moneys
- 11 appropriated by this act and other university accounts during
- 12 said fiscal year, the number of full-time equivalent students
- 13 enrolled in the Doctor of Medicine program and costs, as
- 14 provided in sections 2 and 3, used as a basis for receipt of any
- 15 appropriation during said fiscal year.
- 16 Such statement of expenditures and number of full-time
- 17 equivalent students enrolled in the Doctor of Medicine program
- 18 and costs shall be reviewed by the Auditor General of the
- 19 Commonwealth, and he shall have the right, in respect to the
- 20 moneys appropriated by this act, to audit and disallow
- 21 expenditures made for purposes not permitted by this act and to
- 22 cause such sums to be recovered and paid by the Pennsylvania
- 23 State University to the Treasurer of the Commonwealth. The
- 24 Auditor General shall also make a determination of full-time
- 25 equivalent students enrolled in the Doctor of Medicine program
- 26 and costs and make a certification as to their correctness. In
- 27 respect to expenditures made by the university from moneys other
- 28 than those appropriated by this act, the Auditor General shall
- 29 have the right to review only and he shall file annually with
- 30 the General Assembly such information concerning such

- 1 expenditures as the General Assembly or any of its committees
- 2 may require.
- 3 Section 6. A report shall be submitted to the Governor and
- 4 the Appropriations and Education Committees of the Senate and
- 5 House of Representatives and shall include data for all programs
- 6 of the university except the Doctor of Medicine program. The
- 7 report, to be submitted prior to November 1, 1976, shall cover
- 8 the twelve-month period beginning September 1, 1975. The report
- 9 shall include for each term during the period:
- 10 (1) The following counts and distributions:
- 11 (i) The definitions and numbers of full-time faculty
- 12 members, of part-time faculty members, of full-time students
- 13 enrolled in graduate courses, of full-time students enrolled in
- 14 undergraduate courses, of part-time students enrolled in
- 15 graduate courses, and of part-time students enrolled in
- 16 undergraduate courses.
- 17 (ii) A distribution of part-time faculty members by the
- 18 percentage of full-time employment.
- 19 (iii) Total numbers of undergraduate student credit hours,
- 20 divided into lower division and upper division levels, and of
- 21 graduate student credit hours divided into three levels--
- 22 master's, first professional and doctoral.
- 23 (iv) Number of different courses scheduled by level of
- 24 instruction, distributed by the number of sections scheduled in
- 25 each course and the sections distributed by the number of
- 26 students enrolled in each section.
- 27 (v) Number of terms scheduled and the dates thereof.
- 28 (2) A classification of faculty members or other
- 29 professional employees by title including: professor, associate
- 30 professor, assistant professor, instructor, lecturer, research

- 1 associate, librarian, and academic administrator; faculty
- 2 members or other professional employees under each title to be
- 3 subdivided by type of assignment: undergraduate courses only,
- 4 graduate courses only, or both graduate and undergraduate
- 5 courses; and each such set of faculty members or other
- 6 professional employees to be further subdivided by type of
- 7 employment: full-time or part-time; and the following aggregates
- 8 for each such subdivided classification:
- 9 (i) The number.
- 10 (ii) The sum of credits assigned to undergraduate courses
- 11 and the sum of credits assigned to graduate courses taught,
- 12 divided into lower division, upper division, master's, first
- 13 professional and doctoral levels.
- 14 (iii) The sum of undergraduate student credit hours and the
- 15 sum of graduate student credit hours generated; divided into
- 16 lower division, upper division, master's, first professional and
- 17 doctoral levels.
- 18 (iv) Total salary paid.
- 19 (v) Total salary paid from university funds.
- 20 (vi) Total salary paid from Federal funds.
- 21 (vii) Total salary paid from other funds.
- 22 (3) For each term of the period covered for each full-time
- 23 faculty member identified by school, department and title:
- 24 (i) An analysis of the average hours per week spent in
- 25 university-related activities, stating specifically hours spent
- 26 in undergraduate classroom contact and graduate classroom
- 27 contact, hours spent in preparation, hours spent in research and
- 28 hours spent in public service.
- 29 (ii) The total salary paid and the salary paid from
- 30 university funds.

- 1 Section 7. In addition to the requirements of section 6, the
- 2 report covering the twelve-month period beginning September 1,
- 3 1975, shall include for all programs of the university except
- 4 the Doctor of Medicine program:
- 5 (1) Minimum number of credits required for a baccalaureate
- 6 degree, and for a master's degree.
- 7 (2) Number of bachelor's degrees, master's degrees, first
- 8 professional degrees, and doctoral degrees awarded in 1973, 1974
- 9 and 1975 and estimated 1976.
- 10 Section 8. The Pennsylvania State University shall report
- 11 its revenues and expenditures and present its financial
- 12 statements required under the provisions of this act in
- 13 accordance with generally accepted accounting principles and
- 14 procedures for educational institutions as set forth in
- 15 "Industry Audit Guide for Colleges and Universities" of the
- 16 American Institute of Certified Public Accountants of 1973,
- 17 without exception.
- 18 Section 9. This act shall take effect immediately.
