AN ACT

- Amending the act of March 31, 1937 (P.L.160, No.43), entitled 2 "An act creating a commission to be known as the Pennsylvania 3 Public Utility Commission; defining in part the powers and duties of such commission; abolishing The Public Service Commission of the Commonwealth of Pennsylvania, terminating 5 the terms of the members thereof, and transferring to the 6 7 Pennsylvania Public Utility Commission the records, employes, 8 property, and equipment of The Public Service Commission of the Commonwealth of Pennsylvania; authorizing the 9 Pennsylvania Public Utility Commission to appear in and 10 complete all pending proceedings, legal or otherwise, 11 12 instituted before, by or against The Public Service 13 Commission of the Commonwealth of Pennsylvania; providing 14 that all certificates of public convenience, contracts, 15 orders, and rules and regulations of the latter commission 16 shall remain effective until repealed, changed or modified by 17 the Pennsylvania Public Utility Commission, and transferring 18 and appropriating to the Pennsylvania Public Utility 19 Commission any unexpended balance of any existing 20 appropriation to The Public Service Commission of the Commonwealth of Pennsylvania, "further providing for the age 21 22 of members of the Public Utility Commission and making an 23 appropriation for an educational study.
- 24 The General Assembly of the Commonwealth of Pennsylvania
- 25 hereby enacts as follows:
- Section 1. Subsection (a) of section 1, act of March 31,
- 27 1937 (P.L.160, No.43), entitled "An act creating a commission to

- 1 be known as the Pennsylvania Public Utility Commission; defining
- 2 in part the powers and duties of such commission; abolishing The
- 3 Public Service Commission of the Commonwealth of Pennsylvania,
- 4 terminating the terms of the members thereof, and transferring
- 5 to the Pennsylvania Public Utility Commission the records,
- 6 employes, property, and equipment of The Public Service
- 7 Commission of the Commonwealth of Pennsylvania; authorizing the
- 8 Pennsylvania Public Utility Commission to appear in and complete
- 9 all pending proceedings, legal or otherwise, instituted before,
- 10 by or against The Public Service Commission of the Commonwealth
- 11 of Pennsylvania; providing that all certificates of public
- 12 convenience, contracts, orders, and rules and regulations of the
- 13 latter commission shall remain effective until repealed, changed
- 14 or modified by the Pennsylvania Public Utility Commission, and
- 15 transferring and appropriating to the Pennsylvania Public
- 16 Utility Commission any unexpended balance of any existing
- 17 appropriation to The Public Service Commission of the
- 18 Commonwealth of Pennsylvania, amended March 31, 1943 (P.L.32,
- 19 No.17) is amended to read:
- 20 Section 1. (a) A commission to be known as the Pennsylvania
- 21 Public Utility Commission is hereby created. The commission
- 22 shall consist of five members who shall be appointed by the
- 23 Governor, by and with the advice and consent of two-thirds of
- 24 all the members of the Senate. The commissioners first appointed
- 25 under this act, shall continue in office for terms of two, four,
- 26 six, eight, and ten years, respectively, from the effective date
- 27 of this act, but their successors shall each be appointed for a
- 28 term of ten years. No commissioner, upon the expiration of his
- 29 term as aforesaid, shall continue to hold office until his
- 30 successor shall be duly appointed or shall be qualified. Each

- 1 commissioner, at the time of his appointment and qualification,
- 2 shall be a resident of the Commonwealth of Pennsylvania, and
- 3 shall have been a qualified elector therein for a period of at
- 4 least one year next preceding his appointment. [, and shall also
- 5 be not less than thirty years of age.]

- 7 Section 2. The act is amended by adding a section to read:
- 8 <u>Section 12.1. (a) The sum of fifty thousand dollars</u>
- 9 (\$50,000), or as much thereof as may be necessary, is hereby
- 10 specifically appropriated to The Public Utility Commission SHALL <-

- 11 SET ASIDE THE SUM OF FIFTY THOUSAND DOLLARS(\$50,000) FROM ITS
- 12 ANNUAL BUDGET for the fiscal year 1976-1977 for the purpose of
- 13 <u>funding a research study to design and develop a curriculum for</u>
- 14 the education and continuing education of the employes and
- 15 prospective employes of the Public Utility Commission in
- 16 <u>appropriate areas of utility regulation.</u>
- 17 (b) The Public Utility Commission shall be responsible for
- 18 final approval of this study and the implementation thereof. The
- 19 resulting educational program shall be funded by the Public
- 20 <u>Utility Commission</u>.
