## AN ACT

Amending the act of May 17, 1921 (P.L.912, No.322), entitled, "An act to regulate the drilling, operating, and abandoning of oil and gas wells, and providing a penalty for violation of the provisions of this act," permitting the introduction of pressure into any stratum for the purpose of producing oil or gas therefrom.

7 The General Assembly of the Commonwealth of Pennsylvania

8 hereby enacts as follows:

9 Section 1. Section 3, act of May 17, 1921 (P.L.912, No.322), 10 entitled "An act to regulate the drilling, operating and abandoning of oil and gas wells, and providing a penalty for 11 violation of the provisions of this act," amended April 26, 1929 12 13 (P.L.821, No.352), is amended to read: 14 Section 3. The owner or operator of any well or wells which 15 produce oil or gas from [the strata known as the "Bradford Sand," "Ball Town Sand," "Clarendon Sand," "Cherry Grove Sand," 16 "Kane Sand," "Glade Sand," and "Haskell Sand,"] any stratum 17 18 BELOW THE LOWEST POTABLE WATER AQUIFER shall be permitted to

allow such wells to remain open for the purpose of introducing 1 air, gas, water, or other liquid pressure[, upon said "Bradford 2 3 Sand, " "Ball Town Sand, " "Clarendon Sand, " "Cherry Grove Sand," "Kane Sand," "Glade Sand," and "Haskell Sand,"] into said oil or 4 gas bearing stratum for the purpose of recovering the oil and 5 gas contained therein, provided that the introduction of such 6 pressure of air, gas, water, or other liquid into said 7 8 ["Bradford Sand," "Ball Town Sand," "Clarendon Sand," "Cherry Grove Sand, " "Kane Sand, " "Glade Sand, " and "Haskell Sand, "] 9 stratum shall be through casing or tubing which shall be so 10 11 anchored and packed that no other oil, [or gas bearing sand,] gas or water bearing stratum above or below said ["Bradford 12 13 Sand, " "Ball Town Sand, " "Clarendon Sand, " "Cherry Grove Sand," "Kane Sand," "Glade Sand," and "Haskell Sand,"] stratum shall be 14 15 affected by the introduction of such pressure. 16 Section 2. This act shall take effect in 30 days.
