## AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled, 2 "An act relating to the public school system, including 3 certain provisions applicable as well to private and 4 parochial schools; amending, revising, consolidating and changing the laws relating thereto," by providing for the emergency generated by the gas crisis in relationship to the 6 length of the school year, the compensation of employes and 7 8 the graduation of qualified students. 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1. The act of March 10, 1949 (P.L.30, No.14), known 12 as the "Public School Code of 1949" is amended by adding a 13 section to read: 14 Section 1501.1. Weather Emergency of 1977.--(a) For the 15 school year 1976-77 all public and approved private 16 kindergartens, elementary and secondary schools, vocational-
- 18 instruction, shall make every effort to keep open for at least
- 19 one hundred seventy-seven (177) days of instruction for pupils.
- 20 No public or approved private kindergarten, elementary or

technical schools, and intermediate unit programs of

- 1 secondary school, vocational-technical school, or intermediate
- 2 unit program of instruction which was closed because of the
- 3 Weather Emergency and which makes a good faith effort as
- 4 <u>determined by the Secretary of Education to keep open for at</u>
- 5 <u>least one hundred seventy-seven (177) days of instruction for</u>
- 6 pupils shall receive less subsidy payments or reimbursements
- 7 than it would otherwise be entitled to receive on account of the
- 8 school year 1976-77. No employe of any school closed by reason
- 9 of the Weather Emergency of 1977 shall receive MORE OR less
- 10 compensation, INCLUDING ANY UNEMPLOYMENT COMPENSATION BENEFITS <---
- 11 PAID, than that to which the employe would otherwise have been
- 12 entitled to FROM THE SCHOOL DISTRICT, INTERMEDIATE UNIT OR
- 13 <u>VOCATIONAL-TECHNICAL SCHOOL</u>, had the Weather Emergency of 1977
- 14 not occurred.
- 15 (b) An employe shall not receive additional salary for
- 16 services rendered on days rescheduled as a result of the Weather
- 17 Emergency of 1977, unless the number of days rescheduled extends
- 18 the number of days provided for in the original school calendar;
- 19 in which case, an employe shall receive a prorata increase for
- 20 such additional days.
- 21 (c) A school district shall not be required to change its
- 22 high school graduation schedule or require graduating students
- 23 to return to school after graduation to demonstrate good faith
- 24 for the purposes of subsection (a).
- 25 Section 2. This act shall take effect immediately and shall
- 26 expire on June 30, 1977.
