## AN ACT

- 1 Authorizing the Department of General Services WITH THE APPROVAL <-
- 2 OF THE GOVERNOR AND THE DEPARTMENT OF MILITARY AFFAIRS to
- 3 convey an easement over lands of the Commonwealth in the
- 4 Borough of Sellersville, Bucks County to the Pennridge
- 5 Wastewater Treatment Authority.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. The Department of General Services, with the
- 9 approval of the Governor and the Department of Military Affairs
- 10 is hereby authorized for the consideration of \$1 to convey a
- 11 permanent easement over lands of the Commonwealth in the Borough
- 12 of Sellersville, Bucks County to the Pennridge Wastewater
- 13 Treatment Authority which easement is described as follows:
- 14 All that certain 20 feet wide permanent right-of-way situate
- 15 in the Borough of Sellersville, bounded and described in
- 16 accordance with a plan prepared by Betz Environmental Engineers,
- 17 Plymouth Meeting, Pennsylvania dated August 9, 1976 as follows:
- 18 Beginning, at a point on the northeast side of Herbert
- 19 Street; said point being at the distance of 129.93 feet measured

- 1 north 44 degrees 50 minutes west along said side of said street
- 2 from a corner of lands of the Borough of Sellersville; thence
- 3 from said point of beginning extending in and through lands of
- 4 the Commonwealth of Pennsylvania north 44 degrees 13 minutes
- 5 east 114.06 feet to a point; thence continuing in and through
- 6 the same north 41 degrees 54 minutes east 226.31 feet to a
- 7 point; thence extending along line of lands of the Borough of
- 8 Sellersville south 45 degrees 50 minutes east 20.03 feet to a
- 9 point; thence extending in and through lands of the Commonwealth
- 10 of Pennsylvania south 41 degrees 54 minutes west 225.57 feet to
- 11 a point; thence continuing in and through the same south 44
- 12 degrees 13 minutes west 114.80 feet to a point; thence extending
- 13 along the northeasterly side of Herbert Street north 44 degrees
- 14 50 minutes west 20.00 feet to the first mentioned point and
- 15 place of beginning. Containing 6,807 square feet of land.
- 16 Section 2. The deed of easement shall be approved by the
- 17 Department of Justice and shall be executed by the Secretary of
- 18 General Services in the name of the Commonwealth of
- 19 Pennsylvania.
- 20 Section 3. This act shall take effect immediately.
