AN ACT

1 Amending the act of August 9, 1955 (P.L.323, No.130), entitled
2 "An act relating to counties of the third, fourth, fifth,
3 sixth, seventh and eighth classes; amending, revising,
4 consolidating and changing the laws relating thereto," adding
5 duties of the county solicitor AND FURTHER PROVIDING FOR DAYS <—
6 AND HOURS OF VOTER REGISTRATION OFFICES.

7 The General Assembly of the Commonwealth of Pennsylvania
8 hereby enacts as follows:

9 Section 1. Section 902, act of August 9, 1955 (P.L.323,
10 No.130), known as "The County Code," amended June 7, 1961
11 (P.L.245, No.141), is amended to read:

12 Section 902. Duties.--He shall commence and prosecute all
13 suits brought, or to be brought, by the county, wherein or
14 whereby any rights, privileges, properties, claims or demands of
15 the county are involved, as well as defend all actions or suits
16 brought against the county, and shall perform all duties now
17 enjoined by law upon county solicitors, and shall do all and
18 every professional act and render legal advice incident to the
19 office which may be required of him by the commissioners. He
20 shall, in addition, perform all similar duties for each elected

1 officer who is not authorized to appoint a solicitor or who has
2 not appointed a solicitor although authorized to do so.

3 SECTION 2. SECTION 2301.1 OF THE ACT, AMENDED JUNE 1, 1972 <—
4 (P.L.328, NO.90), IS AMENDED TO READ:

5 SECTION 2301.1. DAYS AND HOURS OF COURT HOUSE AND OFFICES.--
6 THE COUNTY COMMISSIONERS SHALL DETERMINE WHEN THE COUNTY COURT
7 HOUSE AND ALL COUNTY OFFICES LOCATED ELSEWHERE SHALL BE OPEN,
8 EXCEPT THAT VOTERS' REGISTRATION OFFICES [SHALL] MAY BE OPEN
9 DURING ORDINARY BUSINESS HOURS ON THE TWO SATURDAYS PRIOR TO
10 TERMINATION OF REGISTRATION PERIOD TO THE PRIMARY AND GENERAL
11 AND MUNICIPAL ELECTIONS.

12 Section ~~2-~~ 3. This act shall take effect immediately. <—
