INTRODUCED BY MR. PIEVSKY, JUNE 6, 1977

AS AMENDED ON THIRD CONSIDERATION, HOUSE OF REPRESENTATIVES,  
SEPTEMBER 28, 1977

## A SUPPLEMENT

1 To the act of November 30, 1965 (P.L.843, No.355), entitled "An  
2 act providing for the establishment and operation of Temple  
3 University as an instrumentality of the Commonwealth to serve  
4 as a State-related university in the higher education system  
5 of the Commonwealth; providing for change of name; providing  
6 for the composition of the board of trustees; terms of  
7 trustees, and the power and duties of such trustees;  
8 providing for preference to Pennsylvania residents in  
9 tuition; providing for public support and capital  
10 improvements; authorizing appropriations in amounts to be  
11 fixed annually by the General Assembly; providing for the  
12 auditing of accounts of expenditures from said  
13 appropriations; authorizing the issuance of bonds exempt from  
14 taxation within the Commonwealth; requiring the President to  
15 make an annual report of the operations of Temple  
16 University," making appropriations for carrying the same into  
17 effect, providing for a basis for payments of such  
18 appropriation and providing a method of accounting for the  
19 funds appropriated.

20 The General Assembly of the Commonwealth of Pennsylvania

21 hereby enacts as follows:

22 Section 1. The following sums, or as much thereof as may be  
23 necessary, are hereby specifically appropriated to the Trustees  
24 of Temple University at Philadelphia for the fiscal year July 1,  
25 1977 to June 30, 1978, for the purposes and in the amounts as  
26 shown:

1	(1) For educational and general expenses.....	\$58,126,000
2	(2) For cost of student aid.....	3,018,000
3	(3) For instruction - Doctor of Medicine	
4	only.....	5,412,000
5	(4) For operation of dental clinics in the	
6	school of dentistry.....	600,000
7	(5) Temple University Hospital.....	2,500,000

8 Section 2. Payments to Temple University on account of the  
9 appropriations for all items, as provided in section 1, except  
10 for instruction Doctor of Medicine, shall be made on the basis  
11 of costs during the fiscal year.

12 Payments for instruction - Doctor of Medicine only shall be  
13 made on the basis of full-time students enrolled at the rate of  
14 \$7,465 per student.

15 AS A CONDITION OF RECEIVING ITS APPROPRIATION, ON OR AFTER  
16 JANUARY 1, 1978 THE MEDICAL SCHOOL SHALL, WHEN ACCEPTING FIRST  
17 YEAR STUDENTS FOR THE NEXT TERM, SET ASIDE 10% OF THE TOTAL  
18 NUMBER OF ADMISSIONS FOR STUDENTS WHO AGREE THAT UPON THE  
19 COMPLETION OF THEIR MEDICAL TRAINING, THEY SHALL ENGAGE IN THE  
20 PRACTICE OF MEDICINE FOR A PERIOD OF FOUR YEARS IN AN AREA  
21 TERMED MEDICALLY DEPRIVED BY THE PENNSYLVANIA DEPARTMENT OF  
22 HEALTH.

23 Section 3. If necessary, Temple University may transfer  
24 funds among the appropriations listed in section 1, clauses (1)  
25 and (2): Provided, That the aggregate amount transferred into or  
26 out of each appropriation during the fiscal year shall not  
27 exceed 5% of the amount specifically appropriated for that  
28 purpose.

29 Section 4. Payment to Temple University of the  
30 appropriations herein provided shall be made monthly during the

1 fiscal year.

2 Such monthly payments shall be made in accordance with the  
3 provisions of sections 2 and 3, on the basis of estimated costs  
4 and full-time students enrolled in the Doctor of Medicine  
5 program. The estimate of costs shall be submitted by Temple  
6 University to the Secretary of Education, the General Assembly  
7 and to the State Treasurer not later than 30 days prior to the  
8 date on which such payment is to be made.

9 Section 5. Temple University shall apply the moneys  
10 appropriated by this act only for such purposes as are permitted  
11 in this act and shall at all times maintain proper records  
12 showing the application of such moneys. Not later than 120 days  
13 after the close of the fiscal year to which this act relates,  
14 Temple University shall file with the Secretary of Education,  
15 the General Assembly and with the Auditor General of the  
16 Commonwealth a statement setting forth the amounts and purposes  
17 of all expenditures made from moneys appropriated by this act  
18 and other university accounts during said fiscal year the number  
19 of full-time students enrolled in the Doctor of Medicine program  
20 and costs, as provided in section 2, used as a basis for receipt  
21 of any appropriation during said fiscal year. Such statement of  
22 expenditures, and number of full-time students enrolled in the  
23 Doctor of Medicine program and costs shall be reviewed by the  
24 Auditor General of the Commonwealth, and he shall have the  
25 right, in respect to the moneys appropriated by this act, to  
26 audit and disallow expenditures made for purposes not permitted  
27 by this act and to cause such sums to be recovered and paid by  
28 Temple University to the Treasurer of the Commonwealth. The  
29 Auditor General shall also make a determination of full-time  
30 students enrolled in the Doctor of Medicine program and costs

1 and make certification as to their correctness. In respect to  
2 expenditures made by the university from moneys other than those  
3 appropriated by this act, the Auditor General shall have the  
4 right to review only and he shall file annually with the General  
5 Assembly such information concerning said expenditures as the  
6 General Assembly or any of its committees may require.

7 Section 6. A report shall be submitted to the Governor and  
8 the Appropriations and Education Committees of the Senate and  
9 House of Representatives and shall include data for all programs  
10 except the Doctor of Medicine program. Each such report, to be  
11 submitted prior to November 1, 1978, shall cover the 12-month  
12 period beginning September 1, 1977 and shall include for each  
13 term during the period:

14 (1) The following counts and distributions:

15 (i) The definitions and numbers of full-time faculty  
16 members, of part-time faculty members, of full-time  
17 students enrolled in graduate courses, of full-time  
18 students enrolled in undergraduate courses, of part-time  
19 students enrolled in graduate courses, and of part-time  
20 students enrolled in undergraduate courses.

21 (ii) A distribution of part-time faculty members by  
22 the percentage of full-time employment.

23 (iii) Total numbers of undergraduate student credit  
24 hours, divided into lower division and upper division  
25 levels, and of graduate student credit hours divided into  
26 three levels--master's, first professional and doctoral.

27 (iv) Number of different courses scheduled by level  
28 of instruction, distributed by the number of sections  
29 scheduled in each course and the sections distributed by  
30 the number of students enrolled in each section.

1 (v) Number of terms scheduled and the dates thereof.

2 (2) A classification of faculty members or other  
3 professional employees by title including: professor,  
4 associate professor, assistant professor, instructor,  
5 lecturer, research associate, librarian, and academic  
6 administrator; faculty members or other professional  
7 employees under each title to be subdivided by type of  
8 assignment: undergraduate courses only, graduate courses  
9 only, or both graduate and undergraduate courses; and each  
10 such set of faculty members or other professional employees  
11 to be further subdivided by type of employment: full-time or  
12 part-time; and the following aggregates for each such  
13 subdivided classification:

14 (i) The number.

15 (ii) The sum of credits assigned to undergraduate  
16 courses and the sum of credits assigned to graduate  
17 courses taught, divided into lower division, upper  
18 division, master's, first professional and doctoral  
19 levels.

20 (iii) The sum of undergraduate student credit hours  
21 and the sum of graduate student credit hours generated;  
22 divided into lower division, upper division, master's,  
23 first professional and doctoral levels.

24 (iv) Total salary paid.

25 (v) Total salary paid from college or university  
26 funds.

27 (vi) Total salary paid from Federal funds.

28 (vii) Total salary paid from other funds.

29 (3) For each term of the period covered for each full-  
30 time faculty member identified by school, department and

1 title:

2 (i) An analysis of the average hours per week spent  
3 in college or university-related activities, stating  
4 specifically hours spent in undergraduate classroom  
5 contact and graduate classroom contact, hours spent in  
6 preparation, hours spent in research and hours spent in  
7 public service.

8 (ii) The total salary paid and the salary paid from  
9 college or university funds.

10 In addition to the above requirements relative to this  
11 appropriation, each report covering the 12-month period  
12 beginning September 1, 1977, shall include for all programs of  
13 the ~~State colleges or State owned~~ university: <—

14 (1) Minimum number of credits required for a  
15 baccalaureate degree and for a master's degree.

16 (2) Number of bachelor's degrees, master's degrees,  
17 first professional degrees, and doctoral degrees awarded in  
18 1975, 1976, 1977 and estimated 1978.

19 The ~~State colleges and State owned~~ university shall report <—  
20 ~~their~~ ITS revenues and expenditures and present ~~their~~ ITS <—  
21 financial statements required under the provisions of this act  
22 in accordance with "Higher Education Finance Manual" (1975).

23 SECTION 7. THE UNIVERSITY SHALL UPON ADMITTING A FIRST-YEAR <—  
24 CLASS, ADMIT AS MANY STUDENTS IN THAT CLASS TO THE DOCTOR OF  
25 MEDICINE AND DENTAL PROGRAMS AS CAN BE ACCOMMODATED BY THE  
26 FACILITIES OF THE SCHOOL.

27 Section 7- 8. The university shall provide such information <—  
28 AS MAY BE NECESSARY TO CARRY OUT THIS ACT and in such form and <—  
29 manner as the Department of Education may prescribe. THE <—  
30 DEPARTMENT SHALL ANNUALLY REPORT TO THE GENERAL ASSEMBLY SUCH

1 DATA AS WILL SHOW THE NUMBER OF STUDENTS IN EACH CLASS IN THE  
2 DOCTOR OF MEDICINE AND DENTAL PROGRAMS AND THE FACILITIES  
3 AVAILABLE FOR THEM.

4 Section ~~8~~ 9. The university shall report its revenues and ←  
5 expenditures and present its financial statements required under  
6 the provisions of this act in accordance with generally accepted  
7 accounting principles and procedures for educational  
8 institutions as set forth in "Higher Education Finance Manual"  
9 United States Department of Health, Education and Welfare (1975)  
10 with the exceptions set forth in the Commonwealth of  
11 Pennsylvania Budget Instructions for State Related Universities,  
12 Phase I, Fiscal Year 1977-1978. Credits granted for non-  
13 traditional programs such as CLEP, lifelong learning etc.,  
14 including all related costs and revenues thereof shall be  
15 excluded from the function of "Instruction" and included under  
16 "Public Service."

17 SECTION 10. AS A CONDITION TO RECEIVING THESE ←  
18 APPROPRIATIONS, THE UNIVERSITY SHALL NOT ESTABLISH OR CONDUCT OR  
19 COOPERATE WITH ANY AGENCY TO ESTABLISH OR CONDUCT ANY RESEARCH  
20 OR EXPERIMENTS WHICH HAVE THE POTENTIAL TO INTERFERE WITH  
21 THOUGHT PROCESSES OF ANY HUMAN BEING WITHOUT THE INFORMED  
22 CONSENT OF SUCH INDIVIDUAL. THE GENERAL ASSEMBLY MAY WITHHOLD  
23 PART OR ALL OF ANY APPROPRIATION IF THE UNIVERSITY IS FOUND TO  
24 BE VIOLATING THE PROVISIONS OF THIS SECTION. THIS SECTION SHALL  
25 NOT APPLY TO ANY CONTRACTS FOR RESEARCH OR EXPERIMENTATION WHICH  
26 ARE IN EFFECT ON THE EFFECTIVE DATE OF THIS ACT.

27 SECTION 11. EXCEPT WHERE RESTRICTED BY CONTRACT OR BY TERMS  
28 OF AN ENDOWMENT, DISTINGUISHED FACULTY MEMBERS IN WRITING,  
29 LECTURING, AUDIO-VISUAL TECHNIQUES OR RECOGNIZED ON A NATIONAL  
30 OR REGIONAL LEVEL AS AN EXPERT IN A SPECIFIC DISCIPLINE AT THE

1 UNIVERSITY SHALL PRESENT AT LEAST THREE ACADEMIC LECTURES OR  
2 FIVE ACADEMIC CLASSROOM PRESENTATIONS PER ACADEMIC YEAR.

3 Section ~~9-~~ 12. This act shall take effect July 1, 1977.

<—
