AN ACT

1 Amending the act of June 4, 1976 (P.L.1331, No.7-A), entitled
2 "An act to provide for the expenses of the Executive,
3 Legislative and Judicial Departments of the Commonwealth, the
4 public debt and for the public schools for the fiscal period
5 July 1, 1976 to June 30, 1977, and for the payment of bills
6 incurred and remaining unpaid at the close of the fiscal
7 period ending June 30, 1976," increasing the appropriation to
8 the Department of Public Welfare for medical assistance AND <—
9 PROVIDING FOR A CONTINUING APPROPRIATION TO PUBLIC LIBRARIES.

10 The General Assembly of the Commonwealth of Pennsylvania

11 hereby enacts as follows:

12 Section 1. As much of section 2 as relates to the Department
13 of Public Welfare as to medical assistance, act of June 4, 1976
14 (P.L.1331, No.7-A), known as the "General Appropriation Act of
15 1976," is amended to read:

16 Section 2. The following sums, or as much thereof as may be
17 necessary, are hereby specifically appropriated from the General
18 Fund to the several hereinafter named agencies of the Executive,
19 Legislative and Judicial Departments of the Commonwealth for the
20 payment of the salaries, wages or other compensation and travel
21 expenses of the duly elected or appointed officers and employees

1 of the Commonwealth, for payment of fees of contractual services
2 rendered, for the purchase or rental of goods, services,
3 printing, equipment, land and buildings and for payment of any
4 other expenses, as provided by law or by this act, necessary for
5 the proper conduct of the duties, functions and activities and
6 for the purposes hereinafter set forth for the fiscal period
7 beginning July 1, 1976 and for the payment of bills incurred and
8 remaining unpaid at the close of the fiscal period ending June
9 30, 1976.

20 SECTION 2. SECTION 9 OF THE ACT IS AMENDED TO READ: <—

21 SECTION 9. (A) EXCEPT AS PROVIDED IN SUBSECTIONS (B) AND
22 (C), THAT PART OF ALL APPROPRIATIONS IN THIS ACT UNEXPENDED,
23 UNCOMMITTED AND UNENCUMBERED AS OF JUNE 30, 1977 SHALL
24 AUTOMATICALLY LAPSE AS OF THAT DATE.

25 (B) THAT PART OF THE APPROPRIATION TO THE PENNSYLVANIA
26 HISTORICAL AND MUSEUM COMMISSION FOR TEMPORARY CUSTODIAL AND
27 SECURITY PERSONNEL, AND MAINTENANCE AS MAY BE UNEXPENDED,
28 UNCOMMITTED AND UNENCUMBERED AS OF NOVEMBER 1, 1976 SHALL
29 AUTOMATICALLY LAPSE AS OF THAT DATE.

30 (C) THE APPROPRIATION TO THE DEPARTMENT OF COMMERCE FOR

1 REIMBURSEMENT TO MUNICIPALITIES FOR BICENTENNIAL RELATED
2 MUNICIPAL OVERBURDEN AND THE APPROPRIATIONS TO THE LEGISLATIVE
3 DEPARTMENT AND TO THE DEPARTMENT OF EDUCATION FOR GRANTS TO
4 PUBLIC LIBRARIES SHALL BE CONTINUING APPROPRIATIONS.

5 Section ~~2~~ 3. This act shall take effect immediately.
