11 "GENERAL APPROPRIATION ACT OF 1977."

12 SECTION 2. THE FOLLOWING SUMS, OR AS MUCH THEREOF AS MAY BE
13 NECESSARY, ARE HEREBY SPECIFICALLY APPROPRIATED FROM THE GENERAL
14 FUND TO THE SEVERAL HEREINAFTER NAMED AGENCIES OF THE EXECUTIVE,
15 LEGISLATIVE AND JUDICIAL DEPARTMENTS OF THE COMMONWEALTH FOR THE
16 PAYMENT OF THE SALARIES, WAGES OR OTHER COMPENSATION AND TRAVEL

21 OTHER EXPENSES, AS PROVIDED BY LAW OR BY THIS ACT, NECESSARY FOR
22 THE PROPER CONDUCT OF THE DUTIES, FUNCTIONS AND ACTIVITIES AND
23 FOR THE PURPOSES HEREINAFTER SET FORTH FOR THE FISCAL PERIOD
24 BEGINNING JULY 1, 1977 AND FOR THE PAYMENT OF BILLS INCURRED AND

2 VEHICLE SUPPLIES AND REPAIRS, FREIGHT, EXPRESS, AND CARTAGE,
3 POSTAGE, TELEPHONES AND TELEGRAPH RENTALS AND TOLL CHARGES,
4 NEWSPAPER ADVERTISING AND NOTICES, FUEL, LIGHT, HEAT, POWER AND
5 WATER, MINOR CONSTRUCTION AND RENOVATION, REPAIRS OR
6 RECONSTRUCTION OF EQUIPMENT, BUILDINGS AND FACILITIES, RENT OF
7 REAL ESTATE AND EQUIPMENT, PREMIUMS ON WORKMEN'S COMPENSATION,
8 INSURANCE PREMIUMS ON POLICIES OF LIABILITY INSURANCE, PREMIUMS
9 ON MEDICAL PAYMENT INSURANCE AND SURETY BONDS FOR VOLUNTEER
10 WORKERS, PREMIUMS ON EMPLOYEE GROUP LIFE INSURANCE, AND EMPLOYEE
11 AND RETIRED EMPLOYEE GROUP HOSPITAL AND MEDICAL INSURANCE,
12 PAYMENT OF THE COMMONWEALTH'S SHARE OF SOCIAL SECURITY TAXES AND
13 UNEMPLOYMENT COMPENSATION COSTS FOR STATE EMPLOYEES, THE
14 PURCHASE OF REPLACEMENT OR ADDITIONAL EQUIPMENT AND MACHINERY
15 AND ALL OTHER INCIDENTAL COSTS AND EXPENSES, INCLUDING PAYMENT
16 TO THE DEPARTMENT OF GENERAL SERVICES OF MILEAGE AND OTHER
17 CHARGES FOR THE USE OF AUTOMOBILES AND RENTAL PAYMENTS FOR
18 PERMANENTLY ASSIGNED AUTOMOBILES AND OF EXPENSES OR COSTS OF
19 SERVICES INCURRED THROUGH THE PURCHASING FUND. THE TERM
20 "EXPENSES" ALSO SHALL INCLUDE THE MEDICAL COSTS FOR THE
21 TREATMENT OF INMATES OF STATE INSTITUTIONS WHEN THE INMATE MUST
22 BE TRANSFERRED TO AN OUTSIDE HOSPITAL: PROVIDED, THAT IN NO CASE
23 SHALL THE STATE INSTITUTION PAY MORE FOR PATIENT CARE THAN THAT
24 PROVIDED UNDER THE STATE MEDICAL ASSISTANCE PROGRAM.

25 SECTION 7. PURCHASE OF SUPPLIES, MATERIALS AND EQUIPMENT
26 SHALL NOT BE DEEMED TO BE COMMITTED OR ENCUMBERED UNTIL
27 CONTRACTS COVERING SAID PURCHASE HAVE BEEN ENTERED INTO WITH THE
28 VENDORS.

29 SECTION 8. (A) IN ADDITION TO THE AMOUNTS APPROPRIATED BY
30 THIS ACT, MONEYS RECEIVED IN PAYMENT FOR FOOD AND HOUSEHOLD

1 SUPPLIES FURNISHED TO EMPLOYEES AND OTHER PERSONS, EXCEPT
2 INMATES, BY AN INSTITUTION, AND MONEYS RECEIVED FROM THE
3 PROCEEDS FROM THE SALE OF ANY PRODUCTS OF THE SOIL, MEATS,
4 LIVESTOCK, TIMBER, OR OTHER MATERIALS SOLD BY THE DEPARTMENT
5 SHALL BE PAID INTO THE GENERAL FUND AND ARE HEREBY APPROPRIATED
6 OUT OF THE GENERAL FUND TO THE SEVERAL RESPECTIVE INSTITUTIONS
7 FOR THE OPERATION AND MAINTENANCE OF SAID INSTITUTIONS.

8 (B) IN ADDITION TO THE AMOUNTS APPROPRIATED BY THIS ACT, ALL
9 MONEYS RECEIVED FROM ANY OTHER SOURCE, EXCEPT THE FEDERAL
10 GOVERNMENT, AS CONTRIBUTIONS FOR THE PROGRAMS PROVIDED HEREIN,
11 OR AS PAYMENT FOR SERVICES OR MATERIALS FURNISHED BY ONE
12 INSTITUTION TO ANOTHER, EXCEPT THOSE COLLECTIONS DESIGNATED AS
13 REVENUES, SHALL BE PAID INTO THE GENERAL FUND AND ARE HEREBY
14 APPROPRIATED OUT OF THE GENERAL FUND FOR THE PURPOSES OF THE
15 RESPECTIVE APPROPRIATIONS.

16 (C) IN ADDITION TO ANY FUNDS SPECIFICALLY APPROPRIATED BY
17 THIS ACT, ALL MONEYS RECEIVED BY A DEPARTMENT OR AGENCY OF THE
18 COMMONWEALTH FROM ANY OTHER SOURCE, EXCEPT THE FEDERAL
19 GOVERNMENT, AS CONTRIBUTIONS OR SUPPLEMENTS TO THE DEPARTMENT OR
20 AGENCY FOR A PROGRAM OR ADMINISTRATION OF AN ACT INCLUDED IN
21 THIS ACT SHALL BE PAID INTO THE GENERAL FUND AND CREDITED TO THE
22 APPROPRIATION FOR THAT PROGRAM OR ADMINISTRATION OF THE ACT.

23 SECTION 9. ALL AMOUNTS PAID BY THE STATE TREASURER IN
24 ACCORDANCE WITH THE ACT OF JUNE 30, 1977 (NO.4-A), ENTITLED "AN
25 ACT MAKING AN APPROPRIATION TO THE STATE TREASURER FOR THE
26 PURPOSE OF PAYING SALARIES AND WAGES OF STATE OFFICERS AND
27 EMPLOYEES AND OTHER ORDINARY AND GENERAL EXPENSES IN THE INTERIM
28 BETWEEN JUNE 30, 1977 AND AUGUST 1, 1977, AND FOR THE PAYMENT OF
29 BILLS INCURRED AND REMAINING UNPAID AT THE CLOSE OF THE FISCAL
30 YEAR ENDING JUNE 30, 1977," SHALL BE CHARGED AGAINST THE

1 APPROPRIATIONS MADE FOR THE SALARIES AND WAGES OF THE OFFICERS
2 AND EMPLOYEES AND OTHER ORDINARY AND GENERAL EXPENSES OF THE
3 STATE GOVERNMENT IN THIS ACT.

4 SECTION 10. (A) EXCEPT AS PROVIDED IN SUBSECTION (C), THAT
5 PART OF ALL APPROPRIATIONS IN THIS ACT UNEXPENDED, UNCOMMITTED
6 AND UNENCUMBERED AS OF JUNE 30, 1978 SHALL AUTOMATICALLY LAPSE
7 AS OF THAT DATE.

8 (B) IT IS THE INTENT OF THE GENERAL ASSEMBLY THAT MONEYS
9 MADE AVAILABLE TO THE LEGISLATIVE DEPARTMENT REMAINING UNSPENT
10 AND UNENCUMBERED FROM APPROPRIATIONS MADE FOR FISCAL YEAR 1975-
11 1976 SHALL LAPSE INTO THE GENERAL FUND.

12 (C) THE APPROPRIATIONS TO THE LEGISLATIVE DEPARTMENT SHALL
13 BE CONTINUING APPROPRIATIONS.

14 SECTION 11. THIS ACT SHALL TAKE EFFECT IMMEDIATELY.
