AN ACT

Amending the act of March 28, 1974 (P.L.228, No.50), entitled 2 "An act providing for the annual announcement of grants by 3 the Pennsylvania Higher Education Assistance Agency; authorizing the continuing appropriation of certain funds; 5 and providing for the manner in which certain appropriations may be revised, " further providing for coordination with 7 Federal financial aid programs. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. The title and sections 1, 2 and 4, act of March 28, 1974 (P.L.228, No.50), referred to as the Higher Education 11 12 Assistance Continuation Law, are amended to read: 13 AN ACT 14 Providing for the annual announcement of grants by the 15 Pennsylvania Higher Education Assistance Agency; authorizing 16 the continuing appropriation of certain funds; providing for coordination with available Federal programs; and providing 17 18 for the manner in which certain appropriations may be 19 revised.

Section 1. In order to encourage needy students to make

- 1 timely application for enrollment in postsecondary educational
- 2 programs and coordinate the State and Federal evaluation and
- 3 announcement of the student's eligibility to receive financial
- 4 <u>aid</u>, the Pennsylvania Higher Education Assistance Agency
- 5 annually, on the first day of [May] March, shall have the
- 6 authority to announce the scholarships and educational
- 7 assistance grants to be awarded by the agency for the next
- 8 succeeding academic year pursuant to the provisions of the act
- 9 of January 25, 1966 (P.L.1546, No.541), entitled "An act
- 10 providing scholarships and providing funds to secure Federal
- 11 funds for qualified students of the Commonwealth of Pennsylvania
- 12 who need financial assistance to attend postsecondary
- 13 institutions of higher learning, making an appropriation, and
- 14 providing for the administration of this act," and the act of
- 15 October 11, 1972 (P.L.909, No.216), known as the "Veterans'
- 16 Education Act of 1971," and the act of October 11, 1972
- 17 (P.L.899, No.213), entitled "An act providing scholarships for
- 18 certain dependents of members of the armed services who while on
- 19 active duty are taken as prisoners of war or are reported
- 20 missing in action and making an appropriation," not to exceed
- 21 the amounts appropriated for the current fiscal year.
- 22 Section 2. In order to carry out the provisions of section 1
- 23 of this act, any appropriation effective during any fiscal year
- 24 providing moneys to the Pennsylvania Higher Education Assistance
- 25 Agency for scholarship grants shall, if the General Assembly
- 26 does not provide by law prior to [May] March 1 of the same
- 27 fiscal year, to increase, lower or terminate the appropriation,
- 28 be deemed to be reenacted for the ensuing fiscal year in the
- 29 same amount and for the same purpose as provided in such
- 30 appropriation: Provided, however, That the reenacted

- 1 appropriation shall not be effective until the first day of the
- 2 ensuing fiscal year.
- 3 Section 4. If the General Assembly at any time hereafter
- 4 shall enact legislation to reduce appropriations for scholarship
- 5 grants prior to the first day of [May] March such enactment
- 6 shall be applicable to the next succeeding academic year. Should
- 7 such enactment be made after the first of [May] March, the
- 8 provisions thereof shall be applicable to the academic year
- 9 following the next succeeding academic year.
- 10 Section 2. This act shall take effect immediately.
