| 9 | Section 1. Section 807.1, act of March 10, 1949 (P.L.30, |
| 10 | No.14), known as the "Public School Code of 1949," amended |
| 11 | February 25, 1972 (P.L.81, No.28), is amended to read: |
| 12 | Section 807.1. Purchase of SuppliesAll furniture, |
| 13 | equipment, textbooks, school supplies and other appliances for |
| 14 | the use of the public schools, costing [fifteen hundred dollars |
| 15 | (\$1,500)] <u>five thousand dollars (\$5,000)</u> or more shall be |
| 16 | purchased by the board of school directors only after due |
| 17 | advertisement as hereinafter provided. Supplies costing two |
| 18 | thousand dollars (\$2,000) or more but less than five thousand |
| 19 | dollars (\$5,000) may be purchased from the lowest responsible |
| 20 | bidder after soliciting sealed guotations from three (3) or more |

firms, manufacturers, or dealers in such supplies. Supplies 1 costing [fifteen hundred dollars (\$1,500)] five thousand dollars 2 3 (\$5,000) or more shall be purchased by the board of school 4 directors only after public notice has been given by advertisement once a week for three (3) weeks in not less than 5 two (2) newspapers of general circulation. In any district where 6 no newspaper is published, said notice may, in lieu of such 7 publication, be posted in at least five (5) public places. 8 9 The board of school directors shall accept the bid of the lowest responsible bidder, kind, quality, and material being 10 11 equal, but shall have the right to reject any and all bids, or select a single item from any bid. The board of school directors 12 13 in any district may authorize or appoint the secretary of the 14 board or other executive as purchasing agent for the district, 15 with authority to purchase supplies costing less than [fifteen hundred dollars (\$1,500)] two thousand dollars (\$2,000). 16 17 The following shall be exempt from the above provisions: 18 maps, music, globes, charts, educational films, filmstrips, 19 prepared transparencies and slides, pre-recorded magnetic tapes 20 and disc recordings, textbooks, games, toys, prepared kits, flannel board materials, flash cards, models, projectuals and 21 22 teacher demonstration devices necessary for school use. 23 Section 2. This act shall take effect immediately.
