## AN ACT

- 1 Amending the act of April 18, 1949 (P.L.599, No.126), entitled
- 2 "An act establishing, within the limits of Philadelphia, the
- 3 Eastern Pennsylvania Psychiatric Institute as a State
- 4 institution; providing for a board of trustees and a medical
- 5 advisory board therefor; conferring powers and imposing duties
- 6 upon the Department of Property and Supplies, the Department of
- 7 Welfare, the board of trustees and the medical advisory board,"
- 8 further providing for treatment of patients; authorizing the
- 9 leasing of certain property and further providing for certain
- 10 agreements.
- 11 The General Assembly of the Commonwealth of Pennsylvania
- 12 hereby enacts as follows:
- 13 Section 1. Section 1, act of April 18, 1949 (P.L.599,
- 14 No.126), entitled "An act establishing, within the limits of
- 15 Philadelphia, the Eastern Pennsylvania Psychiatric Institute as
- 16 a State institution; providing for a board of trustees and a
- 17 medical advisory board therefor; conferring powers and imposing
- 18 duties upon the Department of Property and Supplies, the
- 19 Department of Welfare, the board of trustees and the medical
- 20 advisory board, " amended October 19, 1967 (P.L.458, No.215), is
- 21 amended to read:
- 22 Section 1. There is hereby directed to be established and
- 23 erected, at a site within the limits of the City of Philadelphia
- 24 to be designated by the Department of Public Welfare with the
- 25 approval of the Governor, the Eastern Pennsylvania Psychiatric
- 26 Institute. [The institute shall accept patients with mental,
- 27 neurological and related disorders who present special problems
- 28 in diagnosis and treatment, including those transferred by the
- 29 department from other State Hospitals.] It shall provide
- 30 training and teaching to graduate and undergraduate students in
- 31 the mental health field and shall conduct research into the
- 32 causes, prevention, treatment and cure of mental, neurological

- 1 and related disorders. Through the department, the institute may
- 2 enter into agreements specifying the terms and conditions under
- 3 which one or more medical schools selected by the Secretary of
- 4 Public Welfare may be associated with the institute in providing
- 5 diagnosis, treatment, training, teaching and research. Such
- 6 agreements may provide for the transfer of responsibility by the
- 7 <u>department for the management and operation of the institute in</u>
- 8 whole or in part.
- 9 Section 2. The act is amended by adding a section to read:
- 10 <u>Section 3.1. The Department of General Services, with the</u>
- 11 approval of the Governor, is authorized to lease or sublease,
- 12 <u>all or part of the land and buildings known as the Eastern</u>
- 13 Pennsylvania Psychiatric Institute, and equipment therein, as
- 14 appropriate to medical schools selected by the Secretary of
- 15 Public Welfare upon such terms and conditions as the Secretary
- 16 of the Department of General Services may prescribe.
- 17 Section 3. This act shall take effect immediately.
