## AN ACT

Amending the act of June 3, 1937 (P.L.1333, No.320), entitled 2 "An act concerning elections, including general, municipal, 3 special and primary elections, the nomination of candidates, 4 primary and election expenses and election contests; creating 5 and defining membership of county boards of elections; 6 imposing duties upon the Secretary of the Commonwealth, 7 courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, 8 9 revising and consolidating the laws relating thereto; and repealing certain acts and parts of acts relating to 10 11 elections, " changing the dates for the Municipal and General 12 primaries and making related changes. 13 The General Assembly of the Commonwealth of Pennsylvania 14 hereby enacts as follows: 15 Section 603, act of June 3, 1937 (P.L.1333, Section 1. 16 No.320), known as the "Pennsylvania Election Code," amended December 22, 1971 (P.L.613, No.165), is amended to read: 17 18 Section 603. General Primary; Candidates to Be Nominated and 19 Party Officers to Be Elected. -- There shall be a General primary 20 preceding each general election which shall be held on the 21 [third Tuesday of May] second Tuesday of September in all even-

- 1 numbered years, except in years when such date would immediately
- 2 <u>follow Labor Day in which case the General primary shall be held</u>
- 3 on the preceding Tuesday, and except in the year of the
- 4 nomination of a President of the United States, in which year
- 5 the General primary shall be held on the fourth Tuesday of
- 6 April. Candidates for all offices to be filled at the ensuing
- 7 general election shall be nominated at the General primary. The
- 8 vote for candidates for the office of President of the United
- 9 States, as provided for by this act, shall be cast at the
- 10 General primary.
- 11 Section 2. Section 604 of the act amended January 14, 1952
- 12 (1951 P.L.1937, No.540), is amended to read:
- 13 Section 604. Municipal Primary; Officers to be Nominated.--
- 14 There shall be a Municipal primary preceding each municipal
- 15 election which shall be held on the [third Tuesday of May]
- 16 second Tuesday of September in all odd-numbered years except in
- 17 years when such date would immediately follow Labor Day in which
- 18 case the Municipal primary shall be held on the preceding
- 19 Tuesday. Candidates for all offices to be filled at the ensuing
- 20 municipal election shall be nominated at the Municipal primary.
- 21 Section 3. Sections 978 and 978.1 of the act amended August
- 22 13, 1963 (P.L.707, No.379) and section 978.1 repealed in part
- 23 April 28, 1978 (No.53), are amended to read:
- 24 Section 978. Withdrawal of Nominated Candidates.--Any person
- 25 who has been nominated by any political party or political body,
- 26 in accordance with the provisions of this act, as a candidate
- 27 for the office of presidential elector, United States Senator,
- 28 Representative in Congress or for any State office, including
- 29 that of senator, representative and judge of court of record,
- 30 may withdraw his name from nomination by request in writing,

- 1 signed by him and acknowledged before an officer qualified to
- 2 take acknowledgement of deeds, and filed in the office of the
- 3 Secretary of the Commonwealth. Any person who has been similarly
- 4 nominated as a candidate for any other office may withdraw his
- 5 name from nomination by similar request, filed with the county
- 6 board of elections of the proper county. Such written
- 7 withdrawals shall be filed with the Secretary of the
- 8 Commonwealth or the county board of elections, as the case may
- 9 be, at least [eighty-five (85)] thirty-five (35) days previous
- 10 to the day of the general or municipal election. Such
- 11 withdrawals to be effective must be received in the office of
- 12 the Secretary of the Commonwealth not later than five (5)
- 13 o'clock P. M. on the last day for filing same, and in the office
- 14 of any county board of elections not later than the ordinary
- 15 closing hour of said office on the last day for filing same. No
- 16 name so withdrawn shall be printed upon the ballot or ballot
- 17 labels. No candidate may withdraw any withdrawal notice already
- 18 received and filed, and thereby reinstate his nomination.
- 19 Section 978.1. Vacancy in Party Nomination by Failure to Pay
- 20 Filing Fee or for Failure to File Loyalty Oath. -- Every person
- 21 nominated at any primary election as the candidate of any
- 22 political party for any office, other than a borough, town,
- 23 township, school district or poor district office, or the office
- 24 of justice of the peace, or constable, who has not paid the
- 25 filing fee required by section nine hundred thirteen of this
- 26 act, as amended, for the filing of a nomination petition for
- 27 such office, or who has not filed the loyalty oath required by
- 28 section 14, act of December 22, 1951 (P.L.1726), known as the
- 29 "Pennsylvania Loyalty Act," as last amended June 19, 1961
- 30 (P.L.446), shall pay the amount of such fee to and file such

- 1 oath with the Secretary of the Commonwealth, or the county board
- 2 of elections, as the case may be, at least [eighty-five (85)]
- 3 <u>thirty-five (35)</u> days previous to the day of the general or
- 4 municipal election at which such candidate's name would appear
- 5 on the ballot. Failure to pay such fee or file such oath within
- 6 the time herein prescribed shall result in a vacancy in such
- 7 party nomination. Such vacancy shall be filled in the manner
- 8 hereinafter provided for the filling of such vacancies happening
- 9 by reason of the death or withdrawal of any candidate.
- 10 Section 4. Section 978.3 of the act added January 16, 1974
- 11 (P.L.5, No.2), is amended to read:
- 12 Section 978.3. Vacancy Due to Revocation of Declaration of
- 13 Candidacy for Retention. -- In the event a justice or a judge had
- 14 filed a declaration of candidacy for retention under the
- 15 provisions of section 15 of the Constitution of the Commonwealth
- 16 of Pennsylvania and thereafter, but after the thirteenth Tuesday
- 17 preceding the primary election and prior to [sixty (60)] forty
- 18 (40) days preceding the municipal election revoked the
- 19 declaration by notifying the Secretary of the Commonwealth in
- 20 writing of the same, nomination to fill such vacancy shall be
- 21 made in accordance with section 993 of this act.
- 22 Section 5. Subsection (a) of section 981 and subsection (b)
- 23 of section 993 of the act, amended August 13, 1963 (P.L.707,
- 24 No.379), are amended to read:
- 25 Section 981. Time for Filing Substituted Nomination
- 26 Certificates.--(a) Substituted nomination certificates to fill
- 27 vacancies caused by the withdrawal of candidates nominated at
- 28 primaries or by nomination papers shall be filed with the
- 29 Secretary of the Commonwealth or proper county board of
- 30 elections, as the case may be, at least [seventy-five (75)]

- 1 thirty (30) days before the day of the general or municipal
- 2 election: Provided, however, That no substituted nomination
- 3 certificate by a political body may be filed until after the
- 4 primary election.

- 6 Section 993. Filling of Certain Vacancies in Public Office
- 7 by Means of Nomination Certificates and Nomination Papers. --
- 8 \* \* \*
- 9 (b) Said nomination certificates and nomination papers for
- 10 State public offices and judges of courts of records shall be
- 11 filed in the office of the Secretary of the Commonwealth at
- 12 least [fifty (50)] thirty (30) days prior to a general or
- 13 municipal election, as the case may be. Nomination certificates
- 14 and nomination papers for public offices in counties, cities,
- 15 boroughs, towns, townships, wards and school districts and for
- 16 the offices of aldermen and justices of the peace shall be filed
- 17 in the office of the county board of elections at least [fifty
- 18 (50)] thirty (30) days prior to a municipal election.

- 20 Section 6. Section 1756 of the act is amended to read:
- 21 Section 1756. Petition; Time of Filing; Amendment.--The
- 22 commencement of proceedings in the case of contests of the
- 23 second, third, fourth and fifth classes shall be by petition,
- 24 which shall be made and filed, as herein required, within
- 25 [twenty] fifteen days after the day of the primary or election,
- 26 as the case may be. The petition shall concisely set forth the
- 27 cause of complaint, showing wherein it is claimed that the
- 28 primary or election is illegal, and after filing may be amended
- 29 with leave of court, so as to include additional specifications
- 30 of complaint. After any such amendment, a reasonable time shall

- 1 be given to the other party to answer.
- 2 Section 7. This act shall take effect January 1, 1981 and
- 3 shall be applicable to all elections held thereafter.
