AN ACT

Amending the act of July 28, 1953 (P.L.723, No.230), entitled, 2 as amended, "An act relating to counties of the second class 3 and second class A; amending, revising, consolidating and 4 changing the laws relating thereto, "providing for veterans' organizations' representation as members of the board of managers of a memorial hall. 6 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 9 Section 1. Subsection (b) of section 2565 and section 2566, 10 act of July 28, 1953 (P.L.723, No.230), known as the "Second 11 Class County Code, amended June 19, 1961 (P.L.463, No.232), are 12 amended to read: 13 Section 2565. Personnel. -- The board of managers shall 14 consist of: 15 (b) Elective members [(fifteen): the present elective 16 17 members representing the Veterans of the Civil War shall be and

continue as members of such board until removed by death,

resignation, or otherwise] (twenty-two): [The remaining] the

- 1 members of the elective [(fifteen)] (twenty-two) shall be filled
- 2 by the following organizations out of their membership: [(three)
- 3 by the county organization of the United Spanish War Veterans;
- 4 (three)] (four) by the county organization of the American
- 5 Legion; [(three)] (four) by the county organization of the
- 6 Veterans of Foreign Wars; [(three)] (two) by the county
- 7 organizations of the Italian American War Veterans of the United
- 8 States, Incorporated; (three) by the county organization of the
- 9 <u>Disabled American Veterans; (two) by the county organization of</u>
- 10 the Jewish War Veterans; (two) by the county organization of the
- 11 <u>Catholic War Veterans; (two) by the county organization of the</u>
- 12 American Veterans of World War II, Korea and Vietnam; (one) by
- 13 the county organization of the Marine Corps League; (one) by the
- 14 county organization of the Veterans of World War I, United
- 15 States of America, Incorporated; (one) by the county
- 16 <u>organization of the Military Order of the Purple Heart</u>; within
- 17 thirty days from the date when this act becomes effective; and
- 18 they shall certify such election to the secretary of the
- 19 existing board, whereupon the persons so elected shall be
- 20 members of the board.
- 21 Section 2566. Vacancies. -- Vacancies occurring among the
- 22 elective members of the board shall be filled by the
- 23 organization which chose the members whose place it is desired
- 24 to fill. [Provided, however, That whenever it may appear that it
- 25 is impossible to fill any vacancy in the board caused by the
- 26 death or resignation of a member thereof who represented the
- 27 Veterans of the Civil War because no organization survives to
- 28 choose such members or no person survives who can qualify for
- 29 such membership, vacancies so created and existing shall, upon
- 30 notice from the secretary, be filled by the county organizations

- 1 of the United Spanish War Veterans and the American Legion and
- 2 the Veterans of Foreign Wars and the Italian American War
- 3 Veterans of the United States, Incorporated. That is to say, the
- 4 first vacancy so caused shall be filled by the county
- 5 organization of the United Spanish War Veterans, the second by
- 6 the county organization of the American Legion, and the third by
- 7 the county organization of the Veterans of Foreign Wars, and so
- 8 on in rotation. That is to say, that when no member representing
- 9 the Veterans of the Civil War shall remain on said board, the
- 10 elective personnel of the board shall be as follows: Elective
- 11 members sixteen; United Spanish War Veterans (four); American
- 12 Legion (four); Veterans of Foreign Wars (four); Italian American
- 13 War Veterans of the United States, Incorporated (four).]
- 14 Section 2. This act shall take effect immediately.
