- 2 Section 322. Eligibility; Incompatible Offices. -- Any citizen
- 3 of this Commonwealth, having a good moral character, being
- 4 eighteen (18) years of age or upwards, being a registered
- 5 <u>elector</u>, and having been a resident of the district for at least
- 6 one (1) year prior to the date of his election or appointment,
- 7 shall be eligible to the office of school director therein:
- 8 Provided, That any person holding any office or position of
- 9 profit under the government of any city of the first class, or
- 10 the office of mayor, chief burgess, county commissioner,
- 11 district attorney, city, borough, or township treasurer, member
- 12 of council in any municipality, township commissioner, township
- 13 supervisor, tax collector, assessor, assistant assessor, any
- 14 comptroller, auditor, constable, executive director or assistant
- 15 executive director of an intermediate unit, supervisor,
- 16 principal, teacher, or employe of any school district, shall not
- 17 be eliqible as a school director in this Commonwealth. This
- 18 section shall not prevent any district superintendent, assistant
- 19 district superintendent, supervisor, teacher, or employe of any
- 20 school district, from being a school director in a district
- 21 other than the one in which he is so employed, and other than in
- 22 a district with which the district in which he is employed
- 23 operates a joint school or department: PROVIDED, HOWEVER, THAT A <
- 24 JOINT SCHOOL OR DEPARTMENT DOES NOT INCLUDE A VOCATIONAL SCHOOL,
- 25 INTERMEDIATE UNIT OR COMMUNITY COLLEGE: AND PROVIDED FURTHER,
- 26 THAT A SCHOOL DIRECTOR WHO IS A SUPERVISOR, PRINCIPAL, TEACHER
- 27 OR EMPLOYE OF A VOCATIONAL SCHOOL, INTERMEDIATE UNIT OR
- 28 COMMUNITY COLLEGE SHALL NOT SERVE AS A MEMBER OF A BOARD OF THE
- 29 VOCATIONAL SCHOOL, INTERMEDIATE UNIT OR COMMUNITY COLLEGE IN
- 30 WHICH HE IS A SUPERVISOR, PRINCIPAL, TEACHER OR EMPLOYE. A

- 3 SECTION 910-A. INTERMEDIATE UNIT BOARD OF DIRECTORS.--(A)

- 4 THE INTERMEDIATE UNIT BOARD OF DIRECTORS SHALL BE COMPOSED OF
- 5 THIRTEEN MEMBERS EXCEPT AS OTHERWISE PROVIDED FOR IN THIS
- 6 SUBSECTION, CHOSEN FOR TERMS OF THREE YEARS FROM AMONG MEMBERS
- 7 OF THE BOARDS OF SCHOOL DIRECTORS OF SCHOOL DISTRICTS COMPRISING
- 8 THE INTERMEDIATE UNIT. AN INTERMEDIATE UNIT DIRECTOR MAY SUCCEED
- 9 HIMSELF WITHOUT LIMITATION AS TO THE NUMBER OF TERMS. [AT NO
- 10 TIME SHALL MORE THAN ONE DIRECTOR FROM ANY SCHOOL DISTRICT BE
- 11 ELECTED TO AN INTERMEDIATE UNIT BOARD OF DIRECTORS.] WHERE THERE
- 12 ARE FEWER THAN THIRTEEN SCHOOL DISTRICTS WITHIN AN INTERMEDIATE
- 13 UNIT, THERE SHALL BE ONE SCHOOL DIRECTOR FROM EACH SCHOOL
- 14 DISTRICT ELECTED TO THE INTERMEDIATE UNIT BOARD OF DIRECTORS,
- 15 BUT ANY SUCH SCHOOL DISTRICT INTERMEDIATE UNIT BOARD OF
- 16 <u>DIRECTORS MAY ELECT ONE ADDITIONAL AT-LARGE MEMBER.</u> WHEN THERE
- 17 ARE MORE THAN THIRTEEN DISTRICTS IN AN INTERMEDIATE UNIT EACH
- 18 DISTRICT, AS FAR AS PRACTICABLE, MAY HAVE ONE MEMBER ON THE UNIT
- 19 BOARD, UP TO A MAXIMUM OF TWENTY MEMBERS. THE ELECTION OF
- 20 INTERMEDIATE UNIT BOARDS OF DIRECTORS SHALL BE BY PROPORTIONATE
- 21 BALLOT, AND EACH SCHOOL DIRECTOR OF EACH SCHOOL DISTRICT WITHIN
- 22 AN INTERMEDIATE UNIT SHALL BE ENTITLED TO CAST VOTES DETERMINED
- 23 BY DIVIDING THE WEIGHTED AVERAGE DAILY MEMBERSHIP OF THE SCHOOL
- 24 DISTRICT BY THE TOTAL WEIGHTED AVERAGE DAILY MEMBERSHIP WITHIN
- 25 THE INTERMEDIATE UNIT, MULTIPLYING THE QUOTIENT SO OBTAINED BY
- 26 ONE THOUSAND, DIVIDING THE PRODUCT SO OBTAINED BY THE NUMBER OF
- 27 DIRECTORS AS PROVIDED FOR ABOVE, AND ROUNDING SUCH DIVIDEND TO
- 28 THE NEAREST WHOLE NUMBER: PROVIDED, HOWEVER, THAT EACH SCHOOL
- 29 DIRECTOR SHALL HAVE AT LEAST ONE VOTE. THE SECRETARY OF
- 30 EDUCATION SHALL ANNUALLY, NOT LATER THAN THE FIRST DAY OF

- 1 FEBRUARY, CERTIFY THE WEIGHTED AVERAGE DAILY MEMBERSHIP FOR THE
- 2 PREVIOUS SCHOOL YEAR FOR EACH SCHOOL DISTRICT AND FOR EACH
- 3 INTERMEDIATE UNIT, AND SHALL COMPUTE THE NUMBER OF VOTES TO
- 4 WHICH EACH SCHOOL DIRECTOR OF EACH SCHOOL DISTRICT WITHIN AN
- 5 INTERMEDIATE UNIT SHALL BE ENTITLED.

- 9 (D) PURCHASE OF TEXTBOOKS AND INSTRUCTIONAL MATERIALS. THE
- 10 SECRETARY SHALL NOT BE REQUIRED TO PURCHASE OR OTHERWISE ACQUIRE
- 11 TEXTBOOKS, PURSUANT TO THIS SECTION, THE TOTAL COST OF WHICH, IN
- 12 ANY SCHOOL YEAR, SHALL EXCEED AN AMOUNT EQUAL TO TWELVE DOLLARS
- 13 (\$12) FOR THE SCHOOL YEAR 1973-1974, FIFTEEN DOLLARS (\$15) FOR
- 14 THE SCHOOL YEAR BEGINNING JULY 1, 1974 [AND], {TWENTY DOLLARS
- 15 (\$20) FOR THE SCHOOL YEAR BEGINNING JULY 1, 1975 AND TWENTY-
- 16 SEVEN DOLLARS (\$27) FOR THE SCHOOL YEAR BEGINNING JULY 1, 1980
- 17 AND FOR EACH SCHOOL YEAR THEREAFTER OR INSTRUCTIONAL MATERIALS,
- 18 THE TOTAL COST OF WHICH, IN ANY SCHOOL YEAR, SHALL EXCEED AN
- 19 AMOUNT EQUAL TO TEN DOLLARS (\$10), MULTIPLIED BY THE NUMBER OF
- 20 CHILDREN RESIDING IN THE COMMONWEALTH WHO ON THE FIRST DAY OF
- 21 OCTOBER OF THE SCHOOL YEAR IMMEDIATELY PRECEDING ARE ENROLLED IN
- 22 GRADES KINDERGARTEN THROUGH TWELVE OF A NONPUBLIC SCHOOL.
- 23 SECTION 1106. DUTY TO EMPLOY. -- THE BOARD OF SCHOOL DIRECTORS
- 24 IN EVERY SCHOOL DISTRICT SHALL EMPLOY THE NECESSARY QUALIFIED
- 25 PROFESSIONAL EMPLOYES, SUBSTITUTES AND TEMPORARY PROFESSIONAL
- 26 EMPLOYES TO KEEP THE PUBLIC SCHOOLS OPEN IN THEIR RESPECTIVE
- 27 DISTRICTS IN COMPLIANCE WITH THE PROVISIONS OF THIS ACT. NO
- 28 SCHOOL DISTRICT SHALL REQUIRE THAT ANY EMPLOYE RESIDE WITHIN THE
- 29 SCHOOL DISTRICT AS A CONDITION FOR APPOINTMENT OR CONTINUED
- 30 EMPLOYMENT. A SCHOOL DISTRICT MAY REQUIRE ITS SCHOOL EMPLOYES TO

- 1 RESIDE IN PENNSYLVANIA.
- 2 SECTION 1501. MINIMUM NUMBER OF DAYS; SCHOOL MONTH. -- ALL
- 3 PUBLIC KINDERGARTENS, ELEMENTARY AND SECONDARY SCHOOLS SHALL BE
- 4 KEPT OPEN EACH SCHOOL YEAR FOR AT LEAST ONE HUNDRED EIGHTY (180)
- 5 DAYS OF INSTRUCTION FOR PUPILS. NO DAYS ON WHICH THE SCHOOLS ARE
- 6 CLOSED SHALL BE COUNTED AS DAYS TAUGHT, AND NO TIME SHALL BE
- 7 COUNTED AS A PUPIL SESSION FOR ANY ACTIVITY TO WHICH ADMISSION
- 8 IS CHARGED. NO FOR THE SCHOOL YEAR 1979-1980, NO SCHOOL DISTRICT <-
- 9 SHALL BE REQUIRED TO CHANGE ITS GRADUATION SCHEDULE OR REQUIRE
- 10 GRADUATING STUDENTS TO RETURN TO SCHOOL AFTER GRADUATION TO MAKE
- 11 UP CLASS DAYS LOST DUE TO SEVERE WEATHER CONDITIONS OR FOR
- 12 <u>SITUATIONS BEYOND THE CONTROL OF THE SCHOOL DISTRICT AS A RESULT</u>
- 14 FOR THE SCHOOL YEAR 1979-1980, NO DISTRICT WHICH MAKES A BONA
- 15 FIDE EFFORT AS DETERMINED BY THE SECRETARY OF EDUCATION TO
- 16 PROVIDE ONE HUNDRED EIGHTY (180) DAYS OF INSTRUCTION FOR
- 17 GRADUATING STUDENTS SHALL RECEIVE LESS SUBSIDY PAYMENTS OR
- 18 REIMBURSEMENTS THAN IT WOULD OTHERWISE BE ENTITLED TO RECEIVE ON
- 19 ACCOUNT OF THE SCHOOL YEAR BECAUSE OF THE PROVISIONS OF THIS
- 20 <u>SECTION.</u> UNLESS OTHERWISE PROVIDED BY THIS ACT, THE BOARD OF
- 21 SCHOOL DIRECTORS IN ANY DISTRICT OR JOINT BOARD MAY KEEP SUCH
- 22 OTHER SCHOOLS OR DEPARTMENTS AS IT MAY ESTABLISH OPEN DURING
- 23 SUCH TIME AS IT MAY DIRECT.

- 26 SECTION 2523. SCHOOLS CLOSED ON ACCOUNT OF CONTAGIOUS
- 27 DISEASE, ETC.--WHEN ANY BOARD OF SCHOOL DIRECTORS OR
- 28 INTERMEDIATE UNIT WITH RESPECT TO AREA TECHNICAL SCHOOLS IS
- 29 COMPELLED TO CLOSE ANY SCHOOL OR SCHOOLS ON ACCOUNT OF ANY
- 30 CONTAGIOUS DISEASE, [THE DESTRUCTION OR DAMAGE OF A SCHOOL

- 1 BUILDING BY FIRE OR OTHERWISE,] MAJOR CONSTRUCTION OR RENOVATION
- 2 TO A SCHOOL BUILDING, NATURAL DISASTER OR OTHER EMERGENCY, NOT
- 3 <u>INCLUDING LABOR DISPUTES INVOLVING SCHOOL EMPLOYES</u>, AND THEREFOR
- 4 IS UNABLE TO KEEP SUCH SCHOOL OR SCHOOLS OPEN FOR THE MINIMUM
- 5 TERM REQUIRED BY THIS ACT, THE [SUPERINTENDENT OF PUBLIC
- 6 INSTRUCTION] SECRETARY OF EDUCATION MAY PAY TO SUCH SCHOOL
- 7 DISTRICT OR INTERMEDIATE UNIT ANY OR ALL OF ITS SHARE OF THE
- 8 ANNUAL STATE APPROPRIATION AS HE DEEMS PROPER.
- 9 Section 2. This act shall take effect immediately.
