AN ACT

- 1 Authorizing the conveyance of Commonwealth lands in Erie County
- 2 to Erie County, providing for the control and management of
- 3 the lands, designating the lands as Presque Island Park and
- 4 making repeals.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Conveyance of lands.
- 8 The Department of Environmental Resources through the
- 9 Department of General Services, acting on behalf of the
- 10 Commonwealth of Pennsylvania, with the approval of the Governor,
- 11 is hereby authorized to convey to the county of Erie, all those
- 12 certain parcels or tracts of land and land covered with water
- 13 situated in the city, county Erie and Commonwealth of
- 14 Pennsylvania described as follows, to wit:
- 15 First. The Presque Isle Peninsula.
- 16 Second. That tract beginning at the northeast corner of
- 17 fifty (50) acre tract, number twenty-seven, in the third section
- 18 of the town of Erie, as finally laid out and sold; thence by the
- 19 north line of fifty (50) acre tracts, numbering from twenty-

- 1 seven to thirty-nine inclusive, following as nearly as may be
- 2 the shore of the Bay of Presque Isle, south sixty-three degrees
- 3 ten minutes west nine thousand two hundred sixty-six (9,266)
- 4 feet to a post, the northwest corner of fifty (50) acre tract,
- 5 number thirty-nine, and the northeast corner of reserve tract,
- 6 number five; thence north twenty-seven degrees fifteen minutes
- 7 west (it being the east line of reserve tract, number five
- 8 produced) fourteen hundred (1,400) feet, more or less, to the
- 9 United States harbor line extended; thence by the United States
- 10 harbor line extended north sixty-two degrees thirty-five minutes
- 11 east nine thousand two hundred sixty-six (9,266) feet to a point
- 12 in the United States harbor line; thence south twenty-seven
- 13 degrees fifteen minutes east seventeen hundred (1,700) feet,
- 14 more or less, to the place of beginning, being the water
- 15 property in the Bay of Presque Isle, in front, adjoining and
- 16 north of the third section of the town of Erie as originally
- 17 laid out.
- 18 Third. All of the shores of Presque Isle Peninsula and the
- 19 waters adjacent thereto, and the lands under said waters to a
- 20 distance of five hundred feet out from low water mark, as well
- 21 as all of that part of the Bay of Presque Isle known as Misery
- 22 Bay, together with the lands thereunder and the shores thereof.
- 23 The conveyance shall be made under and subject to all
- 24 easements, servitudes and rights of others, including but not
- 25 confined to streets, roadways, and rights of any telephone,
- 26 telegraph, water, electric, sewer, gas or pipeline companies, as
- 27 well as under and subject to any interest, estates, or tenancies
- 28 vested in third persons, whether or not appearing of record, for
- 29 any portion of the land or improvements erected thereon.
- 30 Section 2. Reservation clause.

- 1 The Deed of Conveyance shall contain a clause that the lands
- 2 conveyed shall be used for public park purposes by the county of
- 3 Erie and if at any time the county of Erie conveys said property
- 4 or authorizes or permits said property to be used for any
- 5 purpose other than public park purposes, the title thereto shall
- 6 immediately revert to and revest in the Commonwealth of
- 7 Pennsylvania.
- 8 Section 3. Approval of deed.
- 9 The Deed of Conveyance shall be approved by the Department of
- 10 Justice and shall be executed by the Secretary of General
- 11 Services for the Department of Environmental Resources in the
- 12 name of the Commonwealth of Pennsylvania.
- 13 Section 4. Lands to be controlled by county of Erie.
- 14 The lands described in section 1 shall be controlled, managed
- 15 and administered by the county of Erie or its designated agency
- 16 or commission.
- 17 Section 5. Lands to be known as Presque Island Park.
- 18 The lands described in section 1 shall be known as the
- 19 Presque Island Park.
- 20 Section 6. Repeals.
- 21 All acts and parts of acts inconsistent herewith are
- 22 repealed.
- 23 Section 7. Effective date.
- 24 This act shall take effect in 60 days.
