AN ACT

1 Amending Title 42 (Judiciary and Judicial Procedure) of the
2 Pennsylvania Consolidated Statutes, adding additional judges
3 to courts of common pleas in Lycoming, Butler, Montgomery,
4 ~~Carbon~~, Lebanon, Bucks, York, Mercer, Chester, Westmoreland, <—
5 LEHIGH and Delaware counties. <—

6 The General Assembly of the Commonwealth of Pennsylvania
7 hereby enacts as follows:

8 Section 1. Subsection (a) of section 911 of Title 42, act of
9 November 25, 1970 (P.L.707, No.230), known as the Pennsylvania
10 Consolidated Statutes, amended November 26, 1978 (P.L.1264,
11 No.301), is amended to read:

12 § 911. Courts of common pleas.

13 (a) General rule.--There shall be one court of common pleas
14 for each judicial district of this Commonwealth consisting of
