## AN ACT

- 1 Establishing a county prison board for any county of the second class and providing for the powers and duties thereof.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the "Second Class
- 7 County Prison Board Act."
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have, unless the context clearly indicates otherwise, the
- 11 meanings given to them in this section:
- 12 "Board." The county prison board of a second class county.
- 13 Section 3. Establishment and composition.
- 14 (a) Establishment.--There is hereby established a county
- 15 prison board in any county of the second class which shall be
- 16 named the " County Prison Board."
- 17 (b) Composition.--The board shall be composed of:

- 1 (1) The county commissioners.
- 2 (2) The president judge of the court of common pleas of
- 3 the county.
- 4 (3) The county sheriff.
- 5 (4) The county controller.
- 6 (5) The mayor of any city of the second class situate
- 7 within the county.
- 8 (6) Four citizen members as provided in subsection (c).
- 9 (c) Citizen members.--The four citizen members shall not be
- 10 employees of the county or of the Commonwealth. They shall serve
- 11 for a term of three years. Two citizen members shall be
- 12 appointed by the chairman of the county commissioners and two
- 13 shall be appointed by the president judge of the court of common
- 14 pleas.
- 15 Section 3. Powers and duties.
- 16 (a) General rule. -- The board shall administer the county
- 17 prison to include the operation and maintenance of the prison,
- 18 the safekeeping of inmates and the employment of a warden.
- 19 (b) Living conditions.--The board shall insure that the
- 20 living conditions within the prison are healthful and otherwise
- 21 adequate.
- 22 (c) Inspection.--The board shall, at least twice each year,
- 23 conduct an unannounced inspection of the prison's physical
- 24 plant. During such inspections the board shall interview a
- 25 cross-section of inmates, out of the presence of the warden and
- 26 his agents, to determine the conditions within the prison.
- 27 (d) Compliance with laws and regulations.--The board shall
- 28 insure that the prison is being operated in accordance with its
- 29 regulations, the laws and regulations of the Commonwealth and of
- 30 the United States.

- 1 (e) Investigations.--The board shall investigate allegations
- 2 of inadequate prison conditions and improper practices occurring
- 3 within the prison and may make such other investigations or
- 4 reviews of prison operation and maintenance. The books, papers
- 5 and records of the prison, including but not limited to, the
- 6 papers and records of the warden and those relating to
- 7 individual inmates, shall at all times be available for
- 8 inspection by the board.
- 9 Section 4. Rules and regulations.
- 10 The board shall, in the manner provided by law, promulgate
- 11 such rules, regulations and forms it deems necessary for the
- 12 proper administration of the board and for the operation of the
- 13 prison.
- 14 Section 5. Warden.
- 15 (a) Appointment.--The board shall appoint a warden to serve
- 16 at its pleasure and shall fix his salary.
- 17 (b) Employees.--Subject to the board's approval, the warden
- 18 shall employ such deputies, assistants and other personnel
- 19 required to adequately operate the prison.
- 20 Section 6. Board meetings.
- 21 The board shall meet at least once each month and shall keep
- 22 regular minutes of its proceedings which shall be open to public
- 23 inspection.
- 24 Section 7. Contracts and purchases.
- 25 All expenditures, required for the maintenance and support of
- 26 the prisoners, the repairs and improvement of said prison, shall
- 27 be paid from the county treasury, by warrants, drawn in the
- 28 manner provided by law, on the regular appropriation for the
- 29 purpose. All contracts involving an expenditure exceeding \$100
- 30 shall be in writing and shall immediately after their execution

- 1 be filed with the controller of the county. No contracts shall
- 2 be made, nor the payment thereof be certified by the controller,
- 3 for over \$500, unless made with the lowest and best bidder after
- 4 due notice to be pubished by the controller, if he approved the
- 5 purpose of the proposals invited. All purchases of materials and
- 6 supplies shall be made through the purchasing department of the
- 7 county, and all bids shall be received by the controller under
- 8 seal and shall be opened in his presence by the board and the
- 9 contracts awarded thereof. The controller shall keep a record of
- 10 all such awards and shall certify no warrant for contracts not
- 11 made agreeable thereto.
- 12 Section 8. Transition provisions.
- 13 (a) Certain boards abolished.--Any board of prison
- 14 inspectors or board of managers of prisons or workhouses are
- 15 hereby abolished on the effective date of this act.
- 16 (b) Books and records.--All books, papers and records of
- 17 these boards shall be transferred to the county prison board.
- 18 (c) Property and contracts. -- The county prison board shall
- 19 assume ownership of all real and personal property owned by the
- 20 boards abolished in subsection (a) and shall assume all rights,
- 21 duties and obligations of any contract entered into by the
- 22 abolished boards.
- 23 Section 9. Repeals.
- 24 (a) Specific repeals.--The following acts and supplements to
- 25 acts are hereby repealed absolutely:
- 26 Act of March 23, 1865 (P.L.607, No.599), entitled "An act for
- 27 the better management of the Allegheny county prison."
- 28 Act of February 1, 1866 (P.L.8, No.11), entitled "A
- 29 supplement to an act, entitled 'An Act for the better management
- 30 of the Allegheny county prison, approved the twenty-third day

- 1 of March, Anno Domini one thousand eight hundred and sixty-
- 2 five."
- 3 Act of April 4, 1868 (P.L.691, No.640), entitled "A
- 4 supplement to an act, entitled 'A supplement to an act for the
- 5 better management of the Allegheny county prison, 'approved the
- 6 first day of February, eighteen hundred and sixty-six."
- 7 Act of January 28, 1870 (P.L.94, No.71), entitled "A
- 8 supplement to an act, entitled 'A supplement to an act for the
- 9 better management of Allegheny county prison, 'approved the
- 10 first day of February, Anno Domini one thousand eight hundred
- 11 and sixty-six."

- 6 of the Allegheny county prison', by requiring all contracts
- 7 involving an expenditure exceeding one hundred dollars to be in
- 8 writing and filed with the county controller, and prohibiting
- 9 the making of any contract involving the expenditure of over
- 10 five hundred dollars unless made with the lowest and best bidder
- 11 after due advertising, and requiring all purchases to be made
- 12 through the purchasing department of the county, and providing
- 13 for the opening of bids and the award of contracts."

- 24 (b) General repeal.--All acts or parts of acts inconsistent
- 25 herewith are hereby repealed to the extent of the inconsistency.
- 26 Section 10. Effective date.
- 27 This act shall take effect in six months.
