1 2 3	Amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, further providing for costs in civil and criminal cases.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. Subsections (a) and (b) of section 1725.1 of
7	Title 42, act of November 25, 1970 (P.L.707, No.230), known as
8	the Pennsylvania Consolidated Statutes, added July 20, 1979
9	(No.52), are amended to read:

L1	(a) Civil cases The costs to be charged by the minor
L2	judiciary in every civil case, except as otherwise provided in
L3	this section, shall be as follows:
L 4	(1) Assumpsit or trespass involving \$100 or
L5	less \$10.00
L6	(2) Assumpsit or trespass involving more than
L7	\$100 but not more than \$300 \$15.00
L8	(3) Assumpsit or trespass involving more than

1	\$300 but not more than \$500 \$20.00
2	(4) Assumpsit or trespass involving more
3	than \$500\$25.00
4	(5) Landlord and tenant proceeding\$25.00
5	(6) Order of execution\$15.00

7	(8) Reinstatement of complaint No Charge
8	Such costs shall include all charges [including, when called
9	for, the costs relating to postage and registered mail,] except
10	the costs of a district justice's transcript of every proceeding
11	on appeal or certiorari (including affidavit, bail and
12	certificate) which shall be \$2.50 per transcript. Said costs
13	shall not include, however, the cost of postage and registered
14	mail which shall be borne by the plaintiff.
15	(b) Criminal cases The costs to be charged by the minor
16	judiciary or by the court of common pleas where appropriate in
17	every criminal case, except as otherwise provided in this
18	section, shall be as follows:
19	(1) Summary conviction, except motor vehicle
20	cases \$16.00
21	(2) Summary conviction, motor vehicles cases,
22	other than paragraph (3) \$10.00
23	(3) Summary conviction, motor vehicle cases,
24	hearing demanded\$15.00
25	(4) Misdemeanor\$20.00
26	(5) Felony\$25.00
27	Such costs shall include all charges including [the costs of
28	postage and registered mail and] the costs of giving a district
29	justice's transcript to the prosecutor or defendant, or both, if
30	requested. Such costs shall not include, however, the cost of
