## AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, authorizing the issuance of firefighter
- 3 registration plates.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Subsections (a) and (b) of section 1334 of Title
- 7 75, act of November 25, 1970 (P.L.707, No.230), known as the
- 8 Pennsylvania Consolidated Statutes are amended to read:
- 9 § 1334. Return of registration plate.
- 10 (a) General rule.--Registration plates shall be returned to
- 11 the department under the following circumstances:
- 12 (1) A registration plate shall be returned if the
- 13 registrant no longer has a vehicle titled in this
- 14 Commonwealth.

- 1 (2) A legislative registration plate shall be returned
- 2 on the expiration or termination of the term of office of the
- 3 legislative member.
- 4 (3) A dealer or "Miscellaneous Motor Vehicle Business"
- 5 registration plate shall be returned if the business is
- 6 discontinued.
- 7 (4) A handicapped registration plate shall be returned
- 8 if the person to whom it was issued no longer qualifies under
- 9 section 1338 (relating to handicapped plate).
- 10 (5) A firefighter registration plate shall be returned
- if the person to whom it was issued no longer is an employee
- or member of a fire department or fire company.
- 13 (b) Time for return of plate.--
- 14 <u>(1)</u> Each registration plate required to be returned
- under [this section] subsection (a)(1), (2), (3) or (4) shall
- 16 be returned to the department within five days of the
- occurrence requiring its return.
- 18 (2) Each registration plate required to be returned
- 19 <u>under subsection (a)(5) shall be returned to the department</u>
- 20 <u>within 15 days of the occurrence requiring its return.</u>

- 22 Section 2. Title 75 is amended by adding sections to read:
- 23 § 1342.1. Firefighter plate.
- 24 (a) Issuance of plate. -- On the application of any person who
- 25 <u>is actively engaged in firefighting activities as an employee of</u>
- 26 <u>a fire department or as a member of a volunteer fire company,</u>
- 27 and upon submission of satisfactory proof of such activities,
- 28 the department shall issue a special registration plate
- 29 indicating that the vehicle is owned by a firefighter. No
- 30 applicant shall be entitled to more than one firefighter plate.

- 1 Each renewal of registration shall be accompanied by a statement
- 2 signed by the applicant, on a form prepared by the department,
- 3 declaring that the applicant continues to qualify for a
- 4 <u>firefighter registration plate</u>.
- 5 (b) Design of plate. -- The design of the firefighter plate
- 6 <u>shall be approved by the department and shall bear a maltese</u>
- 7 cross and the letters "F.D."
- 8 (c) Penalties. -- Any person violating this section is guilty
- 9 of a summary offense and upon conviction shall be sentenced to
- 10 pay a fine of not less than \$50 nor more than \$100 and, in
- 11 addition, shall be thereafter ineligible for future receipt of a
- 12 <u>firefighter registration plate.</u>
- 13 § 1930.1. Firefighter registration plates.
- 14 The fee for issuance of a firefighter registration plate
- 15 <u>shall be \$20 which shall be in addition to the annual</u>
- 16 registration fee. Only one payment of the issuance fee shall be
- 17 <u>charged for each firefighter registration issued or replaced.</u>
- 18 Section 3. This act shall take effect in 60 days.
