## AN ACT

- Amending the act of July 4, 1979 (No.9A), entitled "An act to 2 provide for the expenses of the Executive, Legislative and 3 Judicial Departments of the Commonwealth, the public debt and for the public schools for the fiscal period July 1, 1979 to June 30, 1980, and for the payment of bills incurred and 5 remaining unpaid at the close of the fiscal period ending 7 June 30, 1979, adding language in appropriations to the Departments of Health and Justice. 8 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: Section 2, act of July 4, 1979 (No.9A), known as 11 the "General Appropriations Act of 1979," is amended by adding 12 13 language in the appropriations to the Departments of Health and 14 Justice to read: 15 Section 2. The following sums, or as much thereof as may be 16 necessary, are hereby specifically appropriated from the General

- 7 beginning July 1, 1979 and for the payment of bills incurred and
- 8 remaining unpaid at the close of the fiscal period ending June
