AN ACT

- 1 Amending the act of June 12, 1919 (P.L.476, No.240), entitled,
- as amended, "An act to regulate and establish the fees to be
- 3 charged and collected by the recorder of deeds, in counties
- 4 of the second class, " changing certain fees.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 1, act of June 12, 1919 (P.L.476,
- 8 No.240), entitled, as amended, "An act to regulate and establish
- 9 the fees to be charged and collected by the recorder of deeds,
- 10 in counties of the second class, "amended May 5, 1970 (P.L.332,
- 11 No.107) and November 5, 1971 (P.L.522, No.128), is amended to
- 12 read:
- 13 Section 1. Be it enacted, &c., That the fees to be charged
- 14 and collected by the recorder of deeds, in counties of the
- 15 second class, shall be as follows:
- 16 For recording deeds, the minimum fee for not more than [one
- 17 description or more than] four legal [cap typewritten] pages
- 18 shall be [six dollars and twenty-five cents (\$6.25)] ten dollars

- 1 (\$10.00); and for each additional [description, one dollar
- 2 (\$1.00)] page or fraction thereof, two dollars (\$2.00) extra.
- For recording sheriff's deeds, the minimum fee for not more
- 4 than [one description or more than] four legal [cap typewritten]
- 5 pages shall be [six dollars and fifty cents (\$6.50)] ten dollars
- 6 (\$10.00); and for each additional [description one dollar
- 7 (\$1.00)] page or fraction thereof, two dollars (\$2.00) extra.
- 8 For recording schedule of distribution, the minimum fee for
- 9 not more than [one description or more than] four legal [cap
- 10 typewritten] pages shall be [six dollars and fifty cents
- 11 (\$6.50)] ten dollars (\$10.00) and for each additional
- 12 [description one dollar (\$1.00)] page or fraction thereof, two
- 13 <u>dollars (\$2.00)</u> extra.
- 14 For recording declaration of taking, the minimum fee for not
- 15 more than [one description or more than] four legal [cap
- 16 typewritten] pages, plans or maps, shall be [six dollars and
- 17 fifty cents (\$6.50)] ten dollars (\$10.00), for indexing each
- 18 name [fifty cents (50ç)] one dollar (\$1.00), and for each page,
- 19 plan or map [one dollar and fifty cents (\$1.50)] two dollars
- 20 (\$2.00) extra per legal [cap] page of plans or maps or fraction
- 21 thereof.
- 22 For indexing deeds, mortgages, and all other writings, with
- 23 more than four names, [fifty cents (50¢)] the minimum fee shall
- 24 be one dollar (\$1.00) extra for each additional name.
- 25 For recording agreements, leases, oil and gas leases, rights
- 26 of way, municipal ordinance vacating streets, lanes, or alleys,
- 27 or parts thereof, of not more than four legal [cap typewritten]
- 28 pages, the minimum fee shall be [six dollars and twenty-five
- 29 cents (\$6.25)] ten dollars (\$10.00), and [one dollar and fifty
- 30 cents (\$1.50)] two dollars (\$2.00) for each additional legal

- 1 [cap typewritten] page or fractional part thereof.
- 2 For recording assignments of agreements, leases, oil and gas
- 3 leases, rights of way, or other instrument of writing, by
- 4 separate paper, except such as are herein specially provided,
- 5 of not more than two legal [cap typewritten] pages, the minimum
- 6 fee shall be [four dollars and fifty cents (\$4.50)] eight
- 7 dollars (\$8.00); and [one dollar and fifty cents (\$1.50)] two
- 8 <u>dollars (\$2.00)</u> for each additional page or fractional part
- 9 thereof.
- 10 For recording adjudication in bankruptcy, [four dollars and
- 11 fifty cents (\$4.50)] the minimum fee shall be ten dollars
- 12 (\$10.00).
- 13 For recording widow's election, [four dollars and fifty cents
- 14 (\$4.50)] the minimum fee shall be ten dollars (\$10.00).
- 15 For recording widow's appraisement, [five dollars and fifty
- 16 cents (\$5.50)] the minimum fee shall be ten dollars (\$10.00).
- 17 For recording release of legacies, [four dollars and fifty
- 18 cents (\$4.50)] the minimum fee shall be ten dollars (\$10.00).
- 19 For recording military or naval discharge, [one dollar
- 20 (\$1.00). Fee to be paid by the county] no fee.
- 21 For exemplification of military or naval discharge for
- 22 purpose of securing benefits under the "Korean Conflict
- 23 Veteran's Compensation Act," [one dollar (\$1.00). Fee to be paid
- 24 by the county] no fee.
- 25 For recording military or naval certificate of service, [one
- 26 dollar (\$1.00). Fee to be paid by the county.] no fee.
- 27 For exemplification of military or naval certificate of
- 28 service for purpose of securing benefits under the "Korean
- 29 Conflict Veteran's Compensation Act," [one dollar (\$1.00). Fee
- 30 to be paid by the county] no fee.

- 1 For a certified copy of any honorable military or naval
- 2 discharge, a certificate of service, separation form known as DD
- 3 Form 214, or other similar forms, delivered to members of the
- 4 armed services upon their retirement or separation from active
- 5 duty for use in connection with any claim for compensation [one
- 6 dollar (\$1.00) to be paid by the county.] no fee.
- 7 For recording decree of feme sole trader, [four dollars and
- 8 fifty cents (\$4.50)] the minimum fee shall be ten dollars
- 9 (\$10.00).
- 10 For recording declaration of trust of not [more than one
- 11 description of property or] more than four legal [cap
- 12 typewritten] pages, the minimum fee shall be [five dollars and
- 13 fifty cents (\$5.50)] ten dollars (\$10.00); and [one dollar and
- 14 fifty cents (\$1.50)] two dollars (\$2.00) for each additional
- 15 page or fractional part thereof.
- 16 For recording decree or order of court of not more than two
- 17 legal [cap typewritten] pages, [five dollars and fifty cents
- 18 (\$5.50)] the minimum fee shall be ten dollars (\$10.00); and [one
- 19 dollar and fifty cents (\$1.50)] two dollars (\$2.00) for each
- 20 additional page or fractional part thereof.
- 21 For recording mortgages of not more than [one description or
- 22 more than] four legal [cap typewritten] pages; the minimum fee
- 23 shall be [five dollars and fifty cents (\$5.50)] seventeen
- 24 <u>dollars (\$17.00)</u>; and each additional [description, one dollar
- 25 (\$1.00)] page or fraction thereof, two dollars (\$2.00) extra.
- 26 For recording assignment of mortgage when attached to
- 27 mortgage at time of recording, [three dollars (\$3.00)] the
- 28 minimum fee shall be five dollars (\$5.00).
- 29 For recording assignment of mortgage by separate paper of not
- 30 more than one assignment, [four dollars and fifty cents (\$4.50)]

- 1 the minimum fee shall be eight dollars (\$8.00); for noting each
- 2 additional assignment, [one dollar (\$1.00)] two dollars (\$2.00).
- For recording satisfaction, partial payment, postponement, or
- 4 release, by separate paper, [five dollars and fifty cents
- 5 (\$5.50)] the minimum fee shall be eight dollars (\$8.00).
- 6 For entering satisfactions, assignments, partial payments,
- 7 releases, extensions, and postponements, on margin of mortgage
- 8 record, [four dollars (\$4.00)] the minimum fee shall be six
- 9 dollars (\$6.00).
- 10 For entering partial payment, release, extension, and
- 11 assignment, under one marginal entry, [four dollars (\$4.00)] the
- 12 minimum fee shall be six dollars (\$6.00) for first item; and
- 13 [one dollar and fifty cents (\$1.50)] two dollars (\$2.00) for
- 14 each additional item.
- 15 For mortgage searches on not more than one piece of property,
- 16 each name, [four dollars (\$4.00)] the minimum fee shall be ten
- 17 <u>dollars (\$10.00)</u>; and for each unsatisfied mortgage shown, [two
- 18 dollars (\$2.00)] <u>five dollars (\$5.00)</u>.
- 19 For reporting mortgage, lien, assignment or satisfaction
- 20 thereof, to the county commissioners or board of assessors, the
- 21 <u>minimum fee shall be</u> fifty cents (50¢) each, to be paid by the
- 22 county.
- 23 For recording or exemplifying of commission for notary
- 24 public, with bond and oath, [eight dollars (\$8.00)] the minimum
- 25 fee shall be eleven dollars (\$11.00); city or county officer,
- 26 with bond and oath, [eight dollars (\$8.00)] the minimum fee
- 27 shall be fourteen dollars (\$14.00); justice of the peace or
- 28 alderman, with bond and oath, [nine dollars and fifty cents
- 29 (\$9.50)] the minimum fee shall be twelve dollars and fifty cents
- 30 (\$12.50); special police officer, [five dollars and fifty cents

- 1 (\$5.50)] the minimum fee shall be ten dollars (\$10.00).
- 2 For exemplification of special police officer's oath, the
- 3 minimum fee shall be two dollars (\$2.00).
- 4 For furnishing Auditor General with information concerning
- 5 limited partnerships, [fifty cents (50¢)] the minimum fee shall
- 6 be ten dollars (\$10.00).
- 7 For affidavit and acknowledgment of bondsmen for notary
- 8 public, justice of the peace, or alderman, one person, the
- 9 minimum fee shall be one dollar and twenty-five cents (\$1.25);
- 10 two persons, the minimum fee shall be one dollar and seventy-
- 11 five cents (\$1.75).
- 12 For recording powers of attorney of not more than two names
- 13 or more than two legal [cap typewritten] pages, the minimum fee
- 14 shall be [five dollars and fifty cents (\$5.50)] ten dollars
- 15 (\$10.00); and [one dollar and fifty cents (\$1.50)] two dollars
- 16 (\$2.00) for each additional or fractional part thereof.
- 17 [For noting any instrument on margin of record, one dollar
- 18 (\$1.00)] For making marginal notations other than specified
- 19 above the minimum fee shall be two dollars (\$2.00) for each
- 20 <u>item.</u>
- 21 For recording charters or limited partnerships of not more
- 22 than four legal [cap typewritten] pages, the minimum fee shall
- 23 be [six dollars and fifty cents (\$6.50)] ten dollars (\$10.00);
- 24 and [one dollar and fifty cents (\$1.50)] two dollars (\$2.00) for
- 25 each additional page or fractional part thereof.
- 26 For recording bank bonds, [four dollars and fifty cents
- (\$4.50)] the minimum fee shall be ten dollars (\$10.00).
- 28 For recording financing statements and terminations the
- 29 <u>minimum fee shall be five dollars (\$5.00).</u>
- The fee for services not herein specifically provided for

- 1 shall be the same as for similar services.
- 2 Section 2. This act shall take effect in 30 days.
