- 9 § 4701. DUTY TO COMPLY WITH INSPECTION LAWS.
- 10 NO OWNER OR DRIVER SHALL REFUSE TO SUBMIT A VEHICLE <u>OR A MASS</u>
- 11 TRANSIT VEHICLE TO ANY INSPECTION AND TEST THAT IS AUTHORIZED OR
- 12 REQUIRED BY THE PROVISIONS OF THIS CHAPTER.
- 13 § 4702. REQUIREMENT FOR PERIODIC INSPECTION OF VEHICLES.
- 14 (A) GENERAL RULE. -- THE DEPARTMENT SHALL ESTABLISH A SYSTEM
- 15 OF SEMIANNUAL INSPECTION OF VEHICLES REGISTERED IN THIS
- 16 COMMONWEALTH AND MASS TRANSIT VEHICLES OPERATED IN THIS
- 17 COMMONWEALTH. WHEN ANY VEHICLE, SUBJECT TO AN EMISSION CONTROL

- 18 SYSTEM INSPECTION, HAS SAID INSPECTION, IT SHALL CONSTITUTE ONE

- 21 § 4703. Operation of vehicle OR MASS TRANSIT VEHICLE
- 22 without official certificate of inspection.
- 23 (a) General rule.--No [registered] motor vehicle required to
- 24 <u>bear current Pennsylvania registration plates</u> shall be driven
- 25 <code>fandf</code> no <code>[registered]</code> trailer <code>required</code> to <code>bear current</code>
- 26 <u>Pennsylvania registration plates</u> shall be moved on a highway <u>AND</u> <---
- 27 NO MASS TRANSIT VEHICLE SHALL BE OPERATED unless the vehicle
- 28 displays a currently valid certificate of inspection [and
- 29 approval].
- 30 (b) Exceptions.--Subsection (a) does not apply to:

- 1 (1) Special mobile equipment.

- 17 Vehicles subject to inspection which have been outside this

- 20 valid certificate of inspection shall be inspected within five
- 21 days of reentering this Commonwealth.
- 22 (d) Newly-purchased vehicles.--Newly-purchased vehicles may
- 23 be driven without being inspected for five days after purchase
- 24 or entry into this Commonwealth, whichever occurs later.

- 7 (q) Limitation on prosecution. -- A motor vehicle, MASS
- 8 TRANSIT VEHICLE OR TRAILER shall be the subject of only one
- 9 <u>arrest PROSECUTION under subsection (a) in any 24-hour period.</u>
- 10 (h) Penalty. -- Any person violating this section is guilty of
- 11 <u>a summary offense and shall, upon conviction, be sentenced to</u>
- 12 pay a fine of up to \$25.
- 13 § 4704. NOTICE BY POLICE OFFICERS OF VIOLATION.
- 14 (A) GENERAL RULE. -- ANY POLICE OFFICER HAVING PROBABLE CAUSE
- 15 TO BELIEVE THAT ANY VEHICLE OR MASS TRANSIT VEHICLE, REGARDLESS
- 16 OF WHETHER IT IS BEING OPERATED, IS UNSAFE OR NOT EQUIPPED AS
- 17 REQUIRED BY LAW MAY AT ANY TIME SUBMIT A WRITTEN NOTICE OF THE
- 18 CONDITION TO THE DRIVER OF THE VEHICLE OR THE MASS TRANSIT
- 19 <u>VEHICLE</u> OR TO THE OWNER, OR IF NEITHER IS PRESENT, TO AN ADULT
- 20 OCCUPANT OF THE VEHICLE OR THE MASS TRANSIT VEHICLE, OR IF THE
- 21 VEHICLE OR THE MASS TRANSIT VEHICLE IS UNOCCUPIED, THE NOTICE
- 22 SHALL BE ATTACHED TO THE VEHICLE OR THE MASS TRANSIT VEHICLE IN
- 23 A CONSPICUOUS PLACE.
- 24 (1) IF AN ITEM OF EQUIPMENT IS BROKEN OR MISSING, THE
- 25 NOTICE SHALL SPECIFY THE PARTICULARS OF THE CONDITION AND
- 26 REQUIRE THAT THE EQUIPMENT BE ADJUSTED OR REPAIRED. WITHIN
- 27 FIVE DAYS EVIDENCE MUST BE SUBMITTED TO THE POLICE THAT THE
- 28 REQUIREMENTS FOR REPAIR HAVE BEEN SATISFIED.
- 29 (2) IF THE POLICE OFFICER HAS PROBABLE CAUSE TO BELIEVE
- 30 THAT A VEHICLE OR MASS TRANSIT VEHICLE IS UNSAFE OR NOT IN

- 1 PROPER REPAIR, HE MAY REQUIRE IN THE WRITTEN NOTICE THAT THE
- 2 CAR OR MASS TRANSIT VEHICLE BE INSPECTED. THE OWNER OR DRIVER
- 3 SHALL SUBMIT TO THE POLICE WITHIN FIVE DAYS OF THE DATE OF
- 4 NOTIFICATION CERTIFICATION FROM AN OFFICIAL INSPECTION
- 5 STATION THAT THE VEHICLE OR THE MASS TRANSIT VEHICLE HAS BEEN
- 6 RESTORED TO SAFE OPERATING CONDITION IN RELATION TO THE
- 7 PARTICULARS SPECIFIED ON THE NOTICE.
- 8 (3) AFTER THE EXPIRATION OF THE FIVE-DAY PERIOD
- 9 SPECIFIED IN PARAGRAPHS (1) AND (2), THE VEHICLE SHALL NOT BE
- 10 OPERATED UPON THE HIGHWAYS OF THIS COMMONWEALTH AND A MASS
- 11 TRANSIT VEHICLE SHALL NOT BE OPERATED UNTIL THE OWNER OR
- 12 DRIVER HAS SUBMITTED TO THE POLICE EVIDENCE OF COMPLIANCE
- 13 WITH THE REQUIREMENTS OF PARAGRAPH (1) OR (2), WHICHEVER IS
- 14 APPLICABLE.
- 15 (B) OPERATION PROHIBITED IF HAZARDOUS. -- IN THE EVENT A
- 16 VEHICLE OR A MASS TRANSIT VEHICLE, IN THE REASONABLE JUDGMENT OF
- 17 THE OFFICER, IS IN SUCH CONDITION THAT FURTHER OPERATION WOULD
- 18 BE HAZARDOUS, THE OFFICER MAY REQUIRE THAT THE VEHICLE OR THE
- 19 MASS TRANSIT VEHICLE NOT BE OPERATED UNDER ITS OWN POWER AND MAY
- 20 SO STIPULATE IN THE NOTICE GIVEN UNDER SUBSECTION (A).
- 21 § 4721. APPOINTMENT OF OFFICIAL INSPECTION STATIONS.
- 22 FOR THE PURPOSE OF ESTABLISHING A SYSTEM OF OFFICIAL
- 23 INSPECTION STATIONS, THE DEPARTMENT SHALL ISSUE CERTIFICATES OF
- 24 APPOINTMENT TO PRIVATELY OWNED FACILITIES WITHIN THIS
- 25 COMMONWEALTH THAT COMPLY WITH THE REQUIREMENTS OF THIS CHAPTER
- 26 AND REGULATIONS ADOPTED BY THE DEPARTMENT. THE DEPARTMENT SHALL
- 27 ISSUE INSTRUCTIONS AND ALL NECESSARY FORMS TO SUCH FACILITIES.
- 28 OFFICIAL INSPECTION STATIONS ARE AUTHORIZED TO INSPECT VEHICLES
- 29 AND MASS TRANSIT VEHICLES AND ISSUE OFFICIAL CERTIFICATES OF
- 30 INSPECTION.

- 1 § 4723. CERTIFICATE OF APPOINTMENT FOR INSPECTING FLEET
- 2 VEHICLES <u>AND FLEET MASS TRANSIT VEHICLES</u>.
- 3 THE DEPARTMENT MAY ISSUE A CERTIFICATE OF APPOINTMENT UNDER
- 4 THE PROVISIONS OF THIS CHAPTER TO ANY PERSON WHO OWNS OR LEASES
- 5 15 OR MORE VEHICLES OR MASS TRANSIT VEHICLES AND WHO MEETS THE
- 6 REQUIREMENTS OF THIS CHAPTER AND REGULATIONS ADOPTED BY THE
- 7 DEPARTMENT. THE CERTIFICATE OF APPOINTMENT MAY AUTHORIZE
- 8 INSPECTION OF ONLY THOSE VEHICLES OR MASS TRANSIT VEHICLES OWNED
- 9 OR LEASED BY SUCH PERSON.
- 10 § 4726. CERTIFICATION OF MECHANICS.
- 11 NO MECHANIC SHALL CONDUCT MOTOR VEHICLE INSPECTIONS OR MASS
- 12 TRANSIT VEHICLE INSPECTIONS AT AN OFFICIAL INSPECTION STATION
- 13 UNLESS CERTIFIED AS TO TRAINING, QUALIFICATIONS AND COMPETENCE
- 14 BY THE DEPARTMENT ACCORDING TO DEPARTMENT REGULATIONS. THE
- 15 REGULATIONS RELATING TO MASS TRANSIT VEHICLE INSPECTIONS SHALL
- 16 REQUIRE THAT ANY MECHANIC CONDUCTING SUCH INSPECTIONS SHALL
- 17 POSSESS PROVEN COMPETENCE IN THE AREA OF MASS TRANSIT VEHICLE
- 18 OPERATION AND MAINTENANCE. THE PROVISIONS OF THIS TITLE OR
- 19 REGULATIONS ADOPTED THEREUNDER SHALL NOT BE CONSTRUED OR APPLIED
- 20 IN A MANNER WHICH WOULD PRECLUDE OR IMPAIR THE RIGHT OF A PERSON
- 21 WHO IS A RESIDENT OF ANOTHER STATE, AND WHO IS IN POSSESSION OF
- 22 A VALID DRIVER'S LICENSE ISSUED BY SUCH STATE, TO BE CERTIFIED
- 23 TO CONDUCT MOTOR VEHICLE INSPECTIONS OR MASS TRANSIT VEHICLE
- 24 <u>INSPECTIONS</u> AT AN OFFICIAL INSPECTION STATION IN THIS
- 25 COMMONWEALTH. NO OFFICIAL INSPECTION STATION APPOINTMENT SHALL
- 26 BE ISSUED OR RENEWED UNLESS A CERTIFIED OFFICIAL INSPECTION
- 27 MECHANIC IS THERE EMPLOYED.
- 28 § 4727. ISSUANCE OF CERTIFICATE OF INSPECTION.
- 29 (A) REQUIREMENTS PRIOR TO INSPECTION. -- NO VEHICLE, EXCEPT A
- 30 MASS TRANSIT VEHICLE FOR WHICH REGISTRATION IS NOT REQUIRED,

- 1 SHALL BE INSPECTED UNLESS IT IS DULY REGISTERED. THE OWNER OR
- 2 OPERATOR OR AN EMPLOYEE OF THE OFFICIAL INSPECTION STATION SHALL
- 3 EXAMINE THE REGISTRATION CARD IN ORDER TO ASCERTAIN THAT THE
- 4 VEHICLE IS REGISTERED.
- 5 (B) REQUIREMENTS FOR ISSUANCE OF CERTIFICATE. -- AN OFFICIAL
- 6 CERTIFICATE OF INSPECTION SHALL NOT BE ISSUED UNLESS THE VEHICLE
- 7 OR MASS TRANSIT VEHICLE IS INSPECTED AND FOUND TO BE IN
- 8 COMPLIANCE WITH THE PROVISIONS OF THIS CHAPTER INCLUDING ANY
- 9 REGULATIONS PROMULGATED BY THE DEPARTMENT. NOTATION OF THE
- 10 ODOMETER READING SHALL BE INCLUDED ON THE CERTIFICATE OF
- 11 INSPECTION.
- 12 § 4728. DISPLAY OF CERTIFICATE OF INSPECTION.
- 13 THE APPROPRIATE CERTIFICATE OF INSPECTION SHALL BE AFFIXED TO
- 14 THE VEHICLE OR MASS TRANSIT VEHICLE AS SPECIFIED IN REGULATIONS
- 15 ADOPTED BY THE DEPARTMENT.
- 16 § 4729. REMOVAL OF CERTIFICATE OF INSPECTION.
- 17 NO CERTIFICATE OF INSPECTION SHALL BE REMOVED FROM A VEHICLE
- 18 OR A MASS TRANSIT VEHICLE FOR WHICH THE CERTIFICATE WAS ISSUED
- 19 EXCEPT TO REPLACE IT WITH A NEW CERTIFICATE OF INSPECTION ISSUED
- 20 IN ACCORDANCE WITH THE PROVISIONS OF THIS CHAPTER OR AS FOLLOWS:
- 21 (1) THE POLICE OFFICER MAY REMOVE A CERTIFICATE OF
- 22 INSPECTION IN ACCORDANCE WITH THE PROVISIONS OF SECTION
- 23 4703[(D)] <u>(F)</u> (RELATING TO OPERATION OF VEHICLE <u>OR MASS</u>
- 24 TRANSIT VEHICLE WITHOUT OFFICIAL CERTIFICATE OF INSPECTION).

- 25 (2) A PERSON REPLACING A WINDSHIELD OR REPAIRING A
- 26 WINDSHIELD IN SUCH A MANNER AS TO REQUIRE REMOVAL OF A
- 27 CERTIFICATE OF INSPECTION SHALL AT THE OPTION OF THE
- 28 REGISTRANT OF THE VEHICLE OR THE OWNER OF A MASS TRANSIT
- 29 <u>VEHICLE</u> CUT OUT THE PORTION OF THE WINDSHIELD CONTAINING THE
- 30 CERTIFICATE AND DELIVER IT TO THE REGISTRANT OF THE VEHICLE

- 1 OR THE OWNER OF THE MASS TRANSIT VEHICLE OR DESTROY THE
- 2 CERTIFICATE. THE VEHICLE OR THE MASS TRANSIT VEHICLE MAY BE
- 3 DRIVEN FOR UP TO FIVE DAYS IF IT DISPLAYS THE PORTION OF THE
- 4 OLD WINDSHIELD CONTAINING THE CERTIFICATE AS PRESCRIBED IN
- 5 DEPARTMENT REGULATIONS. WITHIN THE FIVE DAY PERIOD AN
- 6 OFFICIAL INSPECTION STATION MAY AFFIX TO THE VEHICLE OR MASS
- 7 TRANSIT VEHICLE ANOTHER CERTIFICATE OF INSPECTION FOR THE
- 8 SAME INSPECTION PERIOD WITHOUT REINSPECTING THE VEHICLE OR
- 9 <u>MASS TRANSIT VEHICLE</u> IN EXCHANGE FOR THE PORTION OF THE OLD
- 10 WINDSHIELD CONTAINING THE CERTIFICATE OF INSPECTION. A FEE OF
- 11 NO MORE THAN \$1 MAY BE CHARGED FOR THE EXCHANGED CERTIFICATE
- 12 OF INSPECTION.
- 13 (3) A SALVOR SHALL REMOVE AND DESTROY THE CERTIFICATE OF
- 14 INSPECTION ON EVERY VEHICLE OR MASS TRANSIT VEHICLE IN HIS
- 15 POSSESSION EXCEPT VEHICLES USED IN THE OPERATION OF THE
- 16 BUSINESS OF THE SALVOR.
- 17 § 4730. VIOLATIONS OF USE OF CERTIFICATE OF INSPECTION.
- 18 (A) GENERAL RULE. -- NO PERSON SHALL:
- 19 (1) MAKE, ISSUE, TRANSFER OR POSSESS ANY IMITATION OR
- 20 COUNTERFEIT OF AN OFFICIAL CERTIFICATE OF INSPECTION; OR
- 21 (2) DISPLAY OR CAUSE TO BE DISPLAYED ON ANY VEHICLE OR
- 22 MASS TRANSIT VEHICLE OR HAVE IN POSSESSION ANY CERTIFICATE OF
- 23 INSPECTION KNOWING THE SAME TO BE FICTITIOUS OR STOLEN OR
- 24 ISSUED FOR ANOTHER VEHICLE OR ISSUED WITHOUT AN INSPECTION
- 25 HAVING BEEN MADE.
- 26 \* \* \*
- 27 § 6103. PROMULGATION OF RULES AND REGULATIONS BY DEPARTMENT.
- 28 (A) IN GENERAL GENERAL RULE. -- IN ADDITION TO THE SPECIFIC
- 29 POWERS GRANTED TO THE DEPARTMENT BY THIS TITLE TO PROMULGATE
- 30 RULES AND REGULATIONS, THE DEPARTMENT SHALL HAVE THE POWER IN

- 1 ACCORDANCE WITH THE PROVISIONS OF THE ACT OF JULY 31, 1968
- 2 (P.L.769, NO.240), [KNOWN AS THE "COMMONWEALTH DOCUMENTS LAW,"]
- 3 REFERRED TO AS THE COMMONWEALTH DOCUMENTS LAW, TO PROMULGATE,
- 4 CONSISTENT WITH AND IN FURTHERANCE OF THIS TITLE, RULES AND
- 5 REGULATIONS IN ACCORDANCE WITH WHICH THE DEPARTMENT SHALL CARRY
- 6 OUT ITS RESPONSIBILITIES AND DUTIES UNDER THIS TITLE.
- 7 (B) LEGISLATIVE ACTION; APPROVAL OF MASS TRANSIT INSPECTION <-

- 8 REGULATIONS.--A COPY OF EVERY RULE OR REGULATION OR AMENDMENT TO
- 9 A RULE OR REGULATION RELATING TO CHAPTER 47 (RELATING TO
- 10 <del>INSPECTION OF VEHICLES)</del> THE INSPECTION OF MASS TRANSIT VEHICLES
- 11 SHALL BEFORE ADOPTION BE FORWARDED TO THE SPEAKER OF THE HOUSE
- 12 OF REPRESENTATIVES AND TO THE PRESIDENT PRO TEMPORE OF THE
- 13 <u>SENATE FOR REFERRAL TO AND REVIEW BY THE APPROPRIATE STANDING</u>
- 14 COMMITTEE OF THE HOUSE OF REPRESENTATIVES AND OF THE SENATE AS
- 15 DETERMINED BY THE RESPECTIVE PRESIDING OFFICER. THE STANDING

- 29 <u>IN WRITING, THE OTHER COMMITTEE AND THE DEPARTMENT OF ANY ACTION</u>
- 30 TAKEN PURSUANT TO THIS SUBSECTION. ONLY IN THE ABSENCE OF A

- 1 DISAPPROVAL SHALL THE AGENCY SHALL DEPARTMENT PROCEED WITH THE
- 2 ADOPTION OF THE RULE, REGULATION OR AMENDMENT IN ACCORDANCE WITH
- 3 SECTION 202 OF THE COMMONWEALTH DOCUMENTS LAW.
- 4 SECTION 3. (A) THE PENNSYLVANIA STATE POLICE AND THE
- 5 DEPARTMENT OF TRANSPORTATION IN CONSULTATION WITH MASS TRANSIT
- OPERATORS SHALL SUBMIT THE REGULATIONS REQUIRED BY THIS ACT TO 6
