AN ACT

1 2 3 4 5 6 7 8 9	To provide for the safety and comfort of passengers on public conveyances; to provide for the security of public passenger terminals; to prohibit disorderly conduct board public conveyances; to authorize the removal of disorderly or intoxicated passengers from public conveyances or terminals; to prohibit the possession of explosives or deadly weapons on public conveyances or in public terminals; to authorize enforcement provisions of this act by personnel operating public conveyances; and to provide penalties for violations of this act.
11	WHEREAS, The General Assembly finds that the continued
12	orderly operation of public passenger conveyances of all types
13	is beneficial to the commerce of the Commonwealth of
14	Pennsylvania and to the convenience of the citizens; and
15	WHEREAS, It is essential to the comfort, safety and well-
16	being of passengers by public conveyance that orderly conduct be
17	maintained; and
18	WHEREAS, The promotion of public passenger transportation is
19	beneficial to the economy of the State and conservation of
20	energy; and
21	WHEREAS, An increasing number of citizens avail themselves of
22	this economical and safe mode of transportation; therefore be it

- 1 The General Assembly of the Commonwealth of Pennsylvania
- 2 hereby enacts as follows:
- 3 Section 1. This act shall be known and may be cited as the
- 4 "Public Conveyance Passenger Safety Act."
- 5 Section 2. The following words and phrases when used in this
- 6 act shall have, unless the context clearly indicates otherwise,
- 7 the meanings given to them in this section:
- 8 "Charter." A group of persons, pursuant to a common purpose
- 9 and under a single contract, and at a fixed charge for the
- 10 conveyance in accordance with a transportation company's tariff,
- 11 who have acquired the exclusive use of a conveyance to travel
- 12 together as a group to a specified destination.
- 13 "Passenger." Any person served by the transportation company
- 14 and in addition to the ordinary meaning of passenger, the term
- 15 shall include persons accompanying or meeting another who is
- 16 transported by this company, and any person purchasing a ticket
- 17 or receiving a pass.
- 18 "Public conveyance." Any passenger bus or coach or other
- 19 motor vehicle having a seating capacity of not less than 15
- 20 passengers operated by a transportation company for the purpose
- 21 of carrying passengers for hire or any vehicle operating on
- 22 rails for that purpose.
- 23 "Terminal." A station or depot or any facility operated by
- 24 or leased by or operated on behalf of a transportation company.
- 25 This term shall include a reasonable area immediately adjacent
- 26 to any designated stop along the route traveled by any
- 27 conveyance operated by a transportation company and parking lots
- 28 or parking areas adjacent to a terminal.
- 29 "Transportation company," "company" or "public transportation
- 30 company." Any person, groups of persons or corporation,

- 1 including transportation facilities owned or operated by local
- 2 public bodies, by municipalities and public corporations,
- 3 boards, commissions and authorities established under the laws
- 4 of the Commonwealth providing for-hire interstate or intrastate
- 5 transportation to passengers by public conveyance in the
- 6 Commonwealth of Pennsylvania.
- 7 Section 3. (a) A person is guilty of a felony of the second
- 8 degree if he by force or violence or threat of force or violence
- 9 seizes or exercises control over any public conveyance.
- 10 (b) A person is guilty of a felony of the third degree if he
- 11 by intimidation, threat, assault or battery interferes with the
- 12 performance of the duties of any operator, attendant or guard of
- 13 a public conveyance.
- 14 (c) A person is guilty of a felony of the third degree if he
- 15 boards a public conveyance with a deadly weapon which he is not
- 16 legally authorized to carry. A deadly weapon shall be for the
- 17 purpose of this subsection any firearm, whether loaded or
- 18 unloaded, or any device designed as a weapon and capable of
- 19 producing death or serious bodily injury, or any other device or
- 20 instrumentality which, in the manner in which it is used or
- 21 intended to be used, is calculated or likely to produce death or
- 22 serious bodily injury.
- 23 (d) A person is guilty of a felony of the third degree if he
- 24 bombs or places or plants any bomb or other explosive device or
- 25 matter in, upon or near any public conveyance or terminal.
- 26 (e) A person is guilty of a felony of the third degree if he
- 27 threatens to bomb or place or plant any bomb or other explosive
- 28 device or matter in, upon or near any public conveyance or
- 29 terminal.
- 30 (f) A person is guilty of a misdemeanor of the first degree

- 1 if he discharges any firearm or hurls any missile at, or into,
- 2 any public conveyance, terminal or transportation facility.
- 3 (g) A person is guilty of a summary offense if he threatens
- 4 a breach of the peace or uses any obscene, profane or vulgar
- 5 language on a public conveyance.
- 6 (h) A person is guilty of a summary offense if he causes a
- 7 disturbance while on a public conveyance while under the
- 8 influence of alcohol or unlawfully under the influence of a
- 9 controlled substance is a passenger in or upon any public
- 10 conveyance unless it be chartered.
- 11 (i) A person is guilty of a summary offense if he while on a
- 12 public conveyance ingests any controlled substance unless
- 13 properly prescribed by a physician or medical facility, or
- 14 drinks intoxicating liquor of any kind in or upon any public
- 15 conveyance unless it be chartered or unless the transportation
- 16 company provides bar service on the conveyance.
- 17 (j) A person is guilty of a summary offense if he smokes
- 18 tobacco or other product in a public conveyance after having
- 19 been asked by the operator or other person in attendance thereon
- 20 to refrain.
- 21 Section 4. Any person violating section 3(g) through (j) may
- 22 be removed from the public conveyance by the operator or other
- 23 attendant thereon using only such force as may be necessary at
- 24 any reasonably safe location and may cause such person to be
- 25 detained and delivered to the proper authorities.
- 26 Section 5. In order to provide the safety, comfort and well-
- 27 being of passengers and others having a bona fide business
- 28 interest in any terminal, a public transportation company may
- 29 refuse admission to terminals to any person not having bona fide
- 30 business within the terminal. Any such refusal shall not be

- 1 inconsistent or contrary to State or Federal laws, regulations
- 2 pursuant thereto, or to any ordinance of the political
- 3 subdivision in which such terminal is located. A duly authorized
- 4 company representative may ask any person in a terminal or on
- 5 the premises of a terminal to identify himself and state his
- 6 business. Failure to comply with such request or failure to
- 7 state an acceptable business purpose shall be grounds for such
- 8 company representative to request that such person depart the
- 9 terminal. Refusal to comply with such request shall constitute a
- 10 misdemeanor.
- 11 Section 6. A person is guilty of a misdemeanor of the first
- 12 degree if he carries or attempts to carry any deadly weapon as
- 13 defined in section 3(c) or explosive device into a terminal or
- 14 onto a public conveyance. A transportation company may employ
- 15 reasonable means including mechanical, electronic or x-ray
- 16 devices to detect deadly weapons or explosive devices in the
- 17 baggage or upon the person of the passenger. Upon discovery of
- 18 any such item, the company may obtain possession and retain
- 19 possession of such item until transfer to the custody of law
- 20 enforcement officers.
- 21 Section 7. This act shall take effect in 60 days.
