AN ACT

Amending the act of May 20, 1937 (P.L.728, No.193), entitled, as 2 amended, "An act providing for the creation of a Board of 3 Claims arising from contracts with the Commonwealth; providing for and regulating the procedure in prosecuting 5 claims before such board; defining the powers of the board; and fixing the compensation of members and employes thereof; 7 providing that the awards of such board shall be final; providing for the payment of awards; and authorizing an 8 9 appropriation, "extending the time period for appointing 10 hearing panels. 11 The General Assembly of the Commonwealth of Pennsylvania 12 hereby enacts as follows: 13 Section 1, act of May 20, 1937 (P.L.728, No.193), entitled, as amended, "An act providing for the creation of a 15 Board of Claims arising from contracts with the Commonwealth; providing for and regulating the procedure in prosecuting claims 16 17 before such board; defining the powers of the board; and fixing the compensation of members and employes thereof; providing that 18 the awards of such board shall be final; providing for the 19 payment of awards; and authorizing an appropriation, " amended 20

October 5, 1978 (P.L.1104, No.260), is amended to read:

- 1 Section 1. Be it enacted, &c., That there is hereby created
- 2 [a] an independent administrative board known as the Board of
- 3 Claims, the duty of which shall be to arbitrate claims against
- 4 the Commonwealth arising from contracts entered into by the
- 5 Commonwealth, and to adjust and settle certain other claims
- 6 against the Commonwealth formerly handled by the Auditor General
- 7 and State Treasurer acting as the Board of Claims. Any reference
- 8 in this or any other act to this board shall be deemed a
- 9 reference to the Board of Claims. Administrative services for
- 10 the Board of Claims shall be provided by the Department of the
- 11 Auditor General. Such board shall consist of three members
- 12 appointed by the Governor by and with the advice and consent of
- 13 a majority of the elected members of the Senate, one of whom
- 14 shall be learned in the law and shall be chairman of the board,
- 15 another of whom shall be a registered civil engineer. The third
- 16 member of the board shall be a citizen and resident of the
- 17 Commonwealth. The lawyer member shall hold the title of chief
- 18 administrative judge, one member shall have the title of
- 19 engineer member and one member shall have the title of citizen
- 20 member. Two members of the board shall constitute a quorum. The
- 21 members shall be appointed for terms of four, six and eight
- 22 years, and shall serve until their respective successors shall
- 23 be duly appointed and qualified. Their successors shall each be
- 24 appointed for a term of eight years. In the event any member
- 25 shall die or resign during his term of office the Governor shall
- 26 appoint a successor who shall hold office for such unexpired
- 27 term. Each member of the board shall receive an annual
- 28 compensation as may be fixed by the Executive Board and each
- 29 member of the board and the executive secretary of the board
- 30 shall also be entitled to all necessary traveling and other

- 1 expenses incurred by him in the discharge of his official
- 2 duties. Each member of the board shall be required to devote
- 3 full-time to the duties imposed by this act and shall perform no
- 4 duties inconsistent with their duties and responsibilities as
- 5 board members.
- 6 The Board of Claims may, in its discretion appoint three
- 7 hearing panels consisting of two individuals each, one of whom
- 8 shall be a registered engineer and the other of whom shall be
- 9 learned in the law and shall be the chairman. These individuals
- 10 shall receive actual traveling expenses and per diem
- 11 compensation at the rate of one hundred fifty dollars (\$150) per
- 12 day for the time actually devoted to the business of the board,
- 13 but no panel member shall be paid more than ten thousand dollars
- 14 (\$10,000) per diem compensation in any calendar year. The
- 15 hearing panels shall be denominated the Eastern, Middle and
- 16 Western District Hearing Panel, respectively, and shall have
- 17 jurisdiction in areas of the Commonwealth coterminous with the
- 18 three judicial districts of the United States District Courts in
- 19 the Commonwealth established by section 118 of the Judicial Code
- 20 and Judiciary, act of June 25, 1948, as amended June 2, 1970
- 21 (Public Law 91-272), 28 U.S.C. section 118.
- The power of the Board of Claims to establish hearing panels
- 23 pursuant to this section shall cease on December 31, [1980] 1982
- 24 and the functions and duties of the hearing panels shall
- 25 likewise cease, unless the General Assembly shall, pursuant to
- 26 any sunset law enacted by it, approve an extension of the
- 27 board's power to appoint hearing panels.
- 28 Section 2. This act shall take effect immediately.
