AN ACT

Amending the act of June 18, 1980 (No.17A), entitled "An act to 2 provide for the expenses of the Executive, Legislative and 3 Judicial Departments of the Commonwealth, the public debt and 4 for the public schools for the fiscal period July 1, 1980 to June 30, 1981 and for the payment of bills incurred and 5 remaining unpaid at the close of the fiscal period ending 7 June 30, 1980; to provide supplemental appropriations from 8 the General Fund to the various departments of the 9 Commonwealth for the fiscal period July 1, 1979 to June 30, 10 1980," increasing the appropriation for the Scotland School 11 for Veterans' Children. 12 The General Assembly of the Commonwealth of Pennsylvania 13 hereby enacts as follows: 14 Section 1. As much of the appropriation to the Department of 15 Education as applies to the Scotland School for Veterans' Children in section 201, act of June 18, 1980 (No.17A), known as 16 the "General Appropriation Act of 1980," is amended to read: 17 18 Section 201. The following sums, or as much thereof as may be necessary, are hereby specifically appropriated from the 19 20 General Fund to the several hereinafter named agencies of the 21 Executive, Legislative and Judicial Departments of the

- 2 compensation and travel expense of the duly elected or appointed
- 3 officers and employees of the Commonwealth, for payment of fees
- 4 of contractual services rendered, for the purchase or rental of
- 5 goods, services, printing, equipment, land and buildings and for
- 6 payment of any other expenses, as provided by law or by this
- 7 act, necessary for the proper conduct of the duties, functions
- 8 and activities and for the purposes hereinafter set forth for
- 9 the fiscal period beginning July 1, 1980 and for the payment of
- 10 bills incurred and remaining unpaid at the close of the fiscal
- 11 period ending June 30, 1980.
