In the House of Representatives, March 30, 1981

- 1 WHEREAS, A great majority of Vietnam Veterans have problems
- 2 and needs that have been ignored, including the need for
- 3 programs of medical treatment, therapy and disability benefits,
- 4 as well as vocational and disability rehabilitation; and
- 5 WHEREAS, The American public believes Vietnam Veterans should
- 6 receive the same respect and favorable treatment accorded
- 7 veterans of earlier conflicts; and
- 8 WHEREAS, Some Vietnam Veterans have suffered severe physical
- 9 effects, including cancer, nervous system disorders and skin
- 10 diseases, as a result of their exposure to the defoliant, Agent
- 11 Orange, while serving in the Republic of Vietnam and reports
- 12 have been substantiated that unusually high numbers of
- 13 Vietnamese women and Vietnam veterans' wives have given birth to
- 14 children with birth defects; therefore be it
- 15 RESOLVED (the Senate concurring), That whereas the Federal
- 16 Government, through the Department of Defense, was responsible

- 1 for the spraying of the defoliant, Agent Orange, the Federal
- 2 Government, then, through the Veterans Administration should be
- 3 responsible for the funding and administration of individual
- 4 screening programs in order that those veterans suffering the
- 5 effects of Agent Orange may receive full medical benefits,
- 6 therapy, disability benefits and rehabilitation training; and be
- 7 it further
- 8 RESOLVED, That the General Assembly hereby memorializes the
- 9 Congress of the United States and the Veterans Administration to
- 10 coordinate activities in conjunction with State and local
- 11 veterans assistance centers located in Pennsylvania; and be it
- 12 further
- 13 RESOLVED, That a copy of this resolution be transmitted to
- 14 the President, Speaker of the House of Representatives and
- 15 President pro tempore of the Senate, the appropriate committee
- 16 chairman in the House and Senate of the United States Congress,
- 17 and to each Congressman and Senator from Pennsylvania.
