3 Section 2. Any part of this appropriation which is 4 unexpended, uncommitted or unencumbered as of June 30, 1982 5 shall automatically lapse. 6 Section 3. This act shall take effect July 1, 1981 unless 7 enacted thereafter when it shall take effect immediately. 8 SECTION 1.
