4 AMENDING THE ACT OF JULY 1, 1981 (P.L.628, NO.5A), ENTITLED "AN <—  
5 ACT TO PROVIDE FOR THE EXPENSES OF THE EXECUTIVE, LEGISLATIVE  
6 AND JUDICIAL DEPARTMENTS OF THE COMMONWEALTH, THE PUBLIC DEBT  
7 AND FOR THE PUBLIC SCHOOLS FOR THE FISCAL PERIOD JULY 1, 1981  
8 TO JUNE 30, 1982, AND FOR THE PAYMENT OF BILLS INCURRED AND  
9 REMAINING UNPAID AT THE CLOSE OF THE FISCAL PERIOD ENDING  
10 JUNE 30, 1981; ITEMIZING APPROPRIATIONS OF THE FEDERAL  
11 AUGMENTATION TO THE EXECUTIVE AND JUDICIAL DEPARTMENTS OF THE  
12 COMMONWEALTH, ESTABLISHING RESTRICTED RECEIPTS ACCOUNTS FOR  
13 THE FISCAL PERIOD JULY 1, 1981 TO JUNE 30, 1982 AND FOR THE  
14 PAYMENT OF BILLS INCURRED AND REMAINING UNPAID AT THE CLOSE  
15 OF THE FISCAL PERIOD ENDING JUNE 30, 1981 AND TO PROVIDE  
16 ADDITIONAL AND SUPPLEMENTAL APPROPRIATIONS FROM THE GENERAL  
17 FUND AND THE MOTOR LICENSE FUND TO THE VARIOUS DEPARTMENTS OF  
18 THE COMMONWEALTH FOR THE FISCAL PERIOD JULY 1, 1980 TO JUNE  
19 30, 1981," PROVIDING ADDITIONAL APPROPRIATIONS FOR ARTS  
20 ORGANIZATIONS ~~AND~~, THE DEPARTMENTS OF EDUCATION, <—  
21 ENVIRONMENTAL RESOURCES AND HEALTH AND THE HISTORICAL AND <—  
22 MUSEUM COMMISSION.

23 THE GENERAL ASSEMBLY OF THE COMMONWEALTH OF PENNSYLVANIA

24 HEREBY ENACTS AS FOLLOWS:

25 ~~SECTION 1. THE SUM OF \$35,000 IS HEREBY SPECIFICALLY~~ <—

4 ~~SECTION 2. ANY PART OF THIS APPROPRIATION WHICH IS~~  
5 ~~UNEXPENDED, UNCOMMITTED OR UNENCUMBERED AS OF JUNE 30, 1982~~  
6 ~~SHALL AUTOMATICALLY LAPSE.~~

7 ~~SECTION 3. THIS ACT SHALL TAKE EFFECT JULY 1, 1981 UNLESS~~  
8 ~~ENACTED THEREAFTER WHEN IT SHALL TAKE EFFECT IMMEDIATELY.~~

9 SECTION 1. SECTION 201, INsofar AS IT RELATES TO THE ←  
10 GOVERNOR AND THE DEPARTMENTS OF EDUCATION AND HEALTH, ACT OF  
11 JULY 1, 1981 (P.L.628, NO.5A), KNOWN AS THE "GENERAL  
12 APPROPRIATION ACT OF 1981," IS AMENDED TO READ:

13 SECTION 201. THE FOLLOWING SUMS, OR AS MUCH THEREOF AS MAY  
14 BE NECESSARY, ARE HEREBY SPECIFICALLY APPROPRIATED FROM THE  
15 GENERAL FUND TO THE SEVERAL HEREINAFTER NAMED AGENCIES OF THE  
16 EXECUTIVE, LEGISLATIVE AND JUDICIAL DEPARTMENTS OF THE  
17 COMMONWEALTH FOR THE PAYMENT OF SALARIES, WAGES OR OTHER  
18 COMPENSATION AND TRAVEL EXPENSE OF THE DULY ELECTED OR APPOINTED  
19 OFFICERS AND EMPLOYEES OF THE COMMONWEALTH, FOR PAYMENT OF FEES  
20 OF CONTRACTUAL SERVICES RENDERED, FOR THE PURCHASE OR RENTAL OF  
21 GOODS, SERVICES, PRINTING, EQUIPMENT, LAND AND BUILDINGS AND FOR  
22 PAYMENT OF ANY OTHER EXPENSES, AS PROVIDED BY LAW OR BY THIS  
23 ACT, NECESSARY FOR THE PROPER CONDUCT OF THE DUTIES, FUNCTIONS  
24 AND ACTIVITIES AND FOR THE PURPOSES HEREINAFTER SET FORTH FOR  
25 THE FISCAL PERIOD BEGINNING JULY 1, 1981 AND FOR THE PAYMENT OF  
26 BILLS INCURRED AND REMAINING UNPAID AT THE CLOSE OF THE FISCAL  
27 PERIOD ENDING JUNE 30, 1981.
