AN ACT

1 Providing for the designation by taxpayers on State income tax
2 forms for the use of certain sums for cancer control,
3 prevention and research.

4 The General Assembly of the Commonwealth of Pennsylvania
5 hereby enacts as follows:

6 Section 1. Tax return.

7 The Department of Revenue shall provide on the face of the
8 Pennsylvania individual income tax return form a space whereby
9 an individual taxpayer may designate \$1 of his tax payment to be
10 used to fund the act of December 18, 1980 (P.L.1241, No.224),
11 known as the Pennsylvania Cancer Control, Prevention and
12 Research Act. The space so provided shall also allow two
13 taxpayers filing a joint return to indicate separately if they
14 wish to designate the \$1 for the purpose specified above.

15 Section 2. Checkmark.

1 A taxpayer may place a checkmark in the "Yes" box provided or
2 "No" box provided to indicate whether he wishes \$1 of his tax
3 payments for that fiscal year to be designated for the purpose
4 so specified.

5 Section 3. Tabulation.

6 The Department of Revenue shall tabulate the number of
7 taxpayers who check the "Yes" box provided for in section 2 and
8 multiply that by \$1.

9 Section 4. Appropriation.

10 A sum equal to the amount specified in section 3 is hereby
11 appropriated from the General Fund to the Department of Health
12 for the purposes of the act of December 18, 1980 (P.L.1241,
13 No.224), known as the Pennsylvania Cancer Control, Prevention
14 and Research Act.

15 Section 5. Effective date.

16 This act shall take effect immediately.
