AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- 2 Statutes, further providing for protection from civil or
- 3 criminal liability for medical personnel.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Sections 1547(j) and 3755(b) of Title 75 of the
- 7 Pennsylvania Consolidated Statutes, amended or added December
- 8 15, 1982 (P.L.1268, No.289), are amended to read:
- 9 § 1547. Chemical testing to determine amount of alcohol
- or controlled substance.

- 12 (j) Immunity from civil liability and reports. -- No
- 13 physician, nurse or technician or hospital employing such
- 14 physician, nurse or technician, and no other employer of such
- 15 physician, nurse or technician shall be civilly liable for
- 16 [properly] withdrawing blood or obtaining a urine sample and
- 17 reporting test results to the police at the request of a police
- 18 officer pursuant to this section. No physician, nurse or

- 1 technician or hospital employing such physician, nurse or
- 2 technician may administratively refuse to perform such tests and
- 3 provide the results to the police officer except as may be
- 4 reasonably expected from unusual circumstances that pertain at
- 5 the time the request is made.

- 7 § 3755. Reports by emergency room personnel.
- 8 * * *
- 9 (b) Immunity from civil or criminal liability.--No
- 10 physician, nurse or technician or hospital employing such
- 11 physician, nurse or technician and no other employer of such
- 12 physician, nurse or technician shall be civilly or criminally
- 13 liable for [properly] withdrawing blood or obtaining a urine
- 14 sample and reporting test results to the police pursuant to this
- 15 section or for performing any other duty imposed by this
- 16 <u>section</u>. No physician, nurse or technician or hospital employing
- 17 such physician, nurse or technician may administratively refuse
- 18 to perform such tests and provide the results to the police
- 19 officer except as may be reasonably expected from unusual
- 20 circumstances that pertain at the time of admission.
- 21 Section 2. This act shall be retroactive to January 14,
- 22 1983.
- 23 Section 3. This act shall take effect immediately.
