AN ACT

- 1 Authorizing the Department of General Services, with the
- approval of the Governor, to sell and convey a certain lot or
- 3 tract of land situate in the City of Erie, Erie County,
- 4 Pennsylvania.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The Department of General Services, with the
- 8 approval of the Governor, is hereby authorized and directed on
- 9 behalf of the Commonwealth of Pennsylvania, to grant and convey
- 10 in fee simple to the City of Erie, Erie County, Pennsylvania,
- 11 for a consideration of \$1, a tract of land situate in the City
- 12 of Erie, County of Erie, Commonwealth of Pennsylvania, bounded
- 13 and described as follows:
- 14 All that certain land or property situated in the City of
- 15 Erie and more particularly bounded and described as follows to
- 16 wit:
- 17 Beginning at a point on the east line of Peach Street, the
- 18 said point being 120.5 feet from the intersection of the east

- 1 line of Peach Street with the north line of West Second Street;
- 2 thence north 28 degrees 32 minutes west 295.01 feet to a point;
- 3 thence north 57 degrees 30 minutes 10 seconds east 331.92 feet
- 4 to a point on the west line of State Street; thence south 28
- 5 degrees 32 minutes east 234.1 feet along the east line of State
- 6 Street to a point; thence south 47 degrees 15 minutes 49 seconds
- 7 west 340.47 feet to the point of beginning. Containing 2.008
- 8 acres more or less.
- 9 The conveyance shall be made under and subject to all
- 10 easements, servitudes and rights of others, including but not
- 11 confined to streets, roadways and right of any telephone,
- 12 telegraph, water, electric, sewer, gas or pipeline companies, as
- 13 well as under and subject to any interest, estates or tenancies
- 14 vested in third persons, whether or not appearing of record, for
- 15 any portion of the land or improvements erected thereon.
- 16 Section 2. Costs and fees incidental to this conveyance
- 17 shall be borne by the grantee.
- 18 Section 3. The deed of conveyance shall be approved as
- 19 provided by law and shall be executed by the Secretary of
- 20 General Services in the name of the Commonwealth of
- 21 Pennsylvania.
- 22 Section 4. The City of Erie is authorized to take such
- 23 proceedings as are by general law authorized to open, widen,
- 24 strengthen, alter, extend, improve, grade and vacate so much of
- 25 Front Street, as above described, or any part thereof, as shall
- 26 be deeded to it, without regard to the fact that some but not
- 27 all of said Front Street shall have heretofore been opened for
- 28 public use.
- 29 Section 5. This act shall take effect immediately.
