## Report of the Committee of Conference

To the Members of the House of Representatives and Senate:

We, the undersigned, Committee of Conference on the part of the House of Representatives and Senate for the purpose of considering House Bill No. 2054, entitled: "A supplement to the act of November 30, 1965 (P.L.843, No.355), entitled 'An act providing for the establishment and operation of Temple University as an instrumentality of the Commonwealth to serve as a State-related university in the higher education system of the Commonwealth; providing for change of name; providing for the composition of the board of trustees; terms of trustees, and the power and duties of such trustees; \* \* \*; providing for the auditing of accounts of expenditures from said appropriations; authorizing the issuance of bonds exempt from taxation within the Commonwealth; requiring the President to make an annual report of the operations of Temple University,' making appropriations for carrying the same into effect; providing for a basis for payments of such appropriations; and providing a method of accounting for the funds appropriated,"

## A SUPPLEMENT

- To the act of November 30, 1965 (P.L.843, No.355), entitled "An 2 act providing for the establishment and operation of Temple 3 University as an instrumentality of the Commonwealth to serve 4 as a State-related university in the higher education system 5 of the Commonwealth; providing for change of name; providing 6 for the composition of the board of trustees; terms of 7 trustees, and the power and duties of such trustees; 8 providing for preference to Pennsylvania residents in 9 tuition; providing for public support and capital 10 improvements; authorizing appropriations in amounts to be 11 fixed annually by the General Assembly; providing for the 12 auditing of accounts of expenditures from said 13 appropriations; authorizing the issuance of bonds exempt from 14 taxation within the Commonwealth; requiring the President to 15 make an annual report of the operations of Temple 16 University, making appropriations for carrying the same into 17 effect; providing for a basis for payments of such 18 appropriations; and providing a method of accounting for the 19 funds appropriated.
- 20 The General Assembly of the Commonwealth of Pennsylvania
- 21 hereby enacts as follows:
- 22 Section 1. The following sums or as much thereof as may be
- 23 necessary, are hereby appropriated to the Trustees of Temple
- 24 University for the fiscal year July 1, 1984 to June 30, 1985 for
- 25 the purposes and in the amounts as shown:
- 26 (1) For educational and general expenses and
- 27 for participation by a representative of the
- 28 institution, appointed by the chief executive
- 29 officer thereof, as a member of the Pennsylvania
- 30 Academic Commission on Technological Development,
- 31 a commission for inter-institutional communication
- 32 regarding technological innovation and development
- 33 and for dissemination of information on such
- 34 matters to the Pennsylvania business community and
- 35 others who may use such information for new
- 36 business and job development in Pennsylvania, such
- 37 commission to be composed of representatives of
- 38 every State-owned or State-related educational or

11	Section 2. Payments to Temple University on account of the
12	appropriations for all items as provided in section 1 shall be
13	made on the basis of costs during the fiscal year.
14	Section 3. If necessary, Temple University may transfer
15	funds among the appropriations listed in section 1(1) and (2):
16	Provided, That the aggregate amount transferred into or out of
17	each appropriation during the fiscal year shall not exceed 5% of
18	the amount specifically appropriated for that purpose.
19	Section 4. (a) Payment to Temple University of the
20	appropriations provided in section 1 shall be made monthly
21	during the fiscal year.
22	(b) Such monthly payments shall be made in accordance with
23	the provisions of section 2 on the basis of estimated costs. The
24	estimate of costs shall be submitted by Temple University to the
25	Secretary of Education, the General Assembly and the State
26	Treasurer not later than 30 days prior to the date on which such
27	payment is to be made.
28	Section 5. (a) Temple University shall apply the moneys
29	appropriated by this act only for such purposes as are permitted
30	in this act and shall at all times maintain proper records

- 1 showing the application of such moneys. Not later than 120 days
- 2 after the close of the fiscal year to which this act relates,
- 3 Temple University shall file with the Secretary of Education,
- 4 the General Assembly and the Auditor General of the Commonwealth
- 5 a statement setting forth the amounts and purposes of all
- 6 expenditures made from moneys appropriated by this act and other
- 7 university accounts during said fiscal year as provided in
- 8 section 2 used as a basis for receipt of any appropriation
- 9 during said fiscal year.
- 10 (b) Such statement of expenditures and costs shall be
- 11 reviewed by the Auditor General of the Commonwealth, and he
- 12 shall have the right, in respect to the moneys appropriated by
- 13 this act, to audit and disallow expenditures made for purposes
- 14 not permitted by this act and to cause such sums to be recovered
- 15 and paid by Temple University to the State Treasurer. In respect
- 16 to expenditures made by the university from moneys other than
- 17 those appropriated by this act, the Auditor General shall have
- 18 the right to review only and he shall file annually with the
- 19 General Assembly such information concerning said expenditures
- 20 as the General Assembly or any of its committees may require.
- 21 Section 6. A report shall be submitted to the Governor and
- 22 the Appropriations and Education Committees of the Senate and
- 23 House of Representatives and shall include data for all programs
- 24 except the Doctor of Medicine program. The report, to be
- 25 submitted prior to September 1, 1985, shall cover the 12-month
- 26 period beginning with the summer term 1984 and shall include
- 27 (1) The following counts and distributions for each term
- 28 during the period:
- 29 (i) The definitions and numbers of faculty members employed
- 30 full-time, of faculty members employed part-time, of full-time

- 1 students enrolled in graduate courses, of full-time students
- 2 enrolled in undergraduate courses, of part-time students
- 3 enrolled in graduate courses, and of part-time students enrolled
- 4 in undergraduate courses.
- 5 (ii) The total numbers of undergraduate student credit
- 6 hours, divided into lower division and upper division course
- 7 levels, and of graduate student credit hours divided into three
- 8 course levels--master's, first professional and doctoral.
- 9 (iii) The number of different courses scheduled by level of
- 10 instruction, and the number of sections of individual
- 11 instruction scheduled by level of instruction, each further
- 12 subdivided by two-digit Classification of Instructional Program
- 13 (CIP) categories of instructional programs of higher education
- 14 as defined by the National Center for Education Statistics,
- 15 United States Department of Education.
- 16 (iv) The number of terms scheduled and the dates thereof.
- 17 (2) For the summer term and the following academic year in
- 18 total and for each two-digit CIP program category, a
- 19 classification of faculty members or other professional
- 20 employees by title including: professor, associate professor,
- 21 assistant professor, instructor, lecturer, research associate,
- 22 librarian and academic administrator; faculty members or other
- 23 professional employees under each title to be subdivided by type
- 24 of assignment: teaching and nonteaching, and each such set of
- 25 faculty members or other professional employees to be further
- 26 subdivided by type of employment: full-time or part-time and the
- 27 following aggregates for each such subdivided classification:
- 28 (i) The number of faculty and other professional employees
- 29 and their full-time equivalence in instructional and
- 30 noninstructional functions.

- 1 (ii) The sum of credits assigned to undergraduate classroom
- 2 courses and the sum of credits assigned to graduate classroom
- 3 courses taught, divided into lower division, upper division,
- 4 master's, first professional and doctoral course levels.
- 5 (iii) The sum of credits assigned to undergraduate
- 6 individual instruction courses and the sum of credits assigned
- 7 to graduate individual instruction courses taught, divided into
- 8 lower division, upper division, master's, first professional and
- 9 doctoral course levels.
- 10 (iv) The sum of undergraduate classroom student credit hours
- 11 and the sum of graduate classroom student credit hours
- 12 generated; divided into lower division, upper division,
- 13 master's, first professional and doctoral course levels.
- 14 (v) The sum of undergraduate individual instruction student
- 15 credit hours and the sum of graduate individual instruction
- 16 credit hours generated: divided into lower division, upper
- 17 division, master's, first professional and doctoral course
- 18 levels.
- 19 (vi) The total salary paid for instructional functions and
- 20 for noninstructional functions and the amount of this salary
- 21 paid for each of these functions from university funds, Federal
- 22 funds and other funds.
- 23 (3) For each term of the period covered for each faculty
- 24 member employed full-time identified by two-digit CIP program
- 25 category and title, the report shall contain an analysis of the
- 26 average hours per week spent in university-related activities,
- 27 stating specifically hours spent in undergraduate classroom
- 28 contact and graduate classroom contact, hours spent in
- 29 preparation, hours spent in research and hours spent in public
- 30 service.

- 1 Section 7. In addition to the requirements in section 6
- 2 relative to this appropriation, each report covering the 12-
- 3 month period beginning with the summer term 1984 shall include
- 4 for all programs of the university:
- 5 (1) Minimum number of credits required for a baccalaureate
- 6 degree and for a master's degree.
- 7 (2) Number of bachelor's degrees, master's degrees, first
- 8 professional degrees, and doctoral degrees awarded in 1982,
- 9 1983, 1984 and estimated 1985.
- 10 Section 8. Temple University shall provide such information
- 11 as may be necessary to carry out this act and in such form and
- 12 manner as the Department of Education may prescribe.
- 13 Section 9. Temple University shall report its revenues and
- 14 expenditures and present its financial statements required under
- 15 the provisions of this act in accordance with generally accepted
- 16 accounting principles and procedures for educational
- 17 institutions as set forth in the "Higher Education Finance
- 18 Manual" United States Department of Health, Education and
- 19 Welfare (1975) with the exceptions set forth in the
- 20 "Commonwealth of Pennsylvania Budget Instructions for State
- 21 Related Universities, Phase I, Fiscal Year 1984-1985." Credits
- 22 granted for nontraditional programs such as CLEP, lifelong
- 23 learning, etc., including all related costs and revenues thereof
- 24 shall be excluded from the function of "Instruction" and
- 25 included under "Public Service."
- 26 Section 10. This act shall take effect July 1, 1984 or, if
- 27 enacted subsequent to that date, then immediately.
