AN ACT

- 1 Providing for licensing and operation of video poker machines.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Video Poker
- 6 Machine Law.
- 7 Section 2. Definitions.
- 8 The following words and phrases when used in this act shall
- 9 have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- "Video poker machine." A video screen that, by insertion of
- 12 a coin, is available to display images or symbols on a monitor,
- 13 by which a player, whether by skill or chance, may receive free
- 14 games or credits which can be redeemed for cash or anything of
- 15 value. However, no machine shall directly dispense any coins,
- 16 cash, tokens or anything of value. This machine presently is
- 17 known more commonly as a poker machine.

- 1 Section 3. Administration.
- 2 This act shall be administered by the Department of Revenue,
- 3 Cigarette Tax Division, which shall have the power to adopt
- 4 rules and regulations to carry out its purpose.
- 5 Section 4. License.
- 6 Upon compliance with the following, an individual shall be
- 7 permitted to place video poker machines into operation in the
- 8 Commonwealth:
- 9 (1) The individual must obtain an operator's license and
- pay an annual fee of \$25,000.
- 11 (2) The individual must purchase a tax stamp for each
- video poker machine at a rate of \$1,000 per machine per year.
- 13 The stamp must be affixed to each machine placed in operation
- in the Commonwealth.
- 15 (3) The individual must annually provide the Department
- of Revenue with a list of all video poker machines which the
- individual has in operation in the Commonwealth.
- 18 (4) No more than six video poker machines may be placed
- in operation on one premises.
- 20 Section 5. Violations.
- 21 Any video poker machine found without a tax stamp affixed to
- 22 it shall be confiscated. The licensed operator and/or the owner
- 23 of the premises shall each be subject to a fine of \$10,000 and
- 24 the operator's license shall be suspended.
- 25 Section 6. Revenues.
- One half of all money collected under this act shall accrue
- 27 to the Commonwealth. One fourth of all money collected under
- 28 this act shall be returned to the municipality in which it was
- 29 collected and one fourth shall be returned to the school
- 30 district in which it was collected.

- 1 Section 7. Use by minors.
- 2 (a) Minors.--No person less than 21 years of age shall use
- 3 or play video poker machines in any manner or form or through
- 4 any agency. Any minor using or playing the machine or attempting
- 5 to use or play the machine shall, upon conviction, be liable for
- 6 a fine not in excess of \$1,000.
- 7 (b) Persons permitting use by minors.--Any person who
- 8 permits a person less than 21 years of age to play or use a
- 9 video poker machine in any fashion, whether that person is
- 10 actually aware of the minor's age or not, shall, upon
- 11 conviction, be liable for a fine not in excess of \$1,000, except
- 12 that the establishment of all the following facts by a person
- 13 allowing the minor to operate the machine shall constitute a
- 14 defense to any prosecution under this subsection:
- 15 (1) That the minor falsely represented in writing that
- the minor was 21 years of age or over.
- 17 (2) That the appearance of the minor was such that a
- 18 reasonable person would believe the minor to be 21 years of
- 19 age or over.
- 20 (3) That the permission to operate the video poker
- 21 machine was made in good faith, relying upon written
- 22 representation, and in the reasonable belief that the minor
- was actually 21 years of age or older.
- 24 Section 8. Repeals.
- 25 (a) Specific repeal. -- The provisions of 18 Pa.C.S. § 5513
- 26 (relating to gambling devices, gambling, etc.) are repealed to
- 27 the extent that they are inconsistent with this act.
- 28 (b) General repeal.--All other acts and parts of acts are
- 29 repealed insofar as they are inconsistent with this act.
- 30 Section 9. Exemption from Federal regulations.

- 1 The General Assembly declares that it is exempt from the
- 2 provisions of section 2 of the Gambling Devices Transportation
- 3 Act of January 2, 1951 (64 Stat. 1134, 15 U.S.C. § 1172). All
- 4 shipments of video poker machines into this Commonwealth in
- 5 compliance with sections 3 and 4 of that act shall be deemed
- 6 legal shipments into this Commonwealth.
- 7 Section 10. Effective date.
- 8 This act shall take effect immediately.
