AN ACT

- 1 Establishing a program within the Department of Commerce to
 2 provide funds GRANTS to engineering degree-granting schools <3 to assist in the acquisition of new engineering equipment or
 4 the upgrading of existing engineering equipment that is
 5 necessary to provide students with the courses required to
- obtain a degree in engineering; and making a nonlapsing appropriation.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. Short title.
- 11 This act shall be known and may be cited as the Engineering
- 12 School Equipment Act.
- 13 Section 2. Definitions.
- 14 The following words and phrases when used in this act shall

- 1 have the meanings given to them in this section unless the
- 2 context clearly indicates otherwise:
- 3 "Board." The Board of the Ben Franklin Partnership Fund
- 4 provided for in section 448(n) of the act of April 9, 1929
- 5 (P.L.177, No.175), known as The Administrative Code of 1929.
- 6 "Department." The Department of Commerce.
- 7 "Engineering degree-granting school." An institution of
- 8 higher education which offers curriculum in engineering or
- 9 engineering technology which has been approved by the
- 10 Accreditation Board of Engineering and Technology (ABET) and is
- 11 recognized as such by the State Registration Board for
- 12 Professional Engineers.
- 13 "Equipment." Basic instructional equipment of an engineering
- 14 nature used in the teaching of undergraduate or graduate
- 15 engineering or engineering technology.
- 16 "Full-time equivalent engineering student." The enrollment
- 17 in baccalaureate and graduate programs of engineering schools
- 18 expressed in terms of full-time students as determined by the
- 19 Department of Education.
- 20 Section 3. Engineering equipment acquisition and upgrade.
- 21 (a) Program. -- There is established within the department a
- 22 program to provide funds GRANTS to engineering degree-granting
- 23 schools. The program shall be administered by the board. Funds
- 24 provided through this program shall be used exclusively for the
- 25 acquisition of new engineering equipment and the upgrading of
- 26 existing engineering equipment that is necessary to provide
- 27 students with the courses required to obtain a baccalaureate or
- 28 graduate engineering degree. The board shall:
- 29 (1) Promulgate such policies, develop such forms and
- 30 institute such procedures as may be necessary to implement

- 1 this act.
- 2 (2) Allocate to each engineering school funds as
- 3 provided in subsection (b). FOR WHICH IT IS ELIGIBLE UNDER

- 4 THIS ACT.
- 5 (3) Approve or disapprove any request for expenditures
- for the purchase or upgrading of equipment.
- 7 (4) Require such information and records from each
- 8 engineering school as it deems necessary.
- 9 (5) Request the Department of Education to certify to
- 10 the board the full-time equivalent enrollment of
- 11 baccalaureate and graduate engineering students at each
- engineering school in the most recent year for which data are
- 13 available.
- 14 (b) Allocation of funds. -- The funds provided for in this act
- 15 shall be allocated by the board FOR GRANTS to the engineering
- 16 degree-granting schools based on the ratio of full-time
- 17 equivalent students enrolled in baccalaureate and graduate
- 18 engineering programs at each school to the total number of full-
- 19 time equivalent undergraduate and graduate engineering students
- 20 in the Commonwealth.
- 21 (c) Expenditure of funds.--All funds allocated GRANTS MADE <
- 22 to engineering degree-granting schools shall be expended only
- 23 for equipment. No engineering school shall expend allocated ANY
- 24 GRANT funds on equipment unless it also expends funds obtained
- 25 from private sources on that equipment. At least \$3 of private
- 26 funds shall be required for each \$1 of GRANT funds from this
- 27 program. Funds allocated GRANTS MADE under this act shall not be <---
- 28 used to supplant existing Federal, State or local funds for the
- 29 acquisition or upgrading of engineering equipment.
- 30 (d) Distribution of unused funds. -- Any allocated funds which

- 1 have not been expended consistent with subsection (c) by June
- 2 30, 1986, shall be available for redistribution REALLOCATION by <--
- 3 the board.
- 4 Section 4. Indicators of program impact.
- 5 The department shall report to the General Assembly by June
- 6 30, 1987, on the impact of the program, including the types of
- 7 equipment funded and the amount of private sector matching funds
- 8 generated. All recipients of funds GRANTS under this act shall <-
- 9 provide information requested by the department for the purposes
- 10 of this report.
- 11 Section 5. Appropriation.
- The sum of \$3,000,000 is appropriated from the Pennsylvania
- 13 Economic Recovery REVITALIZATION Fund to the Ben Franklin
- 14 Partnership Fund for grants to engineering degree-granting
- 15 schools for acquiring and upgrading engineering equipment. and <-
- 16 for administration of this program. This appropriation shall be
- 17 a continuing appropriation and shall not lapse until June 30,
- 18 1987. ANY FUNDS FROM THIS APPROPRIATION REMAINING UNEXPENDED OR <-
- 19 UNENCUMBERED UPON THE TERMINATION OF THIS ACT SHALL
- 20 AUTOMATICALLY LAPSE INTO THE PENNSYLVANIA ECONOMIC
- 21 REVITALIZATION FUND.
- 22 Section 6. Expiration.
- 23 This act shall expire June 30, 1987. unless extended by
- 24 statute.
- 25 Section 7. Effective date.
- 26 This act shall take effect immediately.
