$ 1 \\ 2 \\ 3 \\ 4 \\ 5 \\ 6 \\ 7 \\ 8 \\ 9 \\ 10 \\ 12 \\ 13 \\ 14 \\ 15 \\ $	Amending the act of December 7, 1982 (P.L.784, No.225), entitled "An act relating to dogs, regulating the keeping of dogs; providing for the licensing of dogs and kennels; providing for the protection of dogs and the detention and destruction of dogs in certain cases; regulating the sale and transportation of dogs; declaring dogs to be personal property and the subject of theft; providing for the assessment of damages done to livestock, poultry and domestic game birds; providing for payment of damages by the Commonwealth in certain cases and the liability of the owner or keeper of dogs for such damages; imposing powers and duties on certain State and local officers and employees; providing penalties; and creating a Dog Law Restricted Account," further providing for license fees for senior citizens.
16	The General Assembly of the Commonwealth of Pennsylvania
17	hereby enacts as follows:
18	Section 1. Section 201 of the act of December 7, 1982
19	(P.L.784, No.225), known as the Dog Law, is amended to read:
20	Section 201. Applications for licenses; fees; county treasurers
21	as agents.
22	(a) General ruleExcept as provided in subsection (b), on
23	or before January 1 of each year, the owner of any dog, six

months of age or older, except as hereinafter provided, shall 1 2 apply to the county treasurer of his respective county or his 3 authorized agent, on a form prescribed by the department for a 4 license for such dog. The application and license certificate 5 shall state the breed, sex, age, color and markings of such dog, and the name, address and telephone number of the owner. The 6 7 application shall be accompanied by a license fee of \$2.50 for each neutered male dog and for each spayed female dog for which 8 the certificate of a veterinarian or the affidavit of the owner 9 10 is produced, and by a license fee of \$4.50 for all other male 11 and female dogs. For Pennsylvania residents 65 years of age or older, [the license fee shall be \$1.25 for each neutered male 12 13 dog and for each spayed female dog for which the certificate of a veterinarian or the affidavit of the owner is produced, and 14 15 the license fee shall be \$2.25 for all other male or female 16 dogs] no license fee shall be charged but the service fee of 50c 17 may be charged. When the license is issued by the county 18 treasurer, an additional service fee of 50ç shall be paid by all applicants regardless of age to the county treasurer for the use 19 20 of the county. The county treasurers of this Commonwealth shall be agents of the Commonwealth for the collection of license 21 22 fees. All county treasurers shall pay all license fees collected through the Department of Agriculture into the State Treasury 23 24 for credit to the Dog Law Restricted Account.

(b) Lifetime license.--The owner of any dog six months of age or older which has been tattooed with identification numbers may apply to the county treasurer of his respective county or his authorized agent, on a form prescribed by the department for a lifetime license for such a dog. The application and license certificate shall state the breed, sex, age, color and markings 19840H2372B3368 - 2 -

of such a dog, the identifying tattoo number, and the name, 1 address and telephone number of the owner. The application shall 2 3 be accompanied by a license fee of \$10 for each neutered male 4 dog and for each spayed female dog for which the certificate of a veterinarian or the affidavit of the owner is produced, and by 5 a license fee of \$20 for all other male and female dogs. For 6 Pennsylvania residents 65 years of age or older, the license fee 7 8 shall be [\$5] <u>\$1</u> for each neutered male dog and for each spayed female dog for which the certificate of a veterinarian or the 9 affidavit of the owner is produced, and [\$10] <u>\$2</u> for all other 10 11 male and female dogs. When the license is issued by the county treasurer, an additional service fee of 50ç shall be paid by all 12 13 applicants regardless of age to the county treasurer for the use 14 of the county. The department shall promulgate regulations to 15 provide for the registration of lifetime tattoo identification numbers with the department. 16
