## AN ACT

- Amending the act of April 9, 1929 (P.L.177, No.175), entitled "An act providing for and reorganizing the conduct of the 2 3 executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative 5 departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or 6 7 Teachers Colleges; abolishing, creating, reorganizing or 8 authorizing the reorganization of certain administrative 9 departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative 10 11 officers, and of the several administrative departments, 12 boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive 13 14 and administrative officers; providing for the appointment of 15 certain administrative officers, and of all deputies and 16 other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the 17 18 number and compensation of the deputies and all other 19 assistants and employes of certain departments, boards and commissions shall be determined, "further providing for 20 expenditures for the motor vehicle emission inspection 21 22 program.
- 23 The General Assembly of the Commonwealth of Pennsylvania
- 24 hereby enacts as follows:
- 25 Section 1. Section 2013 of the act of April 9, 1929
- 26 (P.L.177, No.175), known as The Administrative Code of 1929,
- 27 added October 5, 1981 (P.L.289, No.99), is amended to read:

- 1 Section 2013. Prohibition on Expenditures for Emission
- 2 Inspection Program. -- [Neither] (a) Except as provided in
- 3 <u>subsection (b)</u>, <u>neither</u> the department nor any other department
- 4 or agency of the Executive Branch of State Government shall
- 5 expend any public funds for the establishment and administration
- 6 of any system for the periodic inspection of emissions or
- 7 emission system of motor vehicles.
- 8 (b) The provisions of subsection (a) shall not apply when
- 9 the Secretary of Transportation shall certify that such system
- 10 is required to comply with Federal law and is necessary for the
- 11 Commonwealth to receive or avoid the loss of Federal funds in
- 12 which case the department may establish and administer such a
- 13 system for motor vehicles registered in areas where periodic
- 14 inspection of emissions or emission systems of motor vehicles is
- 15 required by the Environmental Protection Agency of the United
- 16 States or decrees of the Courts of the United States.
- (c) Whenever a system for the periodic inspection of
- 18 emissions or emission systems is established as authorized in
- 19 subsection (b), the department shall issue a certificate of
- 20 waiver valid until the next scheduled emission inspection
- 21 through an official emission inspection station for a motor
- 22 vehicle which meets all of the following requirements:
- 23 (1) all required emission control devices are installed;
- 24 <u>and</u>
- 25 (2) all required emission control devices must be
- 26 <u>functioning properly or adjustments have been made to such</u>
- 27 devices in the following manner and up to at least the
- 28 <u>following total cost limitations:</u>
- 29 <u>(i) check and repair, if necessary, the following</u>
- items until the waiver total cost limitation is reached:

1	(A) idle speed, mix, timing and dwell;
2	(B) oxygen sensor - 1980 model year and newer;
3	(C) air, fuel and PCV filter;
4	(D) automatic choke;
5	(E) points and condenser;
6	(F) spark plugs;
7	(G) rotor;
8	(H) vacuum hoses;
9	(I) PCV valve;
10	(J) air pump belt;
11	(K) ignition wires; and
12	(L) distributor cap.
13	(ii) Seventy dollars (\$70) for pre-1981 model year
14	vehicles.
15	(iii) One hundred dollars (\$100) for 1981 and new
16	model year vehicles.
17	(iv) Any expenses incurred in the repair of emission
18	control devices found to be tampered with or rendered
19	inoperative through intervention by the vehicle owner or
20	someone acting on his behalf shall not be included in the
21	total cost limitations of this clause.
22	The costs mandated by this subsection do not include any costs
23	recoverable under an emission warranty.
24	(d) Whenever a system for the periodic inspection of
25	emissions or emission systems is established as authorized in
26	subsection (b), the maximum charge for such inspection shall be
27	six dollars (\$6). No additional charge shall be made by the
28	inspecting station for one necessary reinspection within thirty
29	(30) days of the original inspection.

- 1 EMISSIONS OR EMISSION SYSTEMS IS ESTABLISHED AS AUTHORIZED IN
- 2 SUBSECTION (B), SUCH INSPECTION OF EMISSIONS OR EMISSION SYSTEMS
- 3 SHALL BE COORDINATED WITH THE VEHICLE SAFETY INSPECTIONS
- 4 REQUIRED BY 75 PA.C.S. § 4702 (RELATING TO REQUIREMENT FOR
- 5 PERIODIC INSPECTION OF VEHICLES) AND SHALL BE OBTAINED DURING

- 12 not been disapproved by the Environmental Protection Agency of
- 13 the United States or the Courts of the United States, and except
- 14 that the provisions of subsection (d) of section 2013 shall take
- 15 effect upon the certification of the Secretary of Transportation
- 16 that the provisions of subsection (d) have been approved or have
- 17 not been disapproved by the Environmental Protection Agency of
