AN ACT

Amending the act of October 10, 1975 (P.L.383, No.110), entitled "An act relating to the practice of physical therapy," 3 providing for the certification of athletic trainers by the State Board of Physical Therapy Examiners; creating an 5 Athletic Trainer Advisory Committee; authorizing the setting of educational standards, certification standards and fees, 7 for the renewal, revocation and suspension of certifications; further providing standards for the practice of physical therapy; reestablishing the State Board of Physical Therapy 9 10 Examiners; making an appropriation; and providing penalties 11 for violations of the act. 12 The General Assembly of the Commonwealth of Pennsylvania 13 hereby enacts as follows: 14 Section 1. Section 2 of the act of October 10, 1975 15 (P.L.383, No.110), known as the Physical Therapy Practice Act, 16 is amended to read: 17 Section 2. Definitions. -- The following definitions shall 18 apply, when used in this act, unless otherwise expressed 19 therein: 20 "Athletic trainer" shall mean a person certified by the State

Board of Physical Therapy Examiners as an athletic trainer after

- 1 meeting the requirements of this act and rules and regulations
- 2 promulgated pursuant thereto.
- 3 <u>"Athletic Trainer Advisory Committee" shall mean the</u>
- 4 committee created by section 10.1 of this act to advise the
- 5 board.
- 6 "Board" means the State Board of Physical Therapy Examiners
- 7 established in accordance with the act of April 9, 1929
- 8 (P.L.177, No.175), known as "The Administrative Code of 1929."
- 9 <u>"Commissioner" shall mean the Commissioner of the Bureau of</u>
- 10 Professional and Occupational Affairs.
- 11 "Healing arts" shall mean the science and skill of diagnosis
- 12 and treatment in any manner whatsoever of disease or any ailment
- 13 of the human body.
- 14 "Physical therapist" shall mean a person who [practices
- 15 physical therapy in some or all respects as defined in "physical
- 16 therapy", subject to section 9 and] has met all the requirements
- 17 [as stated in] of this act and is licensed to practice physical
- 18 therapy in accordance with this act.
- 19 "Physical therapy" means the evaluation [and], screening or
- 20 treatment of any person by the utilization of the effective
- 21 properties of physical measures such as mechanical stimulation,
- 22 heat, cold, light, air, water, electricity, sound, massage,
- 23 mobilization and the use of therapeutic exercises and
- 24 rehabilitative procedures including training in functional
- 25 activities, with or without assistive devices, for the purpose
- 26 of limiting or preventing disability and alleviating or
- 27 correcting any physical or mental conditions, and the
- 28 performance of tests and measurements as an aid in diagnosis or
- 29 evaluation of function.
- 30 "Physician" means a person who has received formal and

- 1 recognized training in the art and science of medicine and is
- 2 qualified to seek or has acquired an unlimited license to
- 3 practice medicine and surgery as provided by law.
- 4 Section 2. Section 3 of the act is amended to read:
- 5 Section 3. Powers and Duties of Board.--The board shall
- 6 elect annually from its membership a chairman and a vice-
- 7 chairman and shall select a secretary who need not be a member
- 8 of the board. It shall be the duty of the board to pass upon the
- 9 qualifications of applicants for licensure as physical
- 10 therapists and certification as athletic trainers, to conduct
- 11 examinations, to issue and renew licenses to physical therapists
- 12 <u>and certifications to athletic trainers</u> who qualify under this
- 13 act, and in proper cases to suspend or revoke the license of any
- 14 physical therapist or certification of any athletic trainer. The
- 15 board may adopt rules and regulations not inconsistent with law
- 16 as it may deem necessary for the performance of its duties and
- 17 the proper administration of this law. The board is authorized
- 18 and empowered to appoint hearing examiners and to conduct
- 19 investigations and hearings upon charges for discipline of a
- 20 licensee or certificate holder or for violations of this act,
- 21 and to cause, through the office of the Attorney General, the
- 22 prosecution and enjoinder of persons violating this act. The
- 23 board shall maintain a register listing the name of every living
- 24 physical therapist licensed to practice in this State, [his]
- 25 every physical therapist assistant and every athletic trainer
- 26 <u>certified to practice in this State, such individual's</u> last
- 27 known place of business and last known place of residence, and
- 28 the date and number of [his] such individual's license or
- 29 certification.
- 30 Section 3. Section 4 of the act is amended to read:

- 1 Section 4. Training and License Required; Exceptions.--(a)
- 2 [From and after one year from the effective date of this act,
- 3 it] It shall be unlawful for any person to practice or hold
- 4 himself out as being able to practice physical therapy in this
- 5 State [unless he is trained and] in any manner whatsoever unless
- 6 such person has met the educational requirements and is licensed
- 7 in accordance with the provisions of this act. Nothing in this
- 8 act, however, shall prohibit any person trained and licensed to
- 9 practice in this State under any other law, from engaging in the
- 10 practice for which he is trained and licensed.
- 11 (b) This act shall not prohibit students who are enrolled in
- 12 schools of physical therapy approved by the board, from
- 13 performing acts of physical therapy as is incidental to their
- 14 course of study; nor shall it prevent any student in any
- 15 educational program in the healing arts approved or accredited
- 16 under the laws of Pennsylvania in carrying out prescribed
- 17 courses of study. Nothing in this act shall apply to any person
- 18 employed by an agency, bureau, or division of the Federal
- 19 Government while in the discharge of official duties, however,
- 20 if such individual engages in the practice of physical therapy
- 21 outside the scope of official duty, [he must be trained and]
- 22 such individual must meet the educational requirements and be
- 23 licensed as herein provided. The provisions of this act are not
- 24 intended to limit the activities of persons legitimately engaged
- 25 in the nontherapeutic administration of baths, massage, and
- 26 normal exercise.
- 27 (c) It shall be a violation of this act for any person or
- 28 <u>business entity to utilize in connection with a business name or</u>
- 29 <u>activity the words "physical therapy," "physical therapist,"</u>
- 30 "physiotherapy," "physiotherapist" or similar words and their

- 1 related abbreviations which imply directly or indirectly that
- 2 physical therapy services are being provided including the
- 3 billing of physical therapy services unless such services are
- 4 provided by a licensed physical therapist in accordance with
- 5 this act.
- 6 [(c) The practice of physical therapy shall not include the
- 7 practice of chiropractic as defined by the act of August 10,
- 8 1951 (P.L.1182, No.264), known as the "Chiropractic Registration
- 9 Act of 1951."]
- 10 Section 4. Section 6(a), (d), (g) and (h) of the act are
- 11 amended to read:
- 12 Section 6. Qualifications for License; Examinations; Failure
- 13 of Examinations; Licensure Without Examination; Issuing of
- 14 License; Foreign Applicants for Licensure; Temporary License;
- 15 Perjury.--(a) To be eligible for licensure as a physical
- 16 therapist, an applicant must be at least 20 years of age unless
- 17 otherwise determined by the board in its discretion, be of good
- 18 moral character, not be addicted to the habitual use of alcohol
- 19 or narcotics or other habit-forming drugs, and [have an
- 20 education of not less than 60 semester hours of college credits
- 21 or the equivalent thereof including courses in biological,
- 22 physical and social studies at an accredited college or
- 23 university and has attended an accredited physical therapy
- 24 course of not less than 12 months, in a school of physical
- 25 therapy established in a fully accredited medical school,
- 26 hospital, college or university which course has provided
- 27 curricula and training, the requirements of which shall be
- 28 approved from time to time by the board with advice and
- 29 consultation with recognized national accrediting agencies and
- 30 professional organizations including the American Physical

- 1 Therapy Association] has graduated from a school offering an
- 2 <u>educational program in physical therapy as adopted by the board</u>
- 3 which program has been approved for the education and training
- 4 of physical therapists by the appropriate nationally recognized
- 5 <u>accrediting agency</u>. By the time of completion of the
- 6 professional study of physical therapy, a physical therapist
- 7 must hold a minimum of a baccalaureate degree from a regionally
- 8 accredited institution of higher education. In the case of those
- 9 applicants who have completed requirements prior to the first
- 10 day of January, 1967, but who may not technically or totally
- 11 fulfill the above requirements, the board at its discretion and
- 12 by the majority vote of all members present may accept evidence
- 13 of satisfactory equivalence.
- 14 * * *
- 15 (d) On payment to the board of [a fee of \$15 for applicants
- 16 subject to paragraph (1) of this subsection and \$75 for
- 17 applicants subject to paragraph (2) of this subsection,] the
- 18 appropriate fee established pursuant to the act of July 1, 1978
- 19 (P.L.700, No.124), known as the "Bureau of Professional and
- 20 Occupational Affairs Fee Act" or such higher fee established by
- 21 the board from time to time after consultation with the
- 22 Commissioner and on submission of a written application on forms
- 23 provided by the board, the board shall issue a license without
- 24 examination to[:
- 25 (1) A person filing said application within one year from
- 26 the effective date of this act who presents evidence
- 27 satisfactory to the board that he meets the qualifications set
- 28 forth in subsection (a) and that he has a valid license to
- 29 practice physical therapy in the Commonwealth of Pennsylvania on
- 30 the effective date of this act.

- 1 (2) A] any person who is a licensed or otherwise registered
- 2 as a physical therapist by another state or territory of the
- 3 United States of America, or the District of Columbia[, if] and
- 4 whose license or registration is valid and in good standing; and
- 5 <u>further that</u> the requirements for license or registration, as
- 6 the case may be, in such state, territory, or district were [at
- 7 the date of his license or registration by such state,] or are
- 8 substantially equal to the requirements set forth in this act:
- 9 Provided, That such person has not taken and failed, one or more
- 10 times, the examination referred to in subsection (b), in which
- 11 case, the issuance of a license under this paragraph shall be at
- 12 the discretion of the board.
- 13 * * *
- 14 (g) [On payment to the board of a fee of \$25, and the
- 15 submission of a written application on forms provided by it, the
- 16 board, in its discretion, shall issue without examination a
- 17 temporary license to practice physical therapy in this State for
- 18 a period not to exceed one year to any person who meets the
- 19 qualifications set forth in clause (2) of subsection (d) of this
- 20 section upon submission by such person of evidence satisfactory
- 21 to the board and verified by oath that he is in this State on a
- 22 temporary basis to assist in a case of medical emergency or to
- 23 engage in a special physical therapy project. A temporary
- 24 license, as described above, may be renewed for one additional
- 25 year at the board's discretion, and upon expiration must be
- 26 surrendered to the board.
- 27 (h)] Upon the submission of a written application on forms
- 28 provided by it, the board shall also issue a temporary license
- 29 to a person who has applied for a license under the provisions
- 30 of subsection (a) and who is, in the judgment of the board,

- 1 eligible to take the examination provided for in subsection (b).
- 2 Such temporary license shall be available to an applicant with
- 3 respect to his application for a license under subsection (a),
- 4 but the applicant may only use the temporary license while under
- 5 the direct supervision of a licensed physical therapist. Such
- 6 temporary license shall expire upon the failure of the first
- 7 examination and upon expiration the license must be surrendered
- 8 to the board except that the board may reissue such temporary
- 9 <u>license in its discretion and in accordance with rules and</u>
- 10 regulations to be established.
- 11 (h) The granting or issuing of any temporary license or
- 12 permit relating to the practice of physical therapy in the
- 13 Commonwealth for any reason other than as set forth in
- 14 <u>subsection (q), shall be within the sole discretion of the board</u>
- 15 <u>subject to rules and regulations established by the board</u>.
- 16 * * *
- 17 Section 5. Sections 8 and 9 of the act are amended to read:
- 18 Section 8. Fees and Fines for Board.--All fees and fines
- 19 collected under the provisions of this act shall be paid into
- 20 the [State Treasury for the use of the Commonwealth]
- 21 Professional Licensure Augmentation Account established pursuant
- 22 to and for use in accordance with the act of July 1, 1978
- 23 (P.L.700, No.124), known as the "Bureau of Professional and
- 24 Occupational Affairs Fee Act. " Nothing contained in this
- 25 amendment is intended to alter the fees authorized and set
- 26 pursuant to said act except that the board may from time to time
- 27 adopt higher fees where it determines after consultation with
- 28 the commissioner more revenue is needed to effectively
- 29 administer the provisions of this act.
- 30 Section 9. <u>Practice and</u> Referrals by Physicians.--Any person

- 1 licensed under this act as a physical therapist [shall not treat
- 2 human ailments by physical therapy or otherwise except by the
- 3 referral of a person licensed in this State as a physician;
- 4 however, a physical therapist shall be permitted to accept the
- 5 referral of a dentist or podiatrist licensed in this State, for
- 6 the treatment of a condition that is within the scope of
- 7 practice of dentistry or podiatry] <u>may screen, consult with or</u>
- 8 evaluate an individual as to the need for physical therapy
- 9 <u>services</u>. Physical therapy treatment of any individual for a
- 10 medical condition, however, shall be administered by a licensed
- 11 physical therapist based on a referral from or a consultation
- 12 <u>with a licensed physician. Treatment by a licensed physical</u>
- 13 therapist for a medical condition may also occur based on a
- 14 referral from or consultation with a licensed dentist or a
- 15 licensed podiatrist for a condition within the scope of their
- 16 <u>respective practices</u>. Nothing in this act shall be construed as
- 17 authorization for a physical therapist to practice any branch of
- 18 the healing arts except as described in this act. Any person
- 19 violating the provisions of this act shall be guilty of a
- 20 misdemeanor as described in section 12.
- 21 Section 6. The act is amended by adding sections to read:
- 22 Section 10.1. Athletic Trainer Advisory Committee Created.--
- 23 There is hereby created an advisory committee to be known as the
- 24 Athletic Trainer Advisory Committee which shall be appointed by
- 25 and serve at the pleasure of the board for the purpose of
- 26 <u>carrying out the provisions of this act as it relates to</u>
- 27 athletic trainers. The Athletic Trainer Advisory Committee shall
- 28 <u>assist the board in the certification, renewal, revocation or</u>
- 29 <u>suspension of athletic trainers in accordance with this act and</u>
- 30 rules and regulations and as the board deems appropriate. The

- 1 Athletic Trainer Advisory Committee shall consist of no more
- 2 than three members who shall be certified athletic trainers and
- 3 who shall receive reimbursement for actual traveling expenses
- 4 related to their service to the board and a per diem to be fixed
- 5 from time to time by the Governor's Executive Board but not less
- 6 than \$35 per day. Advisory committee members may be selected by
- 7 the board from a list of qualified athletic trainers provided by
- 8 the Pennsylvania Athletic Trainers Society. Members of the
- 9 <u>advisory committee shall serve for three years except that the</u>
- 10 initial committee membership shall be appointed to serve for
- 11 staggered terms of one, two and three years respectively.
- 12 Section 10.2. Certification of Athletic Trainers;
- 13 <u>Certification Renewal, Revocation or Suspension.--(a) The board</u>
- 14 shall have the power to adopt rules and regulations governing
- 15 the certification of athletic trainers. Such rules and
- 16 regulations shall establish standards necessary to Commonwealth
- 17 certification in the following categories:
- 18 (1) Approved educational program standards.
- 19 (2) Education degree requirements for certification.
- 20 (3) Practical training experience requirements for
- 21 certification.
- 22 (4) Other requirements necessary for the proper, ethical and
- 23 professional training of persons applying for certification
- 24 which are deemed appropriate by the board.
- 25 Regulations promulgated pursuant to this section shall be
- 26 formulated with the advice and consultation of the Athletic
- 27 Trainer Advisory Committee.
- 28 (b) The board shall issue certification certificates to
- 29 <u>individuals seeking certification as athletic trainers after its</u>
- 30 review of a proper certification application presented on forms

- 1 prescribed by the board which evidences the satisfaction of the
- 2 standards promulgated by rules in accordance with the provisions
- 3 <u>in subsection (a) and further upon payment of an appropriate fee</u>
- 4 to be set by the board after consultation with the commissioner.
- 5 (c) The board shall renew, revoke or suspend the
- 6 certification of athletic trainers pursuant to rules and
- 7 regulations formulated in consultation with the Athletic Trainer
- 8 Advisory Committee. All actions of the board shall be taken
- 9 subject to the right of notice, hearing and adjudication and the
- 10 right of appeal therefrom in accordance with Title 2 of the
- 11 Pennsylvania Consolidated Statutes (relating to administrative
- 12 <u>law and procedure</u>).
- 13 Section 7. Section 11(a)(1) of the act is amended to read:
- 14 Section 11. Refusal or Suspension or Revocation of
- 15 License.--(a) The board shall refuse to issue a license to any
- 16 person and after notice and hearing in accordance with rules and
- 17 regulations, may suspend or revoke the license of any person who
- 18 has:
- 19 (1) [practiced physical therapy other than upon the referral
- 20 of a physician or as set forth in section 9] been found to have
- 21 violated section 9;
- 22 * * *
- 23 Section 8. Section 12(b) of the act is amended to read:
- 24 Section 12. Penalties; Injunctive Relief. -- * * *
- 25 (b) The board may, in the name of the people of the
- 26 Commonwealth of Pennsylvania, through the Attorney General's
- 27 Office, apply for injunctive relief in any court of competent
- 28 jurisdiction to enjoin any person from committing any act in
- 29 violation of this act. Such injunction proceedings shall be in
- 30 addition to, and not in lieu of, all penalties and other

- 1 remedies in this act.
- 2 Section 9. This act reestablishes the State Board of
- 3 Physical Therapy Examiners in accordance with the procedures set
- 4 forth in section 7(a) of the act of December 22, 1981 (P.L.508,
- 5 No.142), known as the Sunset Act.
- 6 Section 10. There is hereby appropriated from the
- 7 Professional Licensure Augmentation Account within the General
- 8 Fund to the Bureau of Professional and Occupational Affairs, in
- 9 the Department of State, for the establishment and operations of
- 10 the State Board of Physical Therapy Examiners pursuant to this
- 11 act, the sum of \$10,000, or as much thereof as may be necessary.
- 12 Section 11. This act shall take effect three calendar months
- 13 from the date of its enactment.
