AN ACT

- Amending the act of August 31, 1955 (P.L.531, No.131), entitled "An act permitting and regulating wrestling and boxing contests and exhibitions; requiring licenses and permits; conferring powers and imposing duties upon the State Athletic 5 Commission; providing for the granting, suspension, and revocation of licenses and permits issued by the Commission; preserving the rights of existing licensees and permittees; prescribing penalties, fines, forfeitures and misdemeanors; 9 requiring bonds and insurance; creating a Medical Advisory Board; providing for rules and regulations; and making 10 11 appropriations, " regulating kick boxing; further regulating amateur boxing; establishing a State boxing register; 12 13 providing for medical training seminars; requiring certain emergency medical equipment to be at situs of certain events; 14 further providing for suspension; further defining referee's 15 16 role in boxing contest; prohibiting tough guy contests or 17 battle of the brawlers contests; and providing a penalty. 18 The General Assembly of the Commonwealth of Pennsylvania 19 hereby enacts as follows: 20 SECTION 1. SECTION 102 OF THE ACT OF AUGUST 31, 1955 21 (P.L.531, NO.131), KNOWN AS THE PENNSYLVANIA ATHLETIC CODE, IS AMENDED BY ADDING DEFINITIONS TO READ:
- 23 SECTION 102. DEFINITIONS; CONSTRUCTION. -- THE FOLLOWING TERMS

- 1 SHALL BE CONSTRUED WHEN USED IN THIS ACT TO HAVE THE FOLLOWING
- 2 MEANINGS, EXCEPT IN THOSE INSTANCES WHERE THE CONTEXT CLEARLY
- 3 INDICATES OTHERWISE:
- 4 * * *
- 5 "BOXING" SHALL MEAN THE ACT OF ATTACK AND DEFENSE WITH THE
- 6 FISTS, PRACTICED AS A SPORT, SUBJECT TO RULES ADOPTED BY THE
- 7 COMMISSION. THE TERM "BOXING" SHALL INCLUDE ALL VARIATIONS OF
- 8 THE SPORT PERMITTING OR USING OTHER PARTS OF THE HUMAN BODY,
- 9 INCLUDING BUT NOT LIMITED TO, THE FOOT, KNEE, LEG, ELBOW OR
- 10 HEAD.
- 11 * * *
- 12 <u>"WRESTLING" SHALL MEAN A SPORT OR CONTEST OR EXHIBITION IN</u>
- 13 WHICH TWO UNARMED INDIVIDUALS STRUGGLE HAND TO HAND WITH EACH
- 14 INDIVIDUAL ATTEMPTING TO SUBDUE OR UNBALANCE THE OPPONENT. THE
- 15 TERM "WRESTLING" SHALL INCLUDE ALL VARIATIONS OF THE SPORT
- 16 PERMITTING OR USING OTHER PARTS OF THE HUMAN BODY OR OTHER
- 17 <u>NATURAL OR MANMADE SUBSTANCES OR OBJECTS.</u>
- 18 SECTION 2. SECTION 201 OF THE ACT, AMENDED MAY 24, 1956
- 19 (1955 P.L.1693, NO.574), IS AMENDED TO READ:
- 20 SECTION 201. POWER OF COMMISSION TO CONTROL WRESTLING AND
- 21 BOXING.--[THE] EXCEPT AS PROVIDED IN SECTION 103, THE COMMISSION
- 22 IS HEREBY GRANTED SOLE DIRECTION, CONTROL AND JURISDICTION OVER
- 23 ALL AMATEUR AND PROFESSIONAL BOXING AND WRESTLING CONTESTS AND
- 24 EXHIBITIONS OR ANY VARIATIONS THEREOF HELD WITHIN THE
- 25 COMMONWEALTH OF PENNSYLVANIA, EXCEPT SUCH CONTESTS AND
- 26 EXHIBITIONS AS ARE SPECIFICALLY EXEMPTED FROM THE PROVISIONS OF
- 27 THIS ACT.
- 28 Section ± 3. Section 202 of the act, of August 31, 1955
- 29 (P.L.531, No.131), known as the Pennsylvania Athletic Code,
- 30 amended June 18, 1976 (P.L.393, No.85), is amended to read:

- 1 Section 202. Boxing and Wrestling Regulated.--Amateur or
- 2 professional boxing or wrestling contests or exhibitions
- 3 including kick boxing shall be held within the Commonwealth of
- 4 Pennsylvania only in accordance with the provisions of this act
- 5 and the rules and regulations promulgated hereunder. Such
- 6 contests or exhibitions may be held on Sundays.
- 7 Section 24. Section 204 of the act, amended May 24, 1956 <-
- 8 (1955 P.L.1693, No.574), is amended to read:
- 9 Section 204. Physician to be in Attendance.--A physician
- 10 shall be assigned to every boxing or wrestling contest or
- 11 exhibition by the Commission. He shall observe and continue to
- 12 observe the physical condition of the participants and [advise
- 13 the member of the Commission or deputy in charge and the referee
- 14 in regard thereto.] be authorized to stop any contest or
- 15 <u>exhibition at any time to examine a contestant and to terminate</u>
- 16 a bout when in his judgment severe injury could result to a
- 17 contestant if the contest or exhibition were to continue. The
- 18 Commission shall establish by rule or regulation a schedule of
- 19 fees to be paid such physicians for their services. The
- 20 physician's fee shall be paid by the promoter of the contest or
- 21 exhibition attended by the physician.
- 22 Section $\frac{3}{2}$ 5. The act is amended by adding sections to read: <
- 23 Section 204.1. Medical Training Seminars.--The Commission
- 24 shall conduct frequent mandatory medical training seminars, at
- 25 <u>least three (3) per year for all ring personnel, Commission</u>
- 26 personnel and for other persons employed by the Commission and
- 27 designated to attend.
- 28 <u>Section 204.2. Register.--The Commission shall establish and</u>
- 29 <u>maintain a register for all professional boxers licensed in</u>
- 30 Pennsylvania. The register shall include a photograph of the

- 1 boxer. In the register, the Commission shall record the results
- 2 of each boxing contest or exhibition the boxer is involved in,
- 3 including technical knockouts, knockouts and other boxing
- 4 <u>related injuries</u>, as well as the dates of each contest or
- 5 exhibition and the record of wins and losses.
- 6 <u>Section 204.3. Medical Equipment.--No professional or</u>
- 7 amateur boxing event shall be started unless there is on the
- 8 premises:
- 9 (1) an ambulance, together with emergency equipment; and
- 10 (2) a portable resuscitator with oxygen and appropriate
- 11 <u>endotracheal tubes</u>, and a qualified operator.
- 12 <u>Section 204.4. Suspension.--For sound medical reasons and to</u>
- 13 protect the individual boxers, the Commission shall establish
- 14 mandatory license suspensions of those persons who sustain
- 15 <u>certain injuries. The Commission may suspend a boxer's license</u>
- 16 for up to sixty (60) days for a laceration of the face, up to
- 17 thirty (30) days for a technical knockout with minor injuries
- 18 and up to forty-five (45) days for head injuries. Boxers
- 19 receiving a knockout may receive up to a ninety (90) day
- 20 suspension and shall receive an EEG within twenty-four (24)
- 21 hours of the knockout.
- 22 Section 4 6. Sections 208 and 210 of the act, amended May

- 23 24, 1956 (1955 P.L.1693, No.574), are amended to read:
- 24 Section 208. Gloves. [When the boxers are [lighweights, as
- 25 defined in the regulations, or in a lighter class, one hundred
- 26 thirty five (135) pounds or under, they shall wear boxing gloves <-
- 27 weighing not less than five (5) ounces each. When the boxers are
- 28 over one hundred thirty five (135) pounds but do not exceed one
- 29 <u>hundred sixty (160) pounds, they shall wear boxing gloves</u>
- 30 weighing not less than six (6) ounces each. When the boxers are

- 1 [in a heavier class than lightweights,] over one hundred sixty
- 2 (160) pounds, they shall wear boxing gloves weighing not less
- 3 than [six (6)] ten (10) ounces each. THE TYPE, SIZE AND WEIGHT <-

- 4 OF GLOVES ARE TO BE REGULATED BY THE STATE ATHLETIC COMMISSION.
- 5 SSECTION 208. GLOVES.--WHEN THE BOXERS ARE [LIGHTWEIGHTS, AS <---
- 6 DEFINED IN THE REGULATIONS, OR IN A LIGHTER CLASS, ONE HUNDRED
- 7 THIRTY-FIVE (135) POUNDS OR UNDER, THEY SHALL WEAR BOXING GLOVES
- 8 WEIGHING NOT LESS THAN FIVE (5) OUNCES EACH. WHEN THE BOXERS ARE
- 9 OVER ONE HUNDRED THIRTY-FIVE (135) POUNDS BUT DO NOT EXCEED ONE
- 10 HUNDRED SIXTY (160) POUNDS, THEY SHALL WEAR BOXING GLOVES
- 11 WEIGHING NOT LESS THAN SIX (6) OUNCES EACH. WHEN THE BOXERS ARE
- 12 [IN A HEAVIER CLASS THAN LIGHTWEIGHTS,] <u>OVER ONE HUNDRED SIXTY</u>
- 13 (160) POUNDS, THEY SHALL WEAR BOXING GLOVES WEIGHING NOT LESS
- 14 THAN [SIX (6)] TEN (10) OUNCES EACH.
- 15 Section 210. Attendance of Referee and Judges; Scoring. -- At
- 16 each professional boxing contest or exhibition, except an
- 17 exhibition held solely for training purposes, there shall be in
- 18 attendance, at the expense of the promoter, a duly licensed
- 19 referee designated by the Commission who shall direct and
- 20 control the contest or exhibition.
- 21 There shall also be in attendance at every boxing contest, at
- 22 the expense of the promoter, [two (2)] three (3) licensed
- 23 judges, each of whom shall[, together with the referee,] render
- 24 his individual decision, in writing, on a scorecard supplied by
- 25 the Commission at the end of every boxing contest which
- 26 continues for the scheduled number of rounds. Each judge [and
- 27 the referee] shall have one (1) vote and a majority of the votes
- 28 cast shall determine the winner.
- 29 The Commission shall by rule or regulation prescribe the
- 30 methods of scoring.

- 1 Section $\frac{5}{7}$. The act is amended by adding a section to read: <---
- 2 <u>Section 223. Prohibited Competition.--(a) A person commits</u>
- 3 <u>a misdemeanor of the first degree if he promotes, sponsors or</u>
- 4 participates in any manner in the staging of, or the conduct of,
- 5 any tough guy contest or battle of the brawlers or in any
- 6 <u>similar competition</u>.
- 7 (b) The provisions of this section shall not apply to the
- 8 news media, including but not limited to television, radio,
- 9 <u>newspapers and periodicals</u>, for their reporting or advertising
- 10 activities relating to tough guy contests or battle of the
- 11 brawlers.
- (c) As used in this section the phrase "tough guy contest"
- 13 or "battle of the brawlers" means any competition which involves
- 14 any physical contact bout between two or more individuals, who
- 15 attempt to knock out their opponent by employing boxing,
- 16 wrestling, martial arts tactics or any combination thereof and
- 17 by using techniques including, but not limited to, punches,
- 18 kicks and choking. These phrases shall not apply to amateur or
- 19 professional contests sanctioned by the Pennsylvania Athletic
- 20 <u>Commission nor to contests staged in connection with athletic</u>
- 21 training programs nor to amateur or professional contests of the

- 22 martial arts nor to any collegiate or scholastic boxing,
- 23 wrestling or martial arts contests.
- Section 6 8. Section 250 of the act, added May 24, 1956
- 25 (1955 P.L.1693, No.574), is amended to read:
- 26 Section 250. Mandatory Eight Count.--Whenever a boxer is
- 27 knocked down, he shall be required to take a count of eight,
- 28 even if he has regained his feet prior thereto, and the referee
- 29 shall not permit the contest or exhibition to be resumed until
- 30 the count of eight has actually been reached, except in

- 1 professional championship boxing contests and exhibitions. $\underline{\mathbf{A}}$
- 2 referee may give a standing eight count in those instances where
- 3 <u>he deems necessary.</u>
- Section 7 9. This act shall take effect in 60 days. 4
