A SUPPLEMENT

1	To the act of (P.L., No.), entitled "An act providing for
2	the capital budget for the fiscal year 1983-1984," itemizing

5	transportation assistance projects to be constructed or
6 7	acquired or assisted by the Department of General Services,

9	their estimated financial cost; authorizing the incurring of
10	debt without the approval of the electors for the purpose of
11	financing the projects to be constructed or acquired or
12	assisted by the Department of General Services, the
13	Department of Transportation or the Department of Community
14	Affairs; stating the estimated useful life of the projects;
15	and making an appropriation.

3 (b) The total authorization for the additional capital 4 projects in the category of public improvement projects 5 consisting of the acquisition of original movable furniture and 6 equipment to complete public improvement projects itemized in 7 section 3 and to be purchased by the Department of General 8 Services, its successors or assigns and to be financed by the 9 incurring of debt, shall be \$5,840,000 \$9,982,000. <-

10 (c) The total authorization for the capital project in the 11 category of redevelopment assistance projects itemized in 12 section 4 for capital grants by the Department of Community 13 Affairs, its successors or assigns, and to be financed by the 14 incurring of debt, shall be \$43,900,000.

(d) The total authorization for the additional capital projects in the category of transportation assistance projects itemized in section 5 with respect to which an interest is to be acquired in or constructed by the Department of Transportation, its successors or assigns and to be financed by the incurring of debt, shall be \$4,378,000.

The total authorization for the additional capital 21 (e) 22 projects in the category of public improvement projects itemized 23 in section 6 and to be acquired or constructed by the Pennsylvania Fish Commission, its successors or assigns and to 24 25 be financed from the current revenues of the Fish Fund pursuant 26 to executive authorization, shall be \$2,156,000. 27 Section 2.
