AN ACT

- 1 Prohibiting false reports relating to certain disasters and to
- the operation of power generating facilities; and fixing
- 3 penalties.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Public
- 8 Utility Misinformation Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Agency." A branch office or regional office operated by the
- 14 agency.
- 15 Section 3. False reports.
- 16 (a) Emergencies. -- An individual commits a felony of the
- 17 second degree if the individual knowingly provides false

- 1 information to any State agency or political subdivision during
- 2 the occurrence of or relating to a disaster as defined in 35
- 3 Pa.C.S. Part V (relating to emergency management services).
- 4 (b) Power generating facilities.--An individual commits a
- 5 felony of the second degree if the individual knowingly provides
- 6 false information to any agency of the Federal or State
- 7 government relating to or regarding any aspect of the operation
- 8 of a power generating facility which may adversely affect the
- 9 health, welfare or safety of the residents of Pennsylvania.
- 10 (c) Operation of facility after false report. -- An individual
- 11 commits a felony of the second degree if the individual operates
- 12 any power generating facility after providing false information
- 13 which is prohibited by subsection (a) or (b). For purposes of
- 14 this subsection, the time within which an action must be
- 15 commenced by a prosecuting authority shall be computed from the
- 16 time at which the falsity of the information provided is
- 17 discovered.
- 18 (d) Conspiracy. -- An individual commits a felony of the third
- 19 degree if the individual agrees with another individual or
- 20 individuals to engage in any conduct prohibited by subsection
- 21 (a), (b) or (c) or agrees to aid, assist or abet another
- 22 individual or individuals in planning, attempting or
- 23 solicitation to attempt such conduct as prohibited by subsection
- 24 (a), (b) or (c).
- 25 (e) Penalties.--
- 26 (1) An individual who is guilty of violating subsection
- 27 (a), (b) or (c) shall be sentenced to a fine of not less than
- \$10,000 or imprisonment of not less than six years, or both.
- 29 (2) An individual who is guilty of violating subsection
- 30 (d) shall be sentenced to a fine of not less than \$5,000 or

- imprisonment of not less than two years, or both. 1
- 2 Section 4. Effective date.
- This act shall take effect in 60 days. 3
