A JOINT RESOLUTION

- 1 Ratifying the proposed amendment to the Constitution of the
- 2 United States regarding representation of the District of
- 3 Columbia in Congress.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby resolves as follows:
- 6 Section 1. Article V of the United States Constitution
- 7 provides for ratification of the United States Constitutional
- 8 amendments by the legislatures of three-fourths of the several
- 9 states. Congress approved House Joint Resolution 554 on August
- 10 22, 1978, proposing to amend the Constitution to provide for
- 11 representation of the District of Columbia in the Congress and
- 12 submitted said resolution to the states for their ratification.
- 13 Section 2. The following proposed amendment to the
- 14 Constitution of the United States is hereby ratified by the
- 15 General Assembly of the Commonwealth of Pennsylvania:

- 1 "Article ____
- 2 "Section 1. For purposes of representation in the Congress,
- 3 election of the President and Vice President, and Article V of
- 4 this Constitution, the District constituting the seat of
- 5 government of the United States shall be treated as though it
- 6 were a State.
- 7 "Section 2. The exercise of the rights and powers conferred
- 8 under this article shall be by the people of the District
- 9 constituting the seat of government, and as shall be provided by
- 10 the Congress.
- 11 "Section 3. The twenty-third article of amendment to the
- 12 Constitution of the United States is hereby repealed.
- "Section 4. This article shall be inoperative, unless it
- 14 shall have been ratified as an amendment to the Constitution by
- 15 the legislatures of three-fourths of the several States within
- 16 seven years from the date of its submission."
- 17 Section 3. A certified copy of this resolution shall be
- 18 forwarded to the Administrator of General Services, in
- 19 accordance with 1 U.S.C. § 106b, to the President of the United
- 20 States Senate and to the Speaker of the United States House of
- 21 Representatives.
