1 2 3 4 5 6 7 8 9 10	Amending the act of December 6, 1972 (P.L.1614, No.335), entitled "An act defining blood banks, serum exchanges, blood bank depositories; blood fractionization and blood products operation; regulating the operations of same; requiring such organizations to obtain licenses to engage in these activities; requiring minimal standards of operation and qualifications of supervising personnel; imposing certain duties upon the Department of Health; establishing a blood bank advisory committee and providing penalties," requiring a screening test for acquired immune deficiency syndrome.

1 * * * (8) The department shall set guidelines for the location of 2 3 blood banks in order to avoid areas of high risk where there are 4 high levels of hepatitis, acquired immuned deficiency syndrome 5 or other diseases transferred by blood transfusions. * * * 6 7 Section 2. The act is amended by adding a section to read: 8 Section 6514.2. Acquired Immune Deficiency Syndrome.--(a) 9 Donated blood shall be tested for the presence of acquired immune deficiency syndrome (AIDS) virus in accordance with 10 11 screening test procedures approved by the Department of Health. 12 (b) Identification of all donors who show positive signs of 13 exposure shall be made, including the name, address and age of the donor and the date and place of bleeding and testing, and 14 15 transmitted to the Department of Health. 16 (c) Donors shall be notified when positive signs of an antibody have been detected, the blood shall be deferred for use 17 18 and the donor shall be advised to consult with a physician for 19 counseling and further testing. 20 (d) The Department of Health shall distribute to each licensed blood bank a list of donors whose blood has reacted 21 22 positively to the approved test for acquired immune deficiency
