2	Section 1010. Personal Care Home Administrators(a) The
3	department shall, after January 1, 1988, require that all
4	personal care boarding homes identify and appoint a boarding
5	home administrator.
6	(b) A personal care boarding home administrator shall:
7	(1) Be at least twenty-one years of age, have a high school
8	diploma or a General Educational Development diploma and be of
9	good moral character.
10	(2) Have knowledge, education and training in:
11	(i) Fire prevention and emergency planning.
12	(ii) First aid, administration of medications, medical
13	terminology and personal hygiene.
14	(iii) Nutrition.
15	<u>(iv) Recreation.</u>
16	(v) Mental illness and gerontology.
17	(vi) Community resources and social services.
18	By January 1987, the department shall develop such standards for
19	education, training or knowledge to meet the standards of this
20	subsection. In developing standards for education, training and
21	knowledge, the department shall establish an advisory board
22	which shall include owners or operators of personal care
23	boarding homes and members of the public representing residents
24	of personal care boarding homes.
25	(c) If not otherwise available, the department shall
26	schedule and offer at cost, training and educational programs
27	for a person to meet the knowledge, educational and training
28	requirements required by this act.
29	(d) The department may require personal care boarding home
30	operators to annually and satisfactorily complete additional
