AN ACT

Amending the act of May 15, 1945 (P.L.547, No.217), entitled, as 2 amended, "An act relating to the conservation of soil, water 3 and related natural resources and land use practices 4 contributing to soil wastage and soil erosion; providing for 5 the organization of the various counties into conservation districts; the appointment of their officers and employes; 7 and prescribing their powers and duties; creating the State 8 Conservation Commission in the Department of Environmental 9 Resources and fixing its powers and duties relative to the 10 administration of this act; providing financial and legal 11 assistance to such conservation districts and the commission; and authorizing county governing bodies to make 12 13 appropriations thereto; providing for disposition and operation of existing districts; and repealing existing 14 15 laws," further structuring and reestablishing the State 16 Conservation Commission. 17 The General Assembly of the Commonwealth of Pennsylvania 18 hereby enacts as follows: 19 Section 1. Sections 4(1) and (4), 6(1), 7(1) and 14 AND 7(1) < of the act of May 15, 1945 (P.L.547, No.217), known as the 20 21 Conservation District Law, reenacted and amended December 19, 22 1984 (P.L.1125, No.221), are amended to read:

Section 4. State Conservation Commission. -- (1) There is

- 1 hereby created in the department the State Conservation
- 2 Commission, which shall be a departmental administrative
- 3 commission with all the powers and duties generally vested in,
- 4 and imposed upon, such commissions by The Administrative Code of
- 5 1929. The commission shall consist of the Secretary of
- 6 Environmental Resources, who shall be the chairman, the
- 7 Secretary of Agriculture of Pennsylvania, the Dean of the
- 8 College of Agriculture of The Pennsylvania State University and
- 9 four farmer members, who shall be farmers, to be appointed by
- 10 the Governor [from a list of eight] with the advice and consent
- 11 of a majority of the members elected to the Senate. In
- 12 appointing farmer members, the Governor shall consider nominees
- 13 submitted by the associations known as the "Pennsylvania State
- 14 Council of Farm Organizations, " and the "Pennsylvania
- 15 Association of Conservation District Directors, Inc." Each
- 16 association shall nominate one candidate for each farmer member
- 17 vacancy. Two [urban] <u>public</u> members [of the commission] <u>who</u>
- 18 <u>shall not be farmers</u> shall also be appointed to the commission
- 19 by the Governor with the advice and consent of a majority of the
- 20 members elected to the Senate. [In the event, however, that said
- 21 association shall fail to make and submit to the Governor,
- 22 nominations to fill vacancies, the Governor may appoint any
- 23 qualified citizens of Pennsylvania to fill such vacancies.] The
- 24 State Conservationist of the Soil Conservation Service, United
- 25 States Department of Agriculture and the Associate Director of
- 26 the Cooperative Extension Service of The Pennsylvania State
- 27 University shall be associate, non-voting members of the
- 28 commission. The commission shall keep a record of its official
- 29 actions, and may perform such acts and promulgate such rules and
- 30 regulations as may be necessary. The department shall assign

- 1 such personnel as needed for the execution of the commission's
- 2 function under this act. A majority of the voting members shall
- 3 constitute a quorum and all decisions of the commission shall
- 4 require a concurrence of the voting members of the commission.
- 5 At the last regular meeting of the commission in the calendar
- 6 year, a vice-chairperson shall be elected by the members of the
- 7 commission and shall serve in that capacity for the ensuing
- 8 year.
- 9 * * *
- 10 (4) The farmer and [urban] <u>public</u> members of the commission
- 11 shall be appointed for a period of four years and shall hold
- 12 office until their successors have been appointed and have
- 13 qualified, but no longer than six months beyond the four-year
- 14 period. The four farmer members' terms shall be so staggered
- 15 that no more than one member's term shall expire each year while
- 16 the two [urban] public members' terms shall be so staggered that
- 17 no more than one member's term shall expire every second year.
- 18 At the expiration of their terms of office, or in the event of
- 19 vacancies through death, resignation or otherwise, new farmer or
- 20 [urban] <u>public</u> members shall be appointed to fill the unexpired
- 21 term of the members they are replacing. A majority of the
- 22 commission shall constitute a quorum and all decisions shall
- 23 require the concurrence of a majority of the commission. All
- 24 <u>farmer and public</u> members of the commission shall be entitled to
- 25 [fifty dollars (\$50) per diem plus expenses including traveling]
- 26 <u>sixty dollars (\$60) per diem plus reimbursement for reasonable</u>
- 27 traveling, lodging and other necessary expenses incurred in the
- 28 discharge of their duties <u>IN ACCORDANCE WITH COMMONWEALTH</u>
- 29 <u>REGULATIONS</u>. The commission shall provide for the execution of
- 30 surety bonds for all employes and officers who shall be

- 1 entrusted with funds or property of the commission and shall
- 2 provide for the keeping of a full and accurate record of all
- 3 proceedings and of all resolutions, regulations and orders
- 4 issued or adopted. A farmer or public member of the commission
- 5 who fails to attend three consecutive meetings shall forfeit his
- 6 seat unless the Secretary of Environmental Resources, upon
- 7 written request from the member, finds that the member should be
- 8 excused from a meeting because of illness or the death of a
- 9 family member.
- 10 * * *
- 11 Section 6. Designation of District Directors. -- (1) When a
- 12 county has been declared a conservation district, a board of
- 13 directors, consisting of seven members, shall be appointed by
- 14 the county governing body. This board of directors shall consist
- 15 of one member of the county governing body, not more than four
- 16 or less than two farmers, and not less than two or more than
- 17 four [urban members] public members who shall not be farmers.
- 18 The total number of directors shall always be seven, unless the
- 19 State Conservation Commission, upon request of the district and
- 20 the county governing body, approves a lesser or greater number
- 21 in unusual or extenuating circumstances but in no case shall the
- 22 number be less than five nor more than nine. The composition of
- 23 the board shall be determined by the county governing body and
- 24 approved by the State Conservation Commission before such change
- 25 shall become effective; the farmer and [urban] public members to
- 26 be appointed shall be selected from a list containing at least
- 27 double the number of directors to be appointed, and such list is
- 28 to be submitted by each of the organizations within the county
- 29 designated by the State Conservation Commission. Upon receipt of
- 30 notice from the State Conservation Commission of the

- 1 organizations to be entitled to make such nominations, and
- 2 having secured nomination lists, the county governing body shall
- 3 appoint the proper number of directors.
- 4 * * *
- 5 Section 7. Appointment; Qualifications; Compensation; and
- 6 Tenure of Directors. -- (1) The director appointed from the
- 7 county governing body shall be appointed annually by the county
- 8 governing body. The term of office for farmer and [urban] public
- 9 directors will be four years, except that directors shall be
- 10 appointed so that no more than three directors' terms shall
- 11 expire in any one year, unless a conservation district board is
- 12 comprised of more than seven directors as provided for in
- 13 section 6. A director shall hold office until a successor has
- 14 been appointed and has qualified. Vacancies shall be filled for
- 15 the unexpired terms. Successors to fill unexpired terms or for
- 16 full terms shall be appointed by the county governing body from
- 17 a list containing at least double the number of directors to be
- 18 appointed, such list to be composed of nominations submitted in
- 19 writing by a qualified officer of each of the organizations
- 20 designated by the State Conservation Commission. The final list
- 21 of nominations shall be placed on file by the county governing
- 22 body and shall be open to public inspection. In filling
- 23 unexpired terms, the county governing body may make appointments
- 24 from any list prepared in the above manner that has been
- 25 compiled within the twelve months preceding such appointments.
- 26 * * *
- 27 <u>Section 14. Commonwealth Appropriations. (1) The General</u>
- 28 Assembly of the Commonwealth shall appropriate from time to time
- 29 as may be necessary, moneys out of the General Fund to the State
- 30 Conservation Commission for its use in administering the

- 1 provisions of this act.
- 2 (2) The department shall submit annually to the
- 3 appropriations committees of the Senate and the House of
- 4 Representatives, no later than fifteen days after the Governor
- 5 has submitted his budget to the General Assembly, an estimate
- 6 for the upcoming year of the commission members' per diem and
- 7 other expenses, the expenses of the department personnel to be
- 8 incurred in supporting the commission and the percentage of the
- 9 working hours of those personnel to be devoted to supporting the
- 10 commission.
- 11 Section 2. This act, with respect to the State Conservation
- 12 Commission, shall constitute the legislation required to
- 13 reestablish an agency pursuant to the act of December 22, 1981
- 14 (P.L.508, No.142), known as the Sunset Act, and the commission
- 15 is hereby reestablished.
- 16 Section 3. The presently confirmed members of the State
- 17 Conservation Commission AS OF THE EFFECTIVE DATE OF THIS ACT

- 18 shall continue to serve as commission members until their
- 19 present terms of office expire, provided that any present
- 20 commission member whose term has expired on or before the
- 21 effective date of this act shall serve until a successor has
- 22 been appointed and qualified, but no longer than six months
- 23 after the effective date of this act. Any person presently
- 24 serving on the board of directors of a conservation district
- 25 shall continue to serve as a board member until his present term
- 26 of office expires.
- 27 Section 4. Each rule and regulation of the State
- 28 Conservation Commission in effect on the effective date of this
- 29 act and not inconsistent with this act shall remain in effect
- 30 after such date until repealed or amended by the commission,

- 1 provided that the commission shall immediately initiate the
- 2 repeal or amendment of any rule or regulation which is
- 3 inconsistent with the provisions of this act.
- Section 5. This act shall take effect May 1, 1986, or 4
- immediately, whichever is later. 5
