AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 4 schools; amending, revising, consolidating and changing the laws relating thereto, " requiring notification of parents or legal quardians when children are absent from school. 6 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 9 The act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, is amended by adding a

- 12 Section 1354.1. Notification When Children are Absent. -- (a)
- 13 Beginning with the 1986 school year, if any child enrolled in a
- 14 public school in grades kindergarten through eight is absent
- 15 from school, and there is no record that such absence is for a
- valid cause, nor notification that the absence has been 16
- authorized by the parent, legal quardian or other person having 17
- legal custody of such child, an employe or other agent, whether 18
- 19 a volunteer or otherwise, designated by the public school in

- 1 which the child is enrolled, shall, within two hours after the
- 2 <u>first class in which the child is enrolled, make a reasonable</u>
- 3 <u>effort to promptly telephone and notify the parent, legal</u>
- 4 guardian or other person having legal custody of the child, of
- 5 the child's absence from school. Such notification shall not be
- 6 given for an absence authorized by the parent, legal quardian or
- 7 other person having legal custody of the child. Prior to any
- 8 <u>enrollment of a child in a public school, the school district</u>
- 9 shall notify parents, legal guardians or other persons having
- 10 legal custody of a child, of their responsibility to authorize
- 11 any absence and to notify the school in advance or at the time
- 12 of any such absence, and that the school requires at least one
- 13 and not more than two telephone numbers be given for purposes of
- 14 this section. The school district shall require that such
- 15 telephone numbers be given at the time of enrollment of the
- 16 child in school, which numbers may be changed from time to time
- 17 upon notification to the school.
- 18 (b) The requirements of this section shall have been met by
- 19 the school if notification of an absence has been attempted by
- 20 <u>telephoning the one or two numbers given the school by the</u>
- 21 parent, legal guardian or other person having legal custody of a
- 22 child, whether or not there is any answer at such telephone
- 23 number or numbers. Further, the requirements of this section
- 24 <u>shall have been met if the notification is given to a member of</u>
- 25 the household of the child's parent, legal quardian or other
- 26 person having legal custody of the child, which member of the
- 27 household must be ten years of age or older.
- 28 (c) An employe or other agent designated by the public
- 29 school who in good faith makes a reasonable effort to notify the
- 30 parent, legal guardian or other person having legal custody of a

- 1 child of the child's absence from school, when required by this
- 2 <u>section</u>, shall not, as a result of his acts or omissions, except
- 3 wilful or wanton misconduct on the part of such employe or agent
- 4 <u>in attempting to comply with the notification requirements of</u>
- 5 this section, be liable for civil damages, nor shall such person
- 6 be subject to any of the penalties or sanctions provided for in
- 7 this act.
- 8 Section 2. This act shall take effect immediately.
