AN ACT

- Providing for the control of transportation of poultry and for 2 the disinfection of conveyances carrying poultry, poultry 3 products or poultry feed; requiring a license for transportation of live poultry or for dealing in poultry or 4 poultry products; setting fees; authorizing certain powers of enforcement to the Department of Agriculture; making an 6 appropriation; and prescribing penalties. 8 The General Assembly of this Commonwealth intends to prevent the introduction and spread of Avian Influenza H5N2 Virus into 10 this Commonwealth and to halt the subsequent spread of this 11 devastating disease into poultry flocks and markets of 12 surrounding states and Canada. Since the flu virus is spread by 13 human contact and transportation equipment, the General Assembly maintains that strict standards of disinfection and sanitation 14 15 are crucial to the prevention of Avian Influenza epidemics. 16 Additionally, the General Assembly finds the licensing of poultry haulers and dealers to be a method of determining the 17 source and extent of infection. 18
- 19 The General Assembly of the Commonwealth of Pennsylvania

- 1 hereby enacts as follows:
- 2 Section 1. Short title.
- 3 This act shall be known and may be cited as the Poultry
- 4 License and Transportation Control Act.
- 5 Section 2. Definitions.
- 6 The following words and phrases when used in this act shall
- 7 have the meanings given to them in this section unless the
- 8 context clearly indicates otherwise:
- 9 "Conveyance." Any automobile, truck, tractor trailer, wagon
- 10 or other vehicle used in the transportation of persons or
- 11 animate or inanimate items of personal property on public
- 12 highways of this Commonwealth. The term shall not include any
- 13 vehicle used by a producer exclusively on a farm or on or
- 14 between farms operated as part of a single agricultural
- 15 operation.
- 16 "Department." The Department of Agriculture of this
- 17 Commonwealth.
- "Dealer" or "poultry dealer." Any person engaged in the
- 19 business of buying and/or selling poultry or poultry products as
- 20 principal or agent.
- 21 "Operator." The licensed driver of a vehicle.
- 22 "Person." A natural person, corporation, partnership or
- 23 association.
- 24 "Poultry." Any live or undressed domesticated or game bird
- 25 kept or grown for the commercial use of its meat, its eggs or
- 26 any poultry product.
- 27 "Poultry product." The meat, eggs, manure, organs or any
- 28 other portion of a bird having commercial value.
- 29 "Producer" or "poultry producer." Any person engaged in the
- 30 business of growing or keeping poultry for market. This term

- 1 shall not include a person who, by contract, employs another
- 2 person to exclusively perform the actual breeding, growing or
- 3 raising activities on the poultry, regardless of whether or not
- 4 such employer has title in the poultry.
- 5 "Secretary." The Secretary of Agriculture of the
- 6 Commonwealth.
- 7 Section 3. Standards of sanitation required.
- 8 The department shall:
- 9 (1) Within six months of the effective date of this act,
- 10 promulgate and publish regulations for standards of
- 11 sanitation, cleanliness, disinfection and operation for all
- conveyances used in the transportation of poultry and for all
- flats, crates, coops, cages or other accessories, whether or
- 14 not constructed of permeable material, used on conveyances
- for poultry transportation; for the nature of attire and
- sanitation of all persons hauling or employed in the hauling
- or other handling of poultry; and for annual sanitation and
- 18 disinfection of poultry houses.
- 19 (2) Require that a daily record of all sanitation
- 20 measures taken be kept by the owner or operator of any
- 21 conveyance hauling poultry.
- 22 (3) Conduct periodic inspections of conveyances and
- 23 accessories used in hauling poultry and ascertain that
- 24 records are maintained.
- 25 Section 4. License required.
- 26 (a) Transportation of poultry. -- On and after March 31, 1987,
- 27 it shall be unlawful for any owner or operator of any
- 28 conveyance, whether or not contracted by another party, to
- 29 engage in the business of transportation of poultry within this
- 30 Commonwealth, unless he shall hold a license issued by the

- 1 department as provided in this act.
- 2 (b) Poultry business.--It shall be unlawful, on or after
- 3 March 31, 1987, for any poultry dealer to engage in business
- 4 transactions within this Commonwealth, unless he shall hold a
- 5 license issued by the department.
- 6 Section 5. Filing procedures.
- 7 Every poultry dealer and every owner or operator of a
- 8 conveyance desiring to transport poultry within this
- 9 Commonwealth shall annually, on or before December 31, file an
- 10 application for a license with the department. The application
- 11 shall be on a form furnished by the department and shall contain
- 12 any information as the department may require.
- 13 Section 6. Payment of fees.
- 14 Unless the department refuses the application on one or more
- 15 grounds as provided in this act, it shall issue to an applicant,
- 16 upon the payment of proper fees, a license entitling the
- 17 applicant to conduct transportation of poultry or to act as a
- 18 dealer in poultry until December 31 of the year next following.
- 19 The fee for this license shall be \$25 for each vehicle used for
- 20 these purposes.
- 21 Section 7. Keeping of records.
- 22 (a) Poultry transportation.--Every owner or operator of a
- 23 conveyance used to haul poultry shall keep a record for at least
- 24 two years of all premises where receipt or delivery of poultry
- 25 was made; the quantity, condition, type and species of poultry
- 26 received or delivered; the date received or delivered; and any
- 27 other information which the department by regulation shall
- 28 require.
- 29 (b) Poultry dealers.--Every dealer of poultry shall keep a
- 30 record for at least two years of all transactions conducted,

- 1 including name and address of each buyer and seller; the
- 2 quantity and description of goods purchased or sold; the date of
- 3 each transaction; the nature or condition of goods transacted;
- 4 the date and nature of payment; and any other information which
- 5 the department by regulation shall require.
- 6 Section 8. Revocation of suspension of license.
- 7 The department may refuse to grant a license or may suspend
- 8 or revoke a license already granted under this act if it is
- 9 satisfied that the applicant or licensee has:
- 10 (1) Failed to maintain adequate records of poultry
- 11 haulage or transactions or other information required under
- this act or regulations issued pursuant thereto.
- 13 (2) Failed to meet the minimum standards of sanitation
- for conveyances and accessories used for transporting poultry
- in accordance with regulations adopted by the department.
- 16 (3) Made any false statement or statements or kept any
- false records relative to the destination, dates of visit,
- 18 quantity and condition of birds received or delivered, or any
- 19 other information required under this act or regulations of
- the department.
- 21 (4) Made any false statement in the application for or
- 22 attempt to procure any license permitted to be issued under
- this act.
- 24 Section 9. Hearings and appeals.
- 25 (a) Hearings.--Before the department shall refuse, suspend
- 26 or revoke any license, it shall conduct a hearing on the matter.
- 27 If the department shall find the applicant or licensee in
- 28 violation of section 8, the department may refuse, suspend or
- 29 revoke such license and shall notify the applicant or licensee,
- 30 in writing, within five days of its determination.

- 1 (b) Procedure.--Hearings under this act and appeals from
- 2 decisions of the department shall be conducted in the manner
- 3 provided in Title 2 of the Pennsylvania Consolidated Statutes
- 4 (relating to administrative law and procedure) and by the Rules
- 5 of Appellate Procedure.
- 6 Section 10. Penalties.
- 7 Any owner or operator of a vehicle or any poultry dealer who
- 8 violates the provisions of section 4 or interferes with an agent
- 9 of the department in the enforcement of this act:
- 10 (1) For a first offense commits a summary offense and
- shall, upon conviction, be sentenced to pay a fine of not
- less than \$100 nor more than \$300 and costs of prosecution,
- and in default of payment of such fine and costs, be
- sentenced to imprisonment for a period not exceeding 60 days.
- 15 (2) For a subsequent offense commits a misdemeanor of
- 16 the third degree and shall, upon conviction, be sentenced to
- pay a fine of not less than \$500 nor more than \$2,500 or to
- imprisonment not exceeding one year or both.
- 19 Section 11. Injunctions.
- The Attorney General, at the request of the department, may,
- 21 in the name of the Commonwealth, institute proceedings in equity
- 22 in the Commonwealth Court for the purpose of enjoining the
- 23 conduct of business in this Commonwealth contrary to the
- 24 provisions of this act.
- 25 Section 12. Rules and regulations.
- The department shall, in the manner provided by law,
- 27 promulgate and enforce the rules and regulations deemed
- 28 necessary to carry out the provisions of this act.
- 29 Section 13. Poultry Inspection Account.
- 30 All moneys received from license fees and fines collected

- 1 under this act shall be immediately paid by the department into
- 2 the State Treasury and credited to a restricted receipts
- 3 account, to be known as the Poultry Inspection Account, to be
- 4 used for payment of costs to issue licenses and provide for
- 5 inspections pursuant to section 3(3). All moneys in this account
- 6 are hereby appropriated to the department on a continuing basis
- 7 for this purpose.
- 8 Section 14. Effective date.
- 9 This act shall take effect immediately.
