AN ACT

Amending the act of December 7, 1982 (P.L.784, No.225), entitled 2 "An act relating to dogs, regulating the keeping of dogs; providing for the licensing of dogs and kennels; providing 3 4 for the protection of dogs and the detention and destruction of dogs in certain cases; regulating the sale and 6 transportation of dogs; declaring dogs to be personal 7 property and the subject of theft; providing for the 8 assessment of damages done to livestock, poultry and domestic 9 game birds; providing for payment of damages by the 10 Commonwealth in certain cases and the liability of the owner or keeper of dogs for such damages; imposing powers and 11 12 duties on certain State and local officers and employees; 13 providing penalties; and creating a Dog Law Restricted 14 Account, " requiring that dogs be vaccinated against rabies as 15 a condition for licensure; authorizing the department to 16 establish antirabies clinics; and making an appropriation. 17 PROVIDING FOR THE ESTABLISHMENT AND OPERATION OF A STATEWIDE 18 SYSTEM FOR THE PREVENTION AND CONTROL OF RABIES; IMPOSING ADDITIONAL POWERS AND DUTIES ON THE DEPARTMENTS OF 19 20 AGRICULTURE AND HEALTH; PROVIDING FOR EMERGENCY DECLARATIONS; 21 FIXING PENALTIES FOR VIOLATIONS; AND MAKING AN APPROPRIATION.

- 12 The General Assembly of the Commonwealth of Pennsylvania
- 13 hereby enacts as follows:
- 14 Section 1. Section 201 of the act of December 7, 1982
- 15 (P.L. 784, No. 225), known as the Dog Law, is amended by adding
- 16 subsections to read:
- 17 Section 201. Applications for licenses; fees; county treasurers

- 18 as agents.
- 19 * * *
- 20 (a.1) Rabies vaccination required. Each applicant for an
- 21 <u>annual license shall, in addition to the information required by</u>
- 22 subsection (a), present to the county treasurer, or his
- 23 authorized agent, proof, acceptable to the department, that the
- 24 dog has been adequately vaccinated by or under the supervision
- 25 <u>of a licensed veterinarian against rabies. The department shall</u>
- 26 recognize that rabies vaccine is effective for three years. No
- 27 annual license shall be issued for any dog without proof of
- 28 <u>adequate vaccination</u>.
- 29 * * *
- 30 (b.1) Rabies vaccinations for dogs with lifetime licenses.

- 1 Each applicant for a lifetime license shall, at the time of
- 2 application for the license, in addition to the information
- 3 required by subsection (b), present to the county treasurer, or
- 4 his authorized agent, proof, acceptable to the department, that
- 5 the dog has been adequately vaccinated by or under the
- 6 <u>supervision of a licensed veterinarian against rabies. No</u>
- 7 lifetime license shall be issued for any dog without proof of
- 8 adequate vaccination. As a condition for a lifetime license to
- 9 remain valid, the owner of the dog for which such a license has
- 10 been issued shall, within three years from the original date of
- 11 issue, and within each three year period thereafter, present to
- 12 the county treasurer proof, acceptable to the department, that
- 13 the dog has been adequately vaccinated by or under the
- 14 supervision of a licensed veterinarian against rabies. Any
- 15 <u>county treasurer failing to receive the required proof within</u>
- 16 any such three year period shall mail a notice to the dog owner
- 17 informing him that the license has been suspended and that, for
- 18 all purposes of this act, the dog is an unlicensed dog until
- 19 such time as proof is presented that the dog has been adequately
- 20 <u>vaccinated by or under the supervision of a licensed</u>
- 21 veterinarian against rabies.
- 22 (c) Vaccination by certain owners. Any person to whom a
- 23 private kennel license or breeding kennel license has been
- 24 issued pursuant to section 206, or any other person who owns and
- 25 keeps at least five but less than 26 dogs, may make application
- 26 to the department for authorization to vaccinate dogs which he
- 27 owns against rabies. If the department is satisfied that the
- 28 vaccination will be performed in accordance with its prescribed
- 29 guidelines, the department may issue the authorization. An
- 30 <u>authorization so issued may be revoked by the department at any</u>

- 1 time for violation of the quidelines. When applying for a
- 2 <u>license for a dog so vaccinated, the owner shall present to the</u>
- 3 county treasurer, or his authorized agent, the authorization
- 4 issued by the department together with such proof of adequate
- 5 <u>vaccination</u> as the department may prescribe.
- 6 Section 2. Section 1001(c) of the act is amended to read:
- 7 Section 1001. Dog Law Restricted Account; disposition and
- 8 appropriation of funds accruing under the
- 9 provisions of this act.
- 10 * * *
- 11 (c) Subsidized services. [No] Except as provided in section
- 12 1001.1, no funds credited to the restricted account created by
- 13 this section shall be used for government subsidized veterinary
- 14 services.
- 15 Section 3. The act is amended by adding a section to read:
- 16 Section 1001.1. Antirabies clinics.
- 17 (a) General rule. In areas where the department determines
- 18 that occurrences of rabies pose a grave health risk to human or
- 19 animal population, the department may provide for the
- 20 <u>establishment of antirabies clinics</u>. The clinics shall be
- 21 offered at such locations and on such dates as the department
- 22 shall determine. The chief veterinarian of the department shall
- 23 establish vaccination procedures to be used at the clinics. In
- 24 establishing antirabies clinics, the department shall cooperate
- 25 with local licensed veterinarians and other local organizations.
- 26 Using funds credited to the Dog Law Restricted Account, the
- 27 department shall purchase and supply the necessary quantities of
- 28 <u>vaccine at each established antirabies clinic. If any charge is</u>
- 29 <u>made by the department for vaccine so purchased and supplied,</u>
- 30 the funds received by the department in payment of that charge

- 1 shall be paid into the Dog Law Restricted Account. Except as
- 2 provided in subsection (b), funds credited to the Dog Law
- 3 Restricted Account may also be used to pay for other related
- 4 nondepartmental administrative costs associated with such
- 5 antirabies clinics, including, but not limited to, building
- 6 rental, supplies necessary to administer the vaccine, and
- 7 dispensing fees. Not more than 1% of the funds received by the
- 8 department under this act and credited to the Dog Law Restricted
- 9 Account on an annual basis shall be utilized for nondepartmental
- 10 <u>administrative expenses pursuant to this section.</u>
- 11 (b) Antirabies clinics in cities of the first class, second
- 12 <u>class and second class A. The costs of antirabies clinics</u>
- 13 <u>established as provided in subsection (a) in cities of the first</u>
- 14 class, second class and second class A shall be paid by the
- 15 <u>cities in which they are located, and not from funds credited to</u>
- 16 the Dog Law Restricted Account. The department shall, however,
- 17 purchase and supply the necessary quantities of vaccine at each
- 18 established antirabies clinic in such cities.
- 19 Section 4. Section 1201 of the act is amended to read:
- 20 Section 1201. Applicability to cities of the first class,
- 21 second class and second class A.
- 22 Insofar as this act provides for the individual licensing of
- 23 dogs and the payment of damages for livestock or poultry injured
- 24 by dogs or for licensed dogs illegally killed, it shall not
- 25 apply to cities of the first class, second class and second
- 26 class A. Such individual dog licensing and payment of damages in
- 27 cities of the first class, second class and second class A shall
- 28 continue to be carried on under the provisions of existing laws.
- 29 However, the provisions of section 201 requiring proof that a
- 30 dog has been adequately vaccinated against rabies as a condition

- 1 for issuance of a license shall apply to persons issuing dog
- 2 <u>licenses anywhere in this Commonwealth, including cities of the</u>
- 3 first class, second class and second class A.
- 4 Section 5. The sum of \$250,000 is hereby appropriated to the
- 5 Department of Agriculture for fiscal year July 1, 1986, to June
- 6 30, 1987, for agricultural/animal research to further provide
- 7 for wildlife rabies vaccine research.
- 8 Section 6. The provisions of section 201(a.1) and (b.1)
- 9 shall apply to annual dog licenses issued for the year beginning

- 10 January 1, 1987, and each year thereafter, and to lifetime dog
- 11 licenses issued on or after January 1, 1987.
- 12 Section 7. This act shall take effect immediately.
- 13 SECTION 1. SHORT TITLE.
- 14 THIS ACT SHALL BE KNOWN AND MAY BE CITED AS THE RABIES
- 15 PREVENTION AND CONTROL IN DOMESTIC ANIMALS AND WILDLIFE ACT.
- 16 SECTION 2. FINDINGS.
- 17 (A) INCIDENCE IN RABIES.--THE INCIDENCE OF RABIES THROUGHOUT
- 18 THIS COMMONWEALTH HAS INCREASED OVER THE PAST SIX YEARS IN
- 19 ALARMING PROPORTIONS. IN 1985, 450 LABORATORY-CONFIRMED RABIES
- 20 CASES WERE REPORTED IN THIS COMMONWEALTH, AS COMPARED TO ONLY 16
- 21 CONFIRMED CASES IN 1979. FURTHERMORE, THE EPIDEMIC IS SPREADING
- 22 ACROSS THE STATE. IN 1981, ONLY NINE COUNTIES REPORTED CASES OF
- 23 RABIES, WHEREAS, IN 1985, RABIES CASES WERE REPORTED IN ALMOST
- 24 HALF THE COUNTIES OF THIS COMMONWEALTH.
- 25 (B) IMPACT OF RABIES EPIDEMIC. -- THE SOCIOECONOMIC IMPACT OF
- 26 THE EPIDEMIC IS FRIGHTENING. NOT ONLY IS THE POSTEXPOSURE
- 27 TREATMENT COSTLY BUT THE PROTOCOL SURROUNDING A SINGLE SUSPECTED
- 28 RABID ANIMAL REQUIRES THE EXPENDITURE OF BOTH MONETARY AND HUMAN
- 29 RESOURCES.
- 30 SECTION 3. LEGISLATIVE INTENT.

- 1 IT IS THE INTENT OF THE GENERAL ASSEMBLY TO PROVIDE A
- 2 COMPREHENSIVE RABIES CONTROL PROGRAM INVOLVING RESEARCH,
- 3 PREVENTION AND EDUCATION WHICH WILL PROTECT THE CITIZENS OF THIS
- 4 COMMONWEALTH FROM AN UNNECESSARY AND HARMFUL RABIES EPIDEMIC.
- 5 SECTION 4. DEFINITIONS.
- 6 THE FOLLOWING WORDS AND PHRASES WHEN USED IN THIS ACT SHALL
- 7 HAVE THE MEANINGS GIVEN TO THEM IN THIS SECTION UNLESS THE
- 8 CONTEXT CLEARLY INDICATES OTHERWISE:
- 9 "DEPARTMENT." THE DEPARTMENT OF AGRICULTURE OF THE
- 10 COMMONWEALTH.
- 11 "RABIES." IN MAN AND ANIMAL, HYDROPHOBIA, AN ACUTE VIRAL
- 12 DISEASE OF THE CENTRAL NERVOUS SYSTEM USUALLY TRANSMITTED TO MAN
- 13 THROUGH THE INJECTION OF SALIVA BY AN ANIMAL BITE.
- 14 "SECRETARY." THE SECRETARY OF AGRICULTURE OF THE
- 15 COMMONWEALTH.
- 16 SECTION 5. STATEWIDE SYSTEM FOR RABIES CONTROL.
- 17 THE DEPARTMENT, IN COOPERATION WITH THE PENNSYLVANIA GAME
- 18 COMMISSION AND THE DEPARTMENT OF HEALTH, SHALL ESTABLISH A
- 19 STATEWIDE SYSTEM FOR THE PREVENTION AND CONTROL OF RABIES IN
- 20 BOTH WILD AND DOMESTIC ANIMALS. THE SYSTEM WILL ENCOMPASS BOTH A
- 21 COMPREHENSIVE RESEARCH PROGRAM AIMED AT ENDING THE RABIES
- 22 EPIDEMIC IN THE WILD AND A RABIES CONTROL PROGRAM WHICH INCLUDES
- 23 STANDARDIZED PROCEDURES TO FOLLOW IN THIS COMMONWEALTH.
- 24 SECTION 6. POWERS AND DUTIES OF DEPARTMENT.
- 25 THE DEPARTMENT SHALL HAVE THE FOLLOWING POWERS AND DUTIES:
- 26 (1) MONITOR, IN COOPERATION WITH THE DEPARTMENT OF
- 27 HEALTH AND THE PENNSYLVANIA GAME COMMISSION, THE CONFIRMED
- 28 INCIDENCES OF RABIES IN BOTH DOMESTIC AND WILD ANIMALS.
- 29 (2) DETERMINE, BASED ON THE NUMBER OF CONFIRMED CASES,
- 30 THE NUMBER OF PROJECTED INCIDENCES, THE PROBABILITY OF HUMAN

- 1 CONTACT AND THE RAPIDITY OF THE SPREAD OF THE RABIES, WHERE A
- 2 PUBLIC RISK MAY EXIST.
- 3 (3) INSTITUTE THE RELEVANT ACTIONS OUTLINED IN THIS ACT,
- 4 AS WELL AS OTHERS DETERMINED BY THE DEPARTMENT UNTIL IT IS
- 5 DETERMINED THAT THE THREAT OF THE RABIES EPIDEMIC NO LONGER
- 6 EXISTS.
- 7 (4) INSTITUTE AN INTENSIVE PUBLIC EDUCATION CAMPAIGN ON
- 8 RABIES THROUGH NEWSPAPERS, RADIO AND TELEVISION
- 9 ANNOUNCEMENTS.
- 10 SECTION 7. TESTING.
- 11 ALL TESTING AND OTHER NECESSARY OR APPROPRIATE RABIES CONTROL
- 12 CONDUCTED UPON RABID OR SUSPECTED RABID ANIMALS APPROPRIATE TO
- 13 PROTECT HUMAN LIFE AND SAFETY SHALL BE CONDUCTED FREE OF CHARGE
- 14 AT STATE LABORATORIES OR OTHER FACILITIES DESIGNATED BY THE
- 15 SECRETARY.
- 16 SECTION 8. VACCINATION REQUIRED; CERTIFICATE AND TAG.
- 17 (A) REQUIREMENT. -- EVERY PERSON LIVING IN THIS COMMONWEALTH,
- 18 OWNING OR KEEPING A DOG OR CAT OVER THREE MONTHS OF AGE, SHALL
- 19 CAUSE THAT DOG OR CAT TO BE VACCINATED AGAINST RABIES. RABIES
- 20 VACCINE SHALL BE ADMINISTERED BY A LICENSED VETERINARIAN OR
- 21 UNDER THE SUPERVISION OF A LICENSED VETERINARIAN. THE
- 22 COMMONWEALTH SHALL RECOGNIZE THE THREE-YEAR RABIES VACCINE AS
- 23 THE VACCINE TO BE USED. THOSE ANIMALS VACCINATED AFTER ONE YEAR
- 24 OF AGE SHALL GET BOOSTER VACCINATIONS EVERY THREE YEARS
- 25 THEREAFTER. THOSE ANIMALS VACCINATED PRIOR TO ONE YEAR OF AGE
- 26 WILL BE CONSIDERED PROTECTED FOR ONLY ONE YEAR AND SHALL RECEIVE
- 27 A BOOSTER VACCINATION ONE YEAR LATER ON THE ANNIVERSARY DATE OF
- 28 THE ORIGINAL VACCINATION, AND SHALL BE VACCINATED EVERY THREE
- 29 YEARS THEREAFTER.
- 30 (B) CERTIFICATE AND TAG OF VACCINATION. -- EVERY LICENSED

- 1 VETERINARIAN WHO VACCINATES A DOG OR CAT AGAINST RABIES SHALL
- 2 ISSUE A VACCINATION CERTIFICATE AND TAG PROVIDED BY THE
- 3 MANUFACTURER TO THE OWNER. INFORMATION CONTAINED IN RABIES
- 4 VACCINATION RECORDS SHALL NOT BE USED FOR THE PURPOSE OF
- 5 LICENSING ANIMALS OR FOR TAXATION OF INDIVIDUALS FOR OWNING
- 6 ANIMALS. FOR THE PURPOSES OF THIS SECTION, EACH LICENSED
- 7 VETERINARIAN MAY SELECT A VACCINE OF HIS CHOICE AND USE THE
- 8 PROCEDURES FOR ADMINISTERING IT AS ARE CONSISTENT WITH THE
- 9 RECOMMENDATIONS OF THE FEDERAL AGENCY WHICH LICENSES THE
- 10 VACCINE.
- 11 (C) ENFORCEMENT.--IT SHALL BE THE DUTY OF EVERY POLICE
- 12 OFFICER OR STATE DOG WARDEN OR THE DESIGNATED MUNICIPAL ANIMAL
- 13 CONTROL OFFICER TO ISSUE A CITATION TO EVERY PERSON WHO OWNS A
- 14 DOG OR CAT WHICH IS NOT VACCINATED PURSUANT TO SUBSECTION (A).
- 15 SECTION 9. ANTIRABIES CLINICS.
- 16 THE DEPARTMENT SHALL ASSIST IN THE ESTABLISHMENT OF LOW-COST
- 17 ANTIRABIES CLINICS. THESE CLINICS SHALL BE OFFERED AT LOCATIONS
- 18 AND ON DATES AS APPROPRIATE. THE DEPARTMENT SHALL ESTABLISH
- 19 VACCINATION PROCEDURES FOR CATS AND DOGS TO BE USED AT THE
- 20 CLINICS. IN ASSISTING IN THE ESTABLISHMENT OF ANTIRABIES
- 21 CLINICS, THE DEPARTMENT SHALL COOPERATE WITH LOCAL VETERINARIANS
- 22 AND OTHER LOCAL ORGANIZATIONS.
- 23 SECTION 10. POWERS AND DUTIES OF DEPARTMENT RELATING TO
- 24 WILDLIFE.
- 25 (A) POWERS AND DUTIES. -- THE DEPARTMENT SHALL DEVELOP,
- 26 ADMINISTER AND ENTER INTO A CONTRACT WITH WISTAR INSTITUTE FOR A
- 27 COMPREHENSIVE MULTIYEAR WILDLIFE VACCINE RESEARCH PROGRAM, WHICH
- 28 MAY INCLUDE, BUT NOT BE LIMITED TO, THE FOLLOWING:
- 29 (1) THE IDENTIFICATION OF AN APPROPRIATE WILDLIFE
- 30 VACCINE.

- 1 (2) THE DEVELOPMENT OF EFFECTIVE BAIT ATTRACTANTS FOR
- 2 WILDLIFE IN THE FIELD.
- 3 (3) ASSESSMENT OF THE DURATION OF THE IMMUNITY OF THE
- 4 ANIMAL, ONCE VACCINATED, AS WELL AS THE EFFECTS OF THE
- 5 VACCINE ON WILDLIFE, ITS SAFETY AND STABILITY, AND THE
- 6 ECONOMICS OF VACCINE PRODUCTION.
- 7 (4) THE IDENTIFICATION AND DEVELOPMENT OF A DISTRIBUTION
- 8 SYSTEM FOR THE DISSEMINATION OF THE BAIT IN RURAL AND URBAN
- 9 ENVIRONMENT.
- 10 (B) MONITORING AND REPORTING OF RESEARCH ACTIVITY.--
- 11 (1) ANNUALLY, THE DEPARTMENT IN CONJUNCTION WITH THE
- 12 WISTAR INSTITUTE SHALL PROVIDE TO THE GENERAL ASSEMBLY A
- 13 STATUS REPORT OF THE RESEARCH ACTIVITY CONDUCTED FROM THE
- 14 PRIOR YEAR. THE STATUS REPORT SHALL CONTAIN A SUMMARY OF THE
- 15 RESEARCH AND THE DOLLARS EXPENDED.
- 16 (2) PRIOR TO THE DISTRIBUTION OF THE BAIT IN RURAL AND
- 17 URBAN ENVIRONMENTS, A COMPREHENSIVE REPORT OUTLINING THE
- 18 DISTRIBUTION PROCEDURE MUST BE SUBMITTED TO THE GENERAL
- 19 ASSEMBLY FOR REVIEW.
- 20 (C) COMMISSION COOPERATION. -- THE PENNSYLVANIA GAME
- 21 COMMISSION SHALL COOPERATE WITH THE DEPARTMENT IN CARRYING OUT
- 22 THE RESEARCH ACTIVITIES REQUIRED BY THIS SECTION.
- 23 SECTION 11. PENALTY.
- 24 A PERSON WHO VIOLATES ANY PROVISION OF THIS ACT COMMITS A
- 25 SUMMARY OFFENSE AND SHALL, UPON CONVICTION, BE SENTENCED TO PAY
- 26 A FINE NOT EXCEEDING \$300 FOR EACH VIOLATION. EACH DAY OF
- 27 VIOLATION SHALL CONSTITUTE A SEPARATE OFFENSE.
- 28 SECTION 12. APPROPRIATION.
- THE SUM OF \$273,000, OR AS MUCH THEREOF AS MAY BE NECESSARY,
- 30 IS HEREBY APPROPRIATED TO THE DEPARTMENT OF AGRICULTURE FOR THE

- 1 FISCAL YEAR JULY 1, 1986, TO JUNE 30, 1987, FOR THE DEVELOPMENT
- 2 AND ADMINISTRATION OF A COMPREHENSIVE MULTIYEAR WILDLIFE RABIES
- 3 VACCINE RESEARCH PROGRAM.
- 4 SECTION 13. REPEALS.
- 5 ALL ACTS AND PARTS OF ACTS ARE REPEALED INSOFAR AS THEY ARE
- 6 INCONSISTENT WITH THIS ACT.
- 7 SECTION 14. EFFECTIVE DATE.
- 8 THIS ACT SHALL TAKE EFFECT IN 60 DAYS.
