1 2 3	Creating a commission to ensure the coordination of efforts to observe the 125th Anniversary of the Battle of Gettysburg and Lincoln's Gettysburg Address; AND MAKING AN APPROPRIATION.	<
4	The General Assembly of the Commonwealth of Pennsylvania	
5	hereby enacts as follows:	
6	Section 1. Commission created.	
7	The General Assembly hereby creates the Battle of Gettysburg	
8	125th Anniversary Commission to ensure the coordination of	
9	efforts to observe the 125th Anniversary of the Battle of	
10	Gettysburg and Lincoln's Gettysburg Address.	

- 11 Section 2. Duties.
- 12 The duties of the commission will be:
- 13 (1) To facilitate cooperative efforts between State
 14 agencies and those public and private organizations which are
 15 planning activities commemorating this anniversary.
- 16 (2) To invite the cooperation of the Congress of the
 17 United States and the legislatures of the other states.
- 18 (3) To authorize expenditures of Commonwealth funds

- appropriated to support the activities of the 125th
- 2 Anniversary.
- 3 (4) To submit a report to the General Assembly of the
- 4 activities of the commission and make recommendations
- 5 concerning the commemoration of the 125th Anniversary.
- 6 Section 3. Members.
- 7 The commission shall be comprised of eleven citizens of this
- 8 Commonwealth, seven of whom shall be appointed by the Governor,
- 9 and one of whom shall be appointed by each of the following: the
- 10 President pro tempore of the Senate, the Minority Leader of the
- 11 Senate, the Speaker of the House of Representatives and the
- 12 Minority Leader of the House of Representatives.
- 13 SECTION 4. APPROPRIATION.
- 14 THE SUM OF \$210,000, OR AS MUCH THEREOF AS MAY BE NECESSARY,
- 15 IS HEREBY APPROPRIATED TO THE COMMISSION CREATED IN SECTION 1 TO
- 16 CARRY OUT THE PURPOSES OF THIS ACT.
- 17 SECTION 5. REPEALS.
- 18 THE APPROPRIATION IN THE AMOUNT OF \$210,000 IN SECTION 229 OF
- 19 THE ACT OF JULY 3, 1987 (P.L., NO.9A), KNOWN AS THE GENERAL
- 20 APPROPRIATION ACT OF 1987, FOR THE CELEBRATION OF THE 125TH
- 21 ANNIVERSARY OF THE BATTLE OF GETTYSBURG IS HEREBY REPEALED.
- 22 Section 4 6. Expiration.
- 23 The commission shall complete its business and submit its
- 24 final report to the General Assembly by June 30, 1989. This act
