## AN ACT

- Amending the act of April 12, 1951 (P.L.90, No.21), entitled "An act relating to alcoholic liquors, alcohol and malt and 2 3 brewed beverages; amending, revising, consolidating and 4 changing the laws relating thereto; regulating and restricting the manufacture, purchase, sale, possession, 6 consumption, importation, transportation, furnishing, holding 7 in bond, holding in storage, traffic in and use of alcoholic 8 liquors, alcohol and malt and brewed beverages and the 9 persons engaged or employed therein; defining the powers and 10 duties of the Pennsylvania Liquor Control Board; providing for the establishment and operation of State liquor stores, 11 12 for the payment of certain license fees to the respective 13 municipalities and townships, for the abatement of certain nuisances and, in certain cases, for search and seizure 14 15 without warrant; prescribing penalties and forfeitures; 16 providing for local option, and repealing existing laws," 17 providing for the use of the moneys paid from the Liquor 18 License Fund to municipalities. - 20 hereby enacts as follows:
- 21 Section 1. Section 801(b) of the act of April 12, 1951
- (P.L.90, No.21), known as the Liquor Code, is amended to read: 22
- 23 Section 801. Moneys Paid Into Liquor License Fund and
- Returned to Municipalities. -- \* \* \* 24
- 25 The moneys in the Liquor License Fund shall, on the

- 1 first days of February and August of each year, be paid by the
- 2 board to the respective municipalities in which the respective
- 3 licensed places are situated, in such amounts as represent the
- 4 aggregate license fees collected from licenses in such
- 5 municipalities during the preceding period. All moneys received
- 6 by municipalities that have police departments shall be used
- 7 only for purposes relating to the enforcement of this act and
- 8 any other laws relating to alcoholic beverages.

- 10 Section 2. This act shall apply to all moneys paid to the
- 11 board and municipalities after the effective date of this act.
- 12 Section 3. This act shall take effect in 60 days.
